Human Rights Protection Cell and Welfare Association (HRPC & WA), Una is duly registered under Societies Act 1860 (Registration no 02/2006 dt 26/08/2006). Also registered under PWD Act 1995 (now RPD Act, 2016), registered as Service Provider by HP Govt. under PWDV Act 2005.

Since 2006, HRPC & WA is providing free legal service/ counselling to individuals/ societies/ groups to safe guard their human rights. We don't believe in number of cases handled/ solved of human rights violations but we are committed to provide selfless service to all and sundry who's Human Rights are violated/ dignity challenged.

During the year, 45-50 cases of domestic violence, police atrocities, land disputes, social injustices, drug addiction etc. were dealt with utmost care and with the help of District Administration; most of the cases were settled/ resolved amicably.

Every year in connection with World Human Rights Day i.e. 10th Dec, a public awareness function is organized to sensitize and aware the people about their Human Rights. This year it was organised on 30-12-2018. Dr. Sham Kumar Sharma, Superintending Engineer, IPH Una presided over the function. He said that we need a society who cares for protection of human rights of an individual. I am happy to note that HRPC& WA is carrying out the noble cause of protection of Human Rights and at the same time they are running welfare project Ashhraya for Special Children. To mitigate the sufferings of parents of Special Children who reside in nearby villages/ towns of the area. All facilities like Education, training, uniform, lunch, alpaahaar, books, sports and physiotherapy equipments, transportation etc. are provided **free of cost**. We also as an individual must devote some time for welfare of persons in need.

Mr. Rakesh Bhatia, General Manager, Bank of Baroda, Zonal Office, New Dehli was the Chief Guest. Due to inclement weather his flight was cancelled and he could not reach at the venue. Ms. Sammita Sachdev, Deputy General Manager, Bank of Baroda, Chandigarh Region was the Guest of Honour. Dr. Alok Suryvanshi, Sr. Consultant, Cardiothoracic Sciences, Forties Hospital, Mohali (Pb.) was the Guest of Honour. He delivered a key note lecture on heart care/ general health. His Medial team from Forties Hospital, Mohali provided

free Medical Check-up/ tests for person's having heart/ eyes/ knees related problems & general health.

CHILDLINE (HELP LINE) 1098

We are partner organisation of Childline India Foundation, Mumbai for Childline Project for District Una, supported by the Union Ministry of Woman and Child development and State Government since 07 September 2018.

For F.Y. 2018-19 we received 67 complaints regarding child abuse, child labour, Begging, Missing, corporal Punishment, other School related, shelter, Medical + Financial Aid. These were properly attended/ settled/ resolved/ concluded with the commitment/ dedication of Childline Staff.

Childline is 24 hours national toll free help line. Making a call on 1098 (Toll Free) any person can lodge complaint/ grievance/ problem relating to child/ children of the area.

ASHHRAYA (HOME FOR HUMAN RIGHTS) : Special School cum Day Care Centre
Our Welfare Project Ashhraya, Special School Cum Day Care Centre at Dehlan did commendable job by providing Free of Cost Education, Physiotherapy, Transportation, Meals etc. facilities to Children with Special Needs .Annual Report of Welfare Project "Ashhraya" is enclosed.

ASHHRAYA (Home for Human Rights)

Ashhraya has risen with 17 blessed children in academic session 2010-11, with charitable service through public donations and presently (2019-20), the total No. of blessed children rolls to 88 i.e. (68 intellectually Challenged and 20 Hearing impaired). The expenditure has also increased manifold but the 'State bodies' also motivated us by contributing to genuine cause as: 25 intellectually challenged aging 6-14 (only intellectually challenged) years are under the **ASEEM project** (90% funding by State Govt.) and out of remaining 63 CWSN, 20 CWSNs are under RMSA/SSA programme.

The transparency of account and work are permanent attributes of the organisation. The Grant-in-aid received under 'ASEEM Yojna' or else shall be exclusively spent for catering the services of **only those Special children** who are listed under the particular project (Yojna). Mrs. Shivani (B.Ed spl.) , Mrs. Monika (D.Ed. & **coach, special sports**), Dr. Sumit (Physiotherapist) are exclusively designated staff to render the services to Special Children under Aseem Yojna for the academic session 2019-20.

Annual Report 2018-19(ASHHRAYA)

ASHHRAYA, a **Special School Cum Day Care Children** is a Welfare project of Human Rights Protection Cell & Welfare Association, duly registered under Societies Act 1860 (Regd. No 02/2006 dated 26/08/2006)

Also registered under Persons with Disabilities Act, 1995 (now RPD Act, 2016)- Regd. as service provider by the HP Govt. U/PWD Act 2005.

Special School is duly recognized by Dy. Director, Elementary Education, Una (H.P.) from Class I to Class VIII for the academic session 2018-19 & 2019-20.

1.) Aims & Objectives

To mitigate the sufferings of Special rather blessed children (Mentally Challenged, deaf & dumb, Hearing Impaired) & their parents.

Provides Services for:

- Identification of children with Special Needs (CWSNs).
- Special Education & Physical training.
- Discover their hidden potential.
- Integrate children with Special needs into main stream of Society.
- To undertake special programme, activities for education & rehabilitation of persons with disability.
- To work for early intervention, prevention, medical rehabilitation, placement, economic self-reliance of Special Children.
- Counselling to parents & Community regarding myths & misconception about mental retardation/ physical disability.

All Services are provided Free of Cost.

2.) Location

Ashhraya is located at Sadyana Tobba, Dehlan-174306 Tehsil & District Una (H.P.) on Dehlan Badehar Road. Village Dehlan is situated at Nangal Una National Highway, 2 Km away from Mehatpur & 10 Kms from Una. Ashhraya is located at 1.5 Km distance from Shri Gurudwara Sahib Stop, Dehlan.

It is located in rural area.

3.) Establishment

Ashhraya came into existence in May 2010 with enrolment of 17 Special Children. At present it has 81 Special Children (63 mentally challenged 18 Hearing impaired) in addition to 3 Home based Special children, which is very much on target.

Every year new academic session starts in April (around 15th to 18th) with Havan & Cultural function. School timings are from 08:30 AM to 02:00 PM. Children assemble at 08:30 AM Sharp for daily prayers & physical exercise. Academics, Speech Therapy and Physiotherapy start from 09:00 AM onwards as per specific needs of each child. Alpaahar is provided at 10:50 AM. Alpaahar contains Milk, Biscuits and fresh fruits as per availability. Mid-day meal is served to all the children at 01:40 PM. Meal is prepared within the four walls of "Ashhraya", which is duly checked by teaching staff on rotation before it is served to Special

Children. Average attendance is 80% to 85%. Every Saturday is games/curricular activities day, special children learn art & craft, stitching, painting, music and play games of their choice. Once a week volunteers and special children do cleaning activity, do keep premises neat and clean.

Every facility like Education, Speech Therapy, Physiotherapy, physical Exercise, Transportation, Uniform, Books and Medicines etc. is provided **Free of Cost.**

4.) Facilities

Infrastructure

Land is donated by Gram Panchayat, Dehaln (Lower), building comprises of 3 Blocks, 2 Blocks are two storey building & 3rd Block is three storey building. In all there are 19 rooms, Mess, independent Physiotherapy Centre, Speech Therapy room, yoga hall, Principal Office & Admin Block. It has two play grounds with medicinal plants. Ashhraya can accommodate more than 150 special children for Education, Physiotherapy, Speech Therapy, Indoor and Outdoor games etc.

5.) Faculty

There are 19 well qualified, dedicated & committed volunteers comprising 6 Special Educators, 1 Speech Therapist (Part time), 1 Science Teacher (Hony.) 1 Principal (Hony.), 1 Vice principal, 1 Physiotherapist (part time), 3 Drivers, 3 Mother helpers, 1 Computer operator, 1 Bus attendant, headed by Principal Mrs. Usha Vashisht (Honorary) who take care of all needs of the Special Children.

6.) Transportation

Special School has own arrangement for pickup & drop of children at their doorsteps. There are 4 vehicles {1 Mini Bus and three school van (2 Tata Winger and 1 Maruti Eeco)} which operate daily to cater transportation needs.

7.) Activities

On 16.04.2018 New Session (2018-19) "Shubharambh Samaroh" was organised at Ashhraya, which was presided over by Mr. Anil Vashist, Partner, M/s. Unipro Techno Infrastructure Pvt. Ltd., Chandigarh, Mr. M.L. Aery, Administrator, D.A.V. Medical & paramedical Institutes of India was the chief guest and Capt. (Retired) C. S Chahal, Director, Orion Safety & Security Services Pvt. Ltd., Chandigarh was the Guest of Honour.

On this occasion new mini bus service was inaugurated to provide additional transportation services to special Children of the area.

On 28.04.2018 Mr. Narinder Mohan Nirmohi, Director, Ashhraya attended a seminar organised by Let's Endorse (Funded by Tata charitable Trust).

On 06-05-2018 Disaster Management meeting was organised by Govt. of Himachal Pradesh at Himachal Pradesh Lok Prashasan Institute (Himpa), Dhalli. In which Ashhraya was represented by his director Mr. Narinder Mohan Nirmohi.

On 22-06-2018 Mr. Vinay Modi, SDM, Una inspected/ visited Ashhraya to oversee the activities of the Ashhraya. He observed that the institute, the environment of the kids-all are extremely impressive. Lot of hard work has been put in bringing up this.

On 04.08.2018 Special Children celebrated Teej festival with fun and frolic.

On 05.08.2018 CORD, Dharmashala with collaboration of Star's Forum arranged two days seminar on Livelihood opportunities for person with disability and workshop on National Trust schemes in which Mr. Ashwani Kalia, Head Admin. & Mr. N.M. Nirmohi, Director, Ashhraya participated.

On 25-08-2019 special children and volunteers of Ashhraya organised a camp to collect donations from public to provide monetary help to victims of flood affected areas in Kerala. A good amount was collected and sent to CM relief fund on 27/08/2018. News paper of the area duly appreciated special children for this noble cause by carrying out Photographs of special children with donation box.

On 27.08.2018 VRC, Una organised a camp for identification of artificial limbs for Persons with disability in which our 11 special Children participated.

On 01.09.2018 Janamashtami function was organised at Ashhraya in which Special Children Volunteers, other dignitaries took keen interest by reciting bhajans/ kirtan. Glimpse/ Jhankis of Lord Shri krishana were depicted.

On October 1st and 2nd 2018 Asha Kiran Educational Society, Ghumaarvin, organized first state level cultural and half marathn, in which our 12 Special Children and volunteers participated. Kritika (Special Child) and Kriti Bhardhwaj (Volunteer) presented solo dance. Kriti bhardhwaj was awarded with Runner up trophy.

On 10.10.2018 Vaccination of DPT, T.B. and HB Test carried out for all the special children, who were present there.

On 16.10.2018 Special camp was organised by NFL Hospital, Nangal for identification of Aids/ artificial limbs to be provided to persons with disability. Our Volunteer Mr. Mohit & Mrs. Shivani along with 32 children participated in the camp.

25.10.2018 Child Welfare Committee, Una under the Chairmanship of Mr. Kishore Singh visited Ashhraya to oversee the activity of the institute. They appreciated for neat and clean environment and caring attitude of the volunteers towards their wards.

On 28.10.2018 NFL Naya Nangal, organised Dipawali Fair at NFL Stadium, Sector 2, Naya Nangal. Ashhraya had its own stall where goods/paintings/ products prepared by special Children with the help of their mentors were displayed. Mrs. Shamshad Begum and Mrs. Raj

Rani (Volunteer) along with Master Jaswinder, Aakash, Rohit, Yashpal, Suresh, and Baby Anchal (Students) managed the affairs of the stall. Ashhraya's Patron Sh. Anand Kumar Malik, Mr. Rakesh Nayyar and Mr. Shammi Jain were also present. Chairman of NFL along with S. Narlep Singh Rai, General Manager Incharge, Nangal visited our stall and appreciated craftsmanship of Special Children. A painting was presented to him on behalf of Ashhraya. Visitors showed keen interest and purchased almost all products.

Students of SBS Sr. Secondary School, Sadarpur, (Garhshankar) visit every year on the occasion of 'Deepawali' to interact with Special Children of Ashhraya. This year they visited Ashhraya on 29th Oct. 2018. They brought lot of gifts for Special Children & had interaction with them.

On 01.11.2018 D.I.E.T, Dehlan organised Jila Satariya Kala Ustav for the Special Children aged 0-19 years. Mrs. Renuka and Mr. Mohit Kumar along with Special Children Master Jaswinder, Baby Anchal, Baby Kritika, Master Ramandeep and Master Pratham participated in the Utsav. Our Special Children's presentations were highly appreciated.

On 14.11.2018 Children Day was organised at Ashhraya. Children were apprised about our Ex. Prime Minister Chacha Nehru. Representatives of Child Welfare Committee Una were also present.

On 01.01.2019 every year Special Children along with their teachers visit various District Authorities at Una. They present New Year Greeting Cards prepared by themselves to various authorities like DC, SSP, Distt. Session Judge etc. Authorities reciprocate with full zeal & encourage them to keep doing such activities; offer Sweets, Snaks & get selfies.

On 30.01.2019 a Function for donating Hearing Aids MR Kits, equipments to needy persons with disability was organised by NFL Naya Nangal at ABC auditorium. Our 32 Special Children along with their mentors attended function. Our children made two presentations which enthralled the audience.

On 04.02.2019 Indian Oil Corporation, Una organized Special Camp for donating MR kits, Hearing aids, CP Chairs, Wheel Chairs, Joy stick Chair. Our children received 8 MR Kits, 2 CP Chairs, and 2 Wheel Chairs. Ms. Amarjeet kaur, Vice Principal, Ashhraya was presented with Joy stick chair.

On 16.02.2019 Mr. Vivek Thakur, Justice, High Court of Himachal Pradesh, Shimla made an official visit to inspect Ashhraya.

On 20.02.2019 Mr. Rakesh Kumar Prajapati, Deputy Commissioner, Una visited Ashhraya. He was highly appreciative of the activities being undertaken by the Ashhraya. Cleanliness and way of teaching attracted him a lot.

On 11.03.2019 Mr. D.R. Thakur, Session Judge, Una made quarterly visit at Ashhraya.

Parent Teacher Management (PTM) meeting is convened every quarter to review the progress of Special Children. Suggestions are invited for further improvement. Last quarterly meeting for March ending 2018 was conducted on 29th March 2019.

8.) SPORTS

Every year our Special Children participate in sport/cultural activities at District/ State Level organised by the Youth Affairs and Sports Department Govt. of Himachal Pradesh.

Ashhraya won State Level Champion Trophy for overall M.R. Category at 11th State Level Sports Meet held on 2nd and 3rd December 2018 at Dharamshala.

Our Special Children (Girls) bagged first prize in Bocci game & Boys won 3rd prize in the same. They won 5 Gold, 2 Silver, 7 Bronze medals.

This year District Level Sports Event was organised on 26th September 2018 at Una in which our 32 children participated. 17 Children won Gold, 07 Silver and 11 Bronze medals.

Every child is special & different, separate activity profile is maintained for each & every child. Weekly, monthly, quarterly and annual progress is recorded in the profile. Annual report of each child is submitted in which all traits, 5 fold developments are duly recorded. This gives a fair picture of the progress made by the special child.

12.) Success Stories

Every success lies in the continuity, consistency, all out efforts with zeal, co-operation of parents, teachers & support staff.

His mentor Mrs. Renuka Special Educator (MR) observed that Sanju is capable of doing any type of work. He can speak, listen properly. He is very keen to help his mates. He maintains cordial relation with all the students. Though he is obedient yet least interested in studies. He takes a lot of time to learn anything. He seems to be much interested in athletics.

His mentor Mrs. Renuka set goal for Sanju as under:-

- First of all, ways and means to be evolved so that he takes interest in studies.
- His athletic skills to be improved with the help of sports coach Mr. Mohit and Mrs. Monika Sharma.
- To concentrate on his overall personality development.

Achievements:-

Continues and consistent efforts have resulted in shaping and focusing on his athletic skills. Sports coaches' proactive approach and confidence in his ability encouraged Sanju to yield good results in sports.

Sanju has been a team member of Bocche Game. He won 3rd position at state level and 1st position at District Level. He stood first in 100 meter race at District Level Sports Meet organised on 26th sep. 2018. He has started taking interest in studies and feels confident.

2. Baby Samridhi (D.O.B.:- 26-10-2012 HI D.O.A.:-12-04-2016)

Baby Samridhi is very active & attentive. Little bit hyper but good at studies. However, She is not attentive in writing learning sign/skills pays little attention in writing, learning signs.

Her mentor Mrs. Shamshad begum set specific goals for her improvement viz

- Train her to say 'Nameste' to all as & when she enters her class.
- Pay due respect to elders/visitors.
- To make her aware about different sign/ skills at Ashhraya & at home.
- To inculcate interest in drawing, dance, sports, and also to make her speech clear.

Continued/ Consistent efforts by her mentor, parents, mother helpers, volunteers, classmates have shown tremendous overall improvement in her every skill with in short span of 3 years. 'Samridhi' can pronounce Mummy, Papa, Aunty and Uncle. She has also learnt signs of Scooter, fruits, pencil, bag, household goods, trees, plants etc. Now she participates in cultural programme, do dancing, and take part in sports. Appreciation by her mentor has motivated her a lot.

Achievement:-

Samridhi has scored 1st position in 100 mtr. Race at sports meet organised at Ashhraya on 26.11.2018.

3. Baby Aditi (D.O.B.: -15-04-2005 MR+HI+ Low Vision D.O.A.: -25-04-2011)

Baby Aditi's mentor Mrs. Raj Rani (Spl. Educator HI) observed that due to low vision she is in the habit of keeping her face very close to her copy & book while writing/learning. When she was asked to memorise certain things/topics she used to copy others. As a result of which she could not learn properly. Her teacher set specific time bound goals for her.

Academics & Circular activities

As & when she tries to keep her face close to her copy or book, she should be asked to keep certain distance to get rid of habit of copying. She should be encouraged to write on the Black Board. She should be asked to write the same on her copy.

Similarly targets were also set for games, sports, cultural programme, and extracurricular activities.

Achievement

With consistent/ unrelenting efforts by her mentor, volunteers, parents & herself, there is spectacular/ visible improvement in her education abilities. Now she memorises on her own, can write two line Question Answers in Hindi & English, do fill in blanks. She can write 10 lines Essay. She scored good marks in her final exams.

She participates in one act play/ dance. She stood third in Broad Jump and at State Level competition at Daramshala on 3rd December 2018. She also won 1st price in 50 meter race and skipping held on 26th September 2018 at State and District games. She can paint/ colour flower pots etc. prepared from waste materials. She takes interest in keeping her class room neat & clean.
