People with disabilities have been differentially affected by COVID-19 because of three factors: the increased risk of poor outcomes from the disease itself, reduced access to routine health care and rehabilitation, and the adverse social impacts of efforts to mitigate the pandemic.

Santhivardhana Ministries is non-profitable voluntary organization and its registered under societies registration act 35 of 2001 vide registration No. 129/2005 Government of Andhra Pradesh with the noble concept to implement all measures to uplift the living conditions of the persons with disabilities and people below poverty line, irrespective to their caste, creed, religion or sex. Since inception, the organization has been rendering its services for the education, welfare and rehabilitation of persons with different abilities in the rural area at Pulimeru Village, Divili Post, PeddapuramMandal in East Godavari District of Andhra Pradesh.

Santhivardhana Ministries also registered under Persons with Disability Act 1995, has obtained registration under The National Trust under the Ministry of Social Justice and Empowerment, Govt. of India. Santhivardhana Ministries has been certified as an organisation under FCRA and Tax exemption benefit under 80-G of income tax and also having ISO 9001 : 2015 for quality management system.

## SPECIAL RESIDENTIAL SCHOOL FOR THE MENTALLY CHALLENGED

This organization has maintaining a Special School for the Mentally Challenged with the support of Ministry of Social Justice & Empowerment; Department of Empowerment of Persons with Disabilities, Government of India, New Delhi has under Deena Dayal Disabled Rehabilitation Scheme (DDRS) and Local Donors at Pulimeru Village. We are providing services in both day & residential care facilities. It's committed patiently to strive for realistic improvement upon state of existence of people with Mental Retardation, Cerebral Palsy, Autism, Physical Handicap, Speech defect and Hearing Impairment and Multiple Disability.

### Facilities to the children:

- ✧ Training in activities of daily living
- ✧ Academic skill development training
- ✧ Physiotherapy & Speech therapy
- ✧ Skill development in sports & games
- ✧ Training in Arts, Music & Dance
- ✧ Pre- vocational training
- ✧ Vocational Training
- ✧ Recreational facilities

The Special School caters to around 160 students ranging from 7 to 25 years of age including those students enrolled in the Center for Vocational Training. The children attending special school are of a variety of disabilities some of which include cerebral palsy, autism and learning difficulties. The primary goal of the organization is program is to provide each individual with an environment which facilitates & maximizes his/her learning abilities both academically and functionally.

### Functional Academic group:

Students learn the basic literacy & mathematical skills which are necessary for daily interactions within the community, for moving and communicating each other. The introduction of both Student and tutor is very important for future training.

### Care group:

For the enrolled Students in this class need a huge support. It is mainly focus directly towards learning skills about their daily living to perform basic functional activities, enabling individuals to optimize their involvement within the family & community setting. Learning is directed though a variety of fun and motivating recreational and functional activities.

### Music, Dance & Drama:

Many of the students were involved in music, dance and cultural programs throughout the year. In all religious and national festival days students involves in cultural, music and dance events to presenting performances both in-house and within the community. These activities are not only fun to be involved with the students but also contribute the children.

Throughout the year many of our students were involved in music, dance & cultural programs. All national religious festivals are observed whereby students are involved in presenting performances both in-house and within the community setting. Where they show case their musical, dance and drama skills in front of large audiences. These activities are not only fun to be involved with but also contribute to the Child holistic development and personal growth enabling him/her to develop self-confidence.

### Sports & Games:

Sports & Games are a very important medium of physical and social development, creating a deep impact on the wellbeing of a special child. All Our students from the youngest to the oldest are exposed to indoor and outdoor games and participate in a variety of sporting activities, such as roller skating, athletics, fun games, Badminton, volleyball, bocce etc. Several indoor games are used as teaching aids as well as for having fun.

### Arts & Crafts:

Our students are involved in a variety of art and craft activities which are frequently displayed at school premises. Students not only have an opportunity to enjoy creating beauty but also an opportunity to improve their fine motor skills.





This organization has conducted few special events due to Covid-19, in which children with special needs and faculty of the institute have actively participated in 2020-21 and these are:

### INSPECTION BY DISTRICT LEVEL JJ ACT COMMITTEE:

Due to this Corona pandemic instructions and restrictions about care and protection towards children is increased and the observations of homes were implemented by the Government as well. A state level Committee including 5 Departments visited on 4<sup>th</sup> April 2020 and observed the classrooms, children and hygiene conditions of the school and surroundings. Assistant Director, Welfare of Differently able, Transgender and Senior Citizens department, E.G.Dt, Kakinada, Deputy Superintendent of Police, Peddapuram, Grade-I officer D.P.O sir, Rajahmundry, D.C.P.O, Kakinada, I.C.P.O. Rajahmundry, CWC & JJ act committee members and Doctors from Medical department as a group visited our institution inspected what the safety measures taking specially for the children towards this Covid-19. All are very happy with the maintenance and guided some new rules and safety instructions which are introduced especially towards this Corona Virus.

Secretary thanked all the committee members for making aware about Covid-19 and motivating all of us. We promised to follow all the instructions what they guided and mentioned. Vice-President and Secretary follow-up the visit and on behalf of this visit explained to all the staff towards present situation of the increasing cases of Covid-19 throughout the world and especially in India we have a huge number of density of population, if there is no such restrictions it'll be a great loss in all the way in our country. ## HELATH CHECK UP:

We thank our doctors and nurses of Primary health center, Pulimeru for monitoring our children regularly. All the PHC staff does checkups at our school or at PHC with dedication and in service motto. Due to corona, nurses visits our school monthly twice and our beloved doctor Shri. Rambabu Naik sir is observing and monitoring all the reports of the children. Some safety instructions and prescriptions were given by the doctor about this pandemic.

He explained about the Corona. First how it may enter in to our human body and how it implements its strength in our body and at what stage it is going to be in danger position. Most of the innocents may chances of death due to no awareness. N.G.O's can do that what Government do not with its administration. So he requested Santhivardhana to do some COVD-19 awarenes camps to make motivated common people who cannot understand what is Corona and what it will do if we don't take care about this. He suggested some medicine kits to be taken if there are any symptoms observed.

He also told that our Prime Minister was thought a step forward to restrict the spreading of Covid-19 in India by putting lockdown throughout the country. It means there is no any type of transactions will do by anyone of any sector. So it may no direct and indirect contact to person to person. He suggested maintaining social distance, ware face mask and some special drinking and food habits to be maintained to avoid and infect from the virus.

## CENTRE SPECIAL NEEDS CHILDREN AT ANNAVARAM

The organization has maintaining a Santhivardhana special school at Annavaram which is pilgrim place of famous God Sri Annavaram Satyanarayana Swamy. We are proud to extend our services in various areas in East Godavari district. Here we are providing early intervention facility and also providing better services and rehabilitation to both hostlers and day scholars. Our specially trained and qualified staff is working with dedication towards these special needs children.



We are providing the best quality of food, hygiene conditions of this premise. The attendance of the students, the parent's interest and the dedication of our staff is the cause to the improvement of this branch. Most of the children with special needs in this area were kept in their homes and also not getting even minimum training. The need of this project in these areas is very much required. As per object, in this centre it is providing services like special education, home based intervention therapeutic services, and education to the special needs children.



Lack of awareness, Parents and the people were suffering and suffered by these special need children living together in this society. Sri.R.Veerababu, Secretary has conducting regular parent meetings to teach and train how to handle the situations and behavioral problems occurred due to their special children at home or with the neighbors. All the surrounding parents were very thankful towards our secretary, because of these meetings they helped themselves to survive so many problems facing with their children. Some of the people visiting frequently to our children home to bring aware about these children to the society.

All the events which were celebrated in Pulimeru branch is also will be celebrated in this Annavaram branch. Our secretary sir's motto is to help some of the differently able to be change in to capable to do even their personal works.

On 21<sup>st</sup> March 2021 it was celebrated Down syndrome day with these children. Even though they don't know what Down syndrome is, what is Autism and what is disability. They are happy with the special training and special events bring happiness in their lives.

## HOME FOR SENIOR CITIZENS WOMEN AT PULIMERU

Santhivardhana is dedicated its services all the range of age groups. It has been extended from Special School for Children with Special needs upto Old aged women who need of care and neglected. Secretary R.Veerababu says about the purpose of opening of the school. In our journey of services we found some family issues it leads to separation of parents from children. Once upon a time it'll happen unfortunate, but now a day's most of the parents getting such situation from their children due to some family issues. Felt very sad to hear and feel it is very bad to leave the parents in this old age and be neglected. So Santhivardhana established a home for the Senior Citizens.



Shri.V.Kama Raju garu, Assistant Director, Welfare of Differently able, Transgender and Senior Citizens Department have visited this home on 20<sup>th</sup> June 2020. He has interacted with all the beneficiaries and he asked about why and how they joined here and the present situation and the care and protection and what facilities getting here in this home. All of the women respond positively and thanked Santhivardhana for taking such care and protection. On that day respected Assistant Director Sir distributed protein food groceries to the women and explained about the Covid-19 pandemic and about safety measures to take additional care. Vice president Smt. R.Satyaveni and other dedicated staff were participated in this event.





## ADULT LITERACY PROGRAMME

This is a greatest opportunity to Santhivardhana. In this lockdown period Santhivardhan had got a different thought and immediately applied. While implementing Santhivardhana Cheyutha distributing the food groceries to needy and poor people around us, our staff observed more illiterates in tribal villages of Rajavommangi Mandal of our East Godavari District. In those areas most of the people belong to Kondakapu & Valmiki communities founded 90% illiterates. So we made a project proposal explaining about the situation and need & importance of education in those areas. Eventhough they doing hard work they are not getting benefit due to lack of knowledge. So Santivardhana requested and applied about adult education program to implement Adult education centers at the villages of Rajavommangi mandal to Literacy India Trust, Chennai.



They observed our proposal and agreed about adult literacy classes in those areas where it needs. Then Santhivardhana started Adult Education program in collaboration with Literacy India Trust, Chennai inaugurated on October, 2020. For this program Santhivardhana appointed 3 project officers and 15 special trained volunteers who have dedication in social service and work for 15 literacy centers in each center 30 adult students will be educated.



## LIVELIHOOD SUPPORT PROGRAMME

Covid-19 pandemic is a big impact to all fields and economic disaster all over the world. This effected to our livelihood support programme. In this year we didn't support from January 2020 to December 2020 due to severity of the Corona cases in our surrounding areas and main reason that we haven't received any fund from the donor. After decreasing the cases our donors Dewan Foundation, UK asked that any requirement to continue the support Income generation program, then Santhivardhana offered the same women who wants to improve their existing businesses and also who wants to join in this livelihood family.

This year it is changed the loan procedure individuals to groups from Cash to Bank accounts. Donor made condition for account transparency, the next support should be through straight in the beneficiaries bank accounts. We are very happy with the new condition and we motivated our applicants to open group bank accounts in any bank they want. Our secretary and SHG staff helped them and finally opened their group accounts in Axis bank. Santhivardhana Ministries supported this year through bank accounts to the groups in the name of Santhivardhna Social Awareness Development Foundation with the financial supports from Dewan foundation, UK and Brighter Future Development Trust, Vizianagaram.

He appreciated Veerababugaru for the new school building and for the quality of maintenance in all the way.

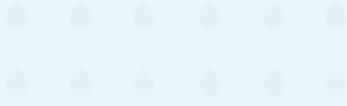
We are looking forward for more help to taken up some more activities for the upliftment of the living conditions of the poor and the Disabled Persons for their Education and Rehabilitation and Youth.
