

## NATIONAL SOCIETY FOR EQUAL OPPORTUNITIES FOR THE HANDICAPPED – GUJARAT

Set up in 1994, National Society for Equal Opportunities for the Handicapped - NASEOH (Gujarat) is a registered society and a registered public charitable trust working for children with developmental delay.

The initial years in a child's life are a critical time for the child's development and growth. Since conception, development is a continuous process and is monitored through growth milestones. This milestones are specific and the four areas which they cover are gross and fine motor abilities, language skills, social development and self help skills. Most children are expected to achieve each milestone within a specific time often referred to as the "key-age". This key age is based on weeks, months and years of a child's growth.

During the early years most children go through significant developmental changes, achieving basic physical, cognitive, language, social and self help skills. Any delay in achieving these milestones falls under developmental delay.

NASEOH (Gujarat) aims to help young children achieve these milestones through Early Intervention, Assessment, Treatment and Therapy as also through Education, Learning and Sports. All activities at NASEOH (Gujarat) are through: KALRAV and BLUE ROSE.

Kalrav, an assessment and treatment centre for children with developmental delay.

Blue Rose a learning and activity centre for developmentally challenged children.

Centrally located at Navrangpura, Ahmedabad, the Centre has been working in the field of developmental disabilities encompassing learning, behavioral, physical and intellectual disabilities. The activities of the Centre are managed by a Board of Trustees and its Governing Council consisting of doctors, advocates, engineers, chartered accountants, social workers and businessmen. The activities of assessment, treatment and special education undertaken at NASEOH (Gujarat) are provided by a team of committed and qualified medical and paramedical professionals and special educators.

## KALRAV



KALRAV an early intervention center undertakes assessment and treatment of children with developmental delay between the age of one month and 10 years. Early Intervention is a systematic programme of therapy, exercises and activities designed to address the problem of developmental delay in children.

Development delay comprises of genetic and non-genetic causes and can be in the form of Mental Retardation, Cerebral Palsy, Down's Syndrome, Autism, Asperger's Syndrome, Attention Deficit Disorder, Dyslexia (Learning disabilities) etc.

Developmental delay if diagnosed at an early stage can, with effective therapy and treatment, help in making the child self-reliant and improve his/her quality of life also.

Statistically, about 2 (two) children per 1000 children are afflicted by either cerebral palsy or some form of developmental delay, which means that at least one million children have cerebral palsy or developmental delay in India.

Therapy and treatment for children with developmental delay covers

- 1) PHYSICAL THERAPY / PEDIATRIC PHYSIOTHERAPY: Treating children with movement difficulties (sitting, crawling, walking, moving etc.), children with difficulty in gross motor skills or children who are uncoordinated or with conditions affecting their bones, joints or muscles and any other congenital syndrome or condition.
- 2) OCCUPATIONAL THERAPY : Teaching children to improve their fine motor skills and motor planning (self-care routine like brushing teeth, dressing, combing hair, writing, holding etc.)
- 3) SPEECHAND LANGUAGE THERAPY: Assessment and treatment of children with communication problems and speech disorders (articulation or stuttering disorder, slow or slurred speech, understanding and communicating disorders or receptive disorders.)
- 4) PLAY THERAPY : Helping children to communicate and express their thoughts and feelings through activities related to Play.
- 5) COGNITIVE BEHAVIOR THERAPY : Changing a child's physical and social environment to encourage good behavior and discourage unwanted behavior.

KALRAV provides comprehensive multi-disciplinary care by housing the entire range of required professionals under one roof in an atmosphere of care and compassion which helps to stimulates mental, developmental as well as physical growth.

At Kalrav, after a comprehensive assessment of the child, a treatment plan based on a unique assessment system- HELP (Hawaii Early Learning Profile) is created. The treatment to the child consists of physiotherapy, occupational therapy, clinical psychology, speech therapy, sensory organization and play therapy.

In keeping with the criteria of a District Early Intervention Centre, Kalrav has also added facilities for Oral and Dental Assessment and therapy, Vision Assessment and therapy, Hearing assessment and therapy and Sensory Integration.

### **BLUE ROSE**

BLUE ROSE is a learning and activity centre for children with special needs.

Special needs are issues that interfere with a child's ability to learn. These could arise because of learning, developmental, behavioral or physical disabilities and challenges. Blue Rose is a learning and activity centre for children with developmental delay in the age group of 4 to 12 years needing special care and personalized attention. Such care is provided through

- Special Educator (Specially trained teachers) Clinical Psychologist
- Behavioral Psychologist

Parent & Child Counsellors

- Speech Therapists
- Trained Volunteers

In addition to developing word, number and basic learning skills. Blue Rose has various other activities involving craft, music, dance, yoga, singing and activities to help in daily living along with stimulating activities which help in the child's overall development.

### BLUE ROSE PRE-VOCATIONAL CENTER:

NASEOH (Gujarat) has also started the Blue Rose Pre-Vocational Center for developmentally challenged children to provide them an opportunity to participate in the community and also a possible means of earning a livelihood.

### BLUE ROSE CENTER FOR AUTISM:

A center dedicated to autistic children involving learning through therapy provided by special educators and therapist.





#### **Report of the Hon. Secretary**

It gives me great pleasure to present this year's report of the activities of The National Society for Equal Opportunities for the Handicapped (Gujarat)-(NASEOH(Gujarat)).

NASEOH (Gujarat) is working for children with developmental disabilities, through its two main activities, **Kalrav** and **Blue Rose**.

**Kalrav** is an early intervention, assessment and treatment Centre for children ranging from new-borns to twelve years of age with developmental disabilities.

Under the guidance of the Centre's Developmental Paediatrician and a panel of medical specialists, each child is assessed by a team of qualified therapists. An individual treatment plan is then designed as per the need of the child. The Centre provides treatment through physiotherapy, occupational therapy, speech therapy, play therapy, sensory organisation and cognitive and behavioural therapy (clinical psychology).

**Blue Rose** is a Learning and Activity Centre providing learning and special training to children with developmental delay between the age groups of four to fourteen years. Blue Rose also has a special Centre for Autism and a pre-vocationaltraining Centre.

All learning is provided by trained special educators and all co-curriculum activities like computer training, music, dance, art and craft and sports are provided with the help of specialists and dedicated volunteers.

The year 2020-2021 has been a very challenging one for the Centre.

Our President Shri Kailasbhai Shah passed away in April' 2020. As President, for the last thirteen years, Kailaskaka (as he was fondly called by all) had been a guiding force with his firm yet gentle work ethic always reminding each one of us of our duty to the Centre.

We mourn his sad demise and pledge to continue working with the same ethics that Kailaskaka has shown us through all these years at the meeting of the Governing Council in November, 2020 Dr. Shri Sumantbhai Shah consented to become the President of NASEOH (Gujarat).

With the national lockdown from late March 2020 due to Covid -19 pandemic to ensure that the children do not slide from the level of treatment and learning that they had achieved, reorganizing the working of the Centre became inevitable.

NASEOH(Gujarat) shifted to online therapy in Kalrav and online learning and activities in Blue Rose through WhatsApp video calling initially from April 2020 and later to Google Classroom and Google Meet from June2020 at fifty percent staff strength.

At present Blue Rose continues to function online and Kalrav gives both online and offline therapies, both at full staff strength. Medical Consultation too has started at the Centre.

84 children received treatment at Kalrav in which 36 children took only online therapy, 22 children came to the Centre for therapy and 26 children opted for both.

All online therapies were free and offline therapies were at a subsidized cost. During the current year after the devasting second wave of COVID-19 of April 2021 – May 2021, the Centre is giving all therapies free and plans to do so through this financial year.

During the year 33 children continued their learning and activities, online at Blue Rose.8 new children were enrolled at the Centre for Autism.

All activities which include prayer, teaching, dance (including an internal Dance Competition), Yoga, Tabla and Drawing were and continue to be done online.



Fees charged to the Children from Blue Rose is being taken only as a deposit for regularity and discipline and is refunded at the end of the year.

#### Other Highlights:

The upgradation of the existing building for purposes of meeting with standards of District Early Intervention Centre which had been kept in abeyance due to the current pandemic and now nearing completion. The additional facilities include special equipment and separate rooms for assessment and treatment related to Vision, Hearing, Oral Hygiene and Health, Sensory Integration and Early Intervention. We have initiated the process to complete the work of equipping and finally setting up all the rooms now that the pandemic situation moves towards normalcy.

#### **Financial Statements:**

The figures stated below would indicate that the deficit has decreased for the current year even though there has been a trend in increase in the deficit due to expanding activities, decreasing rate of interest, increasing human resources cost and providing free and subsidized therapies. The reason for decrease was due the restricted activities of the Centre for part of the year.

Since the Centre funds all its activities mainly through the donations it receives from its well-wishers, we need to make a concerted effort towards raising funds through donations.

NASEOH (Gujarat) has a scheme for regular donations - SAROVAR. This scheme entails a firm commitment from the donor for a period of 5 years of a sum of Rs. 15,000/- or more in each year. The amount collected through SAROVAR is utilized for the running expenses of the Centre. The amount collected during the year through SAROVAR is Rs. 6,59,000/- from 28 donors.

We acknowledge and thank the staff at NASEOH (Gujarat) who through difficult and challenging times had risen to the occasion and worked for the children with all their heart and best interest of the institute during the entire year. We also thank all the parents who have co-operated with the Centre despite all the personal difficulties and constraints they had to go through.

NASEOH (Gujarat) acknowledges and thanks the Ahmedabad Municipal Corporation for their wholehearted co-operation and support.

Our deepest gratitude to all our donors and well wishers for their generosity and continued support.

### APPEAL

Each year, close to 250 children receive treatment and therapies at Kalrav, an assessment and treatment centre for children with developmental delay, from which on an average about 50 children visit the Centre daily for therapy and another 50 children attend the Blue Rose, a learning and activity centre for developmentally challenged children.

Due to COVID-19 pandemic, all activities of the Centre were affected, not just by the earlier lockdown but also because of the continued stress of infection to the child's already compromised immune system. To ensure that the continuous efforts of the parents, therapists and teachers of providing regular therapy and education are not lost because of the current global pandemic, NASEOH (Gujarat) had started giving online therapies to the children of Kalrav. About 60 children participated in the online therapy sessions during the year 20-21. Kalrav has also started giving physical therapy at the centre and children have started coming at the centre due to waning of the pandemic wave. Similarly, all learning and activities like dance, music and painting has been provided online to the children of Blue Rose.40 children had participated in the year 20-21 and are also enrolled presently at Blue Rose. The online solution is an imperfect solution but an absolutely necessary one for the children.

Each year, all treatment at Kalrav and learning at Blue Rose is subsidized by more than 50% of the cost to the Centre. Moreover, based on the previous years' appointments data of Kalrav, about 50 children are selected in "Regular Child" scheme and are given additional subsidy and free therapies to further reduce the financial burden on the parents and also to encourage regularity in treatments. The Centre also provides free therapies to all children daily in a fixed two-hour time slot and to all BPL Card Holders. About 50% of the total therapies during the year are given free of charge to the children.

But this year, due to COVID-19 pandemic, all activities of the Centre are being provided free.

Due to the expansion of the activities, NASEOH (Gujarat) had sought for additional space from the Ahmedabad Municipal Corporation in the building belonging to the Corporation, adjoining the Centre. The Corporation granted permission for construction of an additional floor on the adjoining building and for renovation and reconstruction of the ground floor of the building which has been leased to NASEOH (Gujarat) for carrying out its activities. About Rs.200 lakhs from the existing corpus has been utilized towards this construction, interiors, special play equipment and also for upgradation of the Center to meet the standards of the District Early Intervention Centre.

On account of the expanding activities of the Centre and the increasing treatment costs, the Centre faces deficit every year. Moreover, the Centre is seeking contribution towards the corpus which would also generate income to meet with the expenses of the Centre. All activities of the Centre are managed through donations and contributions received from well wishers and friends and we look forward to receiving such donations from our benefactors towards this project.

We would welcome an opportunity to meet you in person to give further details of our project and our activities should you require the same.

NASEOH (Gujarat) has recently introduced SAROVAR a scheme for donations to NASEOH (Gujarat). This scheme entails a firm commitment from the donor for a period of 5 years of a sum of Rs.15,000/- or more in each year. The Centre aims to collect 365 such donations through SAROVAR which would be utilized for meeting the running expenses of the Centre.

NASEOH (Gujarat) is a registered society and registered public charitable trust and is eligible to receive direct foreign donations under the Foreign Contributions (Regulation) Act.

All donations made to NASEOH (Gujarat) are eligible for deduction under section 80-G of the Income Tax Act. Cheques to be drawn in favour of NASEOH (Gujarat).

## 2 months : Social Smile

On completion of 2 months a child should smile in response to your smile





## 4 months : Head Holding

On completion of 4 months a child should be able to hold its head erect when held upright

## 8 months : Sitting Alone

On completion of 8 months a child should be able to sit alone with a straight back without any support

# 12 months : Standing Alone

On completion of 12 months a child should be able to bear weight on two legs and stand up with no or little support

Make sure that the child can see, hear or listen
