The scheme provides for an insurance cover of Rs.1,00,000/- bifurcated into sub limits covering Facility for OPD treatment including the medicines, pathology, diagnostic tests, etc, Regular Medical checkup for non-ailing disabled, Dental Preventive Dentistry, Surgery to prevent further aggravation of disability, Non- Surgical/ Hospitalization, Ongoing Therapies to reduce impact of disability and disability related complications, transportation and Alternative Medicine for Divyangjan in these categories all over the country.

The Niramaya Health scheme is being implemented since 2008 and at present the no. of beneficiaries enrolled under the scheme are more than 1,00,000.
