In the Annual Report, on the work & activities of the organization, my aim is to after a candid view today and a realistic vision of how we can better deliver on the promise of Asansol Anandam.

We have already set a vision for our dedicated mission. All aim to make the organization approaches more integrated and co-herent, reflective of a more comprehensive undertaking for the greater cause.

But, if we speak of our glories only, it may be prevarication of truth. We have to identify our flaws, mistakes & deficiencies and certainly to get rid of them and avoid for suffering in future. So, we have to be alert enough to combat any adverse situation prudence, perseverance, patience, devotion and determination will be the key force in the days to come. Pointing to out the weakness has not been a measure to denigrate. This is a compulsion that will help the organization more ahead in the right direction and right path.

We have started our journey since 3rd August, 1992 with active & sincere support from our well-wishers and blessings & guidance from all corners has inspired a lot to work for the cause and to bring the differently abled persons to bring them in the main stream of the society for a sustainable life with dignity.

We are, at present, working with 105 Nos. of 'Differently Abled Children' and there are 9 Nos. of specially trained and experienced teachers. We feel that sincere support and caring services are much more needed for the increasing number of special children. In fact, we are in a crisis for qualified teachers, professional & therapist, which is urgently needed for scientific assistance in our organization. But, it is needless to mention that due to very poor and limited financial-resources & potentiality, we are not in a position to extend our full-fledged services and development work. We are facing acute problems to engage more therapist in different area due to our financial constraints.

In the above back drop, we have to be prepared enough to face any new challenges in the year to come and new normal situation with our unity, dedication and devotion. We, however, have a strong believe and confidence in the most needed support and assistance from Central Govt. as well as State Govt. and certainly in our well-wishers in the society. We know it very well that

our journey is through the many odds and crisis. We have to remain firm and will continue our journey at every cross-road as we have experienced in the past years. We must remember our history and we also believe that past creates present and present will create the future. Because, experience is the best teacher.

On this auspicious day, let us again renew our pledge to re-inforce our best effort for our commitment towards Persons with Disabilities (PwD), Children with Special-needs to bring them in the main stream of the civilized society for a suitable, sustainable and a meaningful life with full of dignity. This is the primary objective of our organization with a prudent & pragmatic leadership. We think that leadership is a responsibility not a crown.

1. Our Educational Services :

A. For the children with Intellectual Disability –

Grouping is done into different levels based on the ability and chronological age. The details are given below –

a. Play Care Group [Age Group below 6 years] -

The coverage areas are readiness skills, language and communication skills, thinking skills, play way education and music therapy.

b. Pre-Primary-I [Age Group 6 years to 9 years] -

The coverage is more in personal, social and academic areas along with occupational area.

c. Pre-Primary-II [Age Group 6 years to 10 years] -

Children who are less able than children of Preprimary-I are placed in Preprimary-II.

d. Primary-I [Age Group 10 years to 13 years] -

Children who achieve 80% of the items covered in the Preprimary level are placed Primary-I. The coverage made are in the areas of personal, social, academic (including time, money concept), occupational and recreational (indoor, outdoor) etc.

e. Primary-II [Age Group 10 years to 14 years] -

The students who cannot achieve 80% of items covered in Preprimary level are placed in Primary-II. Upon achieving 80% of the items covered in the Primary-II, they are promoted to Prevocational-II. In case one achieve 80% before reaching the age of 14 years, he may be promoted to secondary group.

f. Secondary Group [Age Group 14 years to 16 years] -

This group is a mixed group comprising of children promoted from both Primary-I and II, students who achieve 80% of the items in this class including the items in academic areas are promoted to Pre-vocational-I and those with lesser achievements are promoted to Prevocational-II.

g. Prevocation-I [Age Group 16 years to 18 years] -

The primary focus of training is on preparing students in basic work skills and domestic activities in the class i.e. the major content covered in the checklist are in the areas of occupational, social & academics skills.

h. Prevocation-II [Age Group 16 years to 20 years] -

This group covers children from 16 years to 20 years with lesser ability than the children of Prevocational-I level. The content of coverage will be minimal or need based for this group of students.

i. Vocational Training Group [Age Group above 18 years] -

Intellectual Disabled students over 18 years of age are sent to vocational training units with their summative evaluation reports for further programming.

B. For the children with Hearing Impairment –

Normal educational curriculum is followed. Main subjects taught are literature, mathematics, general knowledge, science, art and craft. Classes are divided into morning and afternoon sessions. Group classes run in morning session and individual classes are taken in the afternoon.

Auditory training is one major thrust area. It helps to develop sound awareness and identify sound differentiation. Terminal examinations are conducted with true spirit in regular course & performance report of the examination are published in presence of parents.

C. For the children with Cerebral Palsy –

Cerebral Palsy section is divided into C.P.-I & C.P.-II based on the cognitive level.

D. For the children with Multiple Disability –

Multiple Disability section takes care of children who have more than one disability. for the children with multiple disability and cerebral palsy, curriculum adopted is in the areas of Motor, Auditory, Visual i.e. Physical area development, Functional & Self Help area, Cognitive area, Play, Language, Social Behaviour, Emotional Status, Behaviour Management and Work habit development.

E. Management Intervention Services [M.I.S.] –

Individualized service is given to the children belonging to Intellectual Disability/Cerebral Palsied/Hearing Impaired/Multiple Disability categories. Management Intervention Service is extended to areas like Behaviour Management, Physical Management, Communication, Self-help, Pre-academics, Academics etc.

2. Physiotherapy Services & Occupational Therapy :

The therapists, social worker, our special teachers work together aiming at integration of developmental programmes and therapy. We also provide facility for swimming and hydrotherapy to all the special children.

3. Assessment Services :

Assessment service aims at understanding learning delay and special educational need in general. It also helps in assessing speech delay particularly of hearing impaired children and need of motor development and physical management programme for cerebral palsied/physically challenged individuals.

4. Supplementary Services :

Supplementary services are given to the children from economically weaker sections in the form of extending medical care, providing books, stationeries (copy, pencil, rubber, crayon box etc.), special aids (e.g. hearing aid, wheel chair) etc.

5. *Very proud to inform that we are being registered in “Kanyashree Prakalpa” in few years back, which is a unique scheme of Govt. of West Bengal, this is a strong recognition by UNESCO.*






