
# ABOUT MENTALLY DISABLED OPHAN CHILDREN HOME, MOHARI ROAD, PATHARDI, DIST. AHMEDNGAR:

The Residential Children Home for Mentally Challenged children is functioning since year 2009. In this year 1 orphan mentally disabled child namely Mr. Yash Anil Jadhav was newly admitted in the School by order of Child Welfare Committee, Nashik on Dt. 7<sup>th</sup> April, 2017. At present 51 orphan (45 are below 18 years and 05 above 18 years) mentally disabled children are accommodated by the order of Child Welfare Committee in the school. The school provides fullest provisions of physical needs, medical aid, special education and training on socialization and efforts on rehabilitation. The stakeholders of the school use their stature of expertise in the best interest of the children.

The school management and administration is very cautious about its functioning. The organization focuses on two issues: one functioning of the organization and catering to the children. The functioning of the organization is monitored through its documentation whereas catering to the children is monitored through following **child care plan**.

The functioning of the school time to time assessed by six different bodies i.e. (i) District Judge, (ii) Child Welfare Committee, (iii) District Social Welfare Officer, (iv) District Women and Child Development Officer, (v) District Education Officer (Primary) and District Special Medical team. These independent bodies appreciated the work of school moreover; school administration is open armed to take their remarks and suggestions for perusal.

By submitting all the documents and criteria for getting your ISO standard for your school, a proposal is offered for your school ranking.




