It is an honor to share with you our journey this year. We were one of the organizations that was able to quickly adapt and move towards the virtual world in the pandemic. We can proudly claim that we were able to create an impact that was double in comparison with usual conditions. This pandemic inspired us to think in different ways to tackle the current problems.

At the very onset, it was a great pleasure working with corporates and partner organizations to understand their needs better. We were able to reach out to remote places like tsunami-affected areas and towns which was harder for the other organizations to reach. We were able to expand ourselves and reach areas like West Bengal and Uttar Pradesh to create a deeper impact.

In the coming year, we are looking forward to creating an impact with education and reach out to students with disabilities throughout the nation who are deprived of an opportunity to attend schooling due to lack of accessibility.

The year 2019-20 has given me a chance to learn from the pandemic experience and say with confidence that we were able to achieve and create a ripple effect. I am thankful to volunteers, partner organizations, and our well-wishers for being a part of our journey. Most importantly our team who put in great efforts worked tirelessly and as always made sure that we run the show successfully.

# PROJECT SVASTYA :

## A HEALTH INITIATIVE

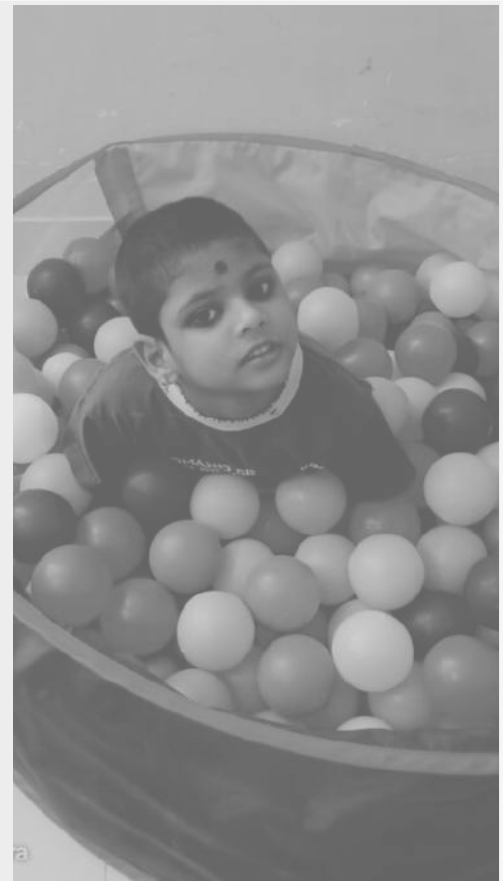
According to WHO estimated 5.2 million children under 5 years died mostly from preventable and treatable causes. India accounts for the second-highest country in the world for deaths of children below 5 years of age. Children who survive, don't reach their full potential. Research studies have proven that early Intervention is particularly beneficial during the first thousand days of life due to rapid brain growth and neuroplasticity, helping better positive functional outcomes for children with disabilities. As per the 'UN Convention on the Rights of the Child'(UNCRC) and SDG 3,4,5 & 10 every child has the right to achieve their full developmental potential and must be supported in this by their caregiver, family, community, and wider society. According to the National Disabled person statistical profile of India, there are over 2 lakh Children with Developmental delays/Disabilities/Malnourishment below the age of 8 years and the numbers are only increasing since the pandemic.

Children are lacking access to rehabilitation services and with schools being closed their social skills and nutrition status is deteriorating. Children are having signs of delay in achieving age-appropriate milestones and are developing secondary complications and deformities. Parent/caregiver burden has increased as they have to act simultaneously as their therapists and teachers. Tele rehabilitation /Education has not been effective due to regional and household disparities in access to the internet and technology. There is an immediate and urgent need to provide early childhood intervention and care to Children with Developmental delays/Disabilities/Malnourished and empower parents as research suggests that brain is most plastic during early critical years. stimulation & intervention can maximize Child's functional independence and minimize disability to ensure enhanced quality of living.

### OUR GOALS AND OBJECTIVES

1. Provide quality early childhood care and education to children with developmental delays, difficulties, disabilities, and disadvantaged and support their families to ensure equal opportunity and inclusion.
2. Sensitize and capacitate stakeholders to strengthen the existing linkages and build a sustainable inclusive ecosystem.

# COE LEAD MESSAGE

---

The Health COE caters to Children and People with Disabilities where we follow a comprehensive rehabilitation program – i.e. we take care of children right from birth to geriatric. Our approach is based on the World Health Organization’s community-based rehabilitation model and is in alliance with all Indian Acts, all the International Acts, UNCRPD, RPD, the national trust, the Child Rights Act. When I say comprehensive rehabilitation in terms of health we provide therapies for people, we provide for medical needs, surgical needs and we also give adaptive devices to Children and People with Disabilities.



Apart from health, we include these children either at Anganvadi or Preprimary Schools and for older children about eight to ten years are provided free vocal training; and once they are eighteen if they want to continue further education we support them. If they want to choose a livelihood, we link these children to our project Swatantra – a livelihood initiative by GiftAble.

On the social front, we help in the formation of self-help groups and parent support groups and also provide government-certified courses for parents so that they could be a pool of human resources created at the village level. We empower by building their capacity for local NGOs and conduct sensitization with government stakeholders which help in building a strong and supportive ecosystem. Our primary aim is to serve in the backward district of our country known as the aspirational districts.

Through our School Rehabilitation Program, we provide therapy and medical needs for school-going children with disabilities. We have also initiated providing technical and funding support to our partner NGOs for implementing the work that we do.

I dream of the day where need-based services are provided in rural Indian with all kinds of health services at the village level.

# EARLY INTERVENTION AND EARLY EDUCATION PROGRAM

**Aims to identify children with developmental delay, cerebral palsy, autism, intellectual disabilities and multiple disabilities were given.**

**children to learn basic and new skills that they would have ideally learned themselves in the first three years of their life.**



**Center-based service:** Child along with parent visit to avail the established early intervention center to avail the therapies using equipment specific to the disability.

**Home-based service:** Therapists or Early interventionists deliver the service at the child's home on predetermined days. This empowers the parents to conduct the therapies at home daily.

**Sub-centre/ Community center-based Service :**

Therapy services are delivered through a partner organization or a suitable center which is accessible to the caregivers and children such as Anganwadi schools, homes, or PHC where 4 to 5 children or more can access.

**THROUGH THIS PROGRAM, OVER 5000 CHILDREN WERE SCREENED BY EARLY INTERVENTIONISTS. CHILDREN WITH DEVELOPMENTAL DELAY AND OTHER DISABILITIES WERE THEN GIVEN THERAPEUTIC INTERVENTIONS AT HOME, AT A CENTER, AND AT THE SUB-CENTER/COMMUNITY LEVEL.**

# Major Project Activities in 2020-21



## Distribution of Adaptive & Assistive Devices to Children and People with Disability at Rural community of Bangalore

With the help of INNER WHEEL CLUB OF BANGALORE, GiftAbleD conducted clinical assessments and provided customized assistive devices, that are the right measurement for the concerned beneficiary. We facilitated trails and also trained the beneficiary in effectively using the device. During the year we distributed 10 unilateral Ankle Foot Orthotics and one pair of Gaiter to 5 Children with Developmental Delays (M-1 & F-4) and 3 wheelchairs to Adults with Locomotor Disability (M-1 & F-2) facing difficulty in movement.

## Health Session

Covid-19 brought the whole world to a standstill from March 2020 onwards. During this time, GiftAbleD initiated Health sessions on various Disability topics and completed 17 sessions with 1023 participants from India and Abroad. These sessions have been facilitated by Medical and Rehab Professionals along with Sign Language Interpretation to include all kinds of participants.

## Health Video

To support front line workers (ASHA, Anganwadi and ANM) with reference material and additional information concerning Children with Disabilities, GiftAbleD developed pertinent animated videos based on the RPwD listed health topics. These short 2 to 3-minute videos are easily accessible to all – front line works as well as parents, through our website and is also available in multiple languages.

# Major Project Activities in 2020-21



## Hearing Aids Distribution

As per the 2011 census report, there are more than 3000 thousand children born with hearing Impairment in the Northern regions of Karnataka State alone. We choose the four most backward districts of North Karnataka in Koppal, Raichuru, Bagalkot and Gadag. Along with the support of partner organizations - Smarthya, Ashadeep and BD Thati we conducted clinical assessments and identified children with hearing impairment who required hearing aids. GiftAbleD distributed Signia Run SP BTE (20-/120dB)- German Brand hearing aids to these 29 children.



## Rehabilitation Council of India (RCI) Approved Continuing Rehabilitation Education (CRE) programs

In collaboration with NIEPMD, we have successfully completed three State-level CRE programs in Karnataka, West Bengal, and Maharashtra online. These programs were conducted to upgrade the knowledge and skills of in-service and practicing rehabilitation professionals/personnel, registered with the RCI u/s 19 of the RCI Act of 1992; and to update professional knowledge and skills of master trainers working in the field of disability rehabilitation and special education.



A total of 150 rehabilitation professionals participated in the CRE on Behavioural Management held in October 2020 and CRE on Role of Play in early childhood developmental disabilities held in February 2021 and a CRE on Community Based Rehabilitation (CBR) was held in March 2021.

---

# PROJECT SWATANTRA :

## A LIVELIHOOD INITIATIVE

India has over 10 crore People with Disability and their caretakers put together. People with disabilities and caretakers have always been marginalized with almost negligent opportunities to earn their livelihood. This holds especially true in rural areas where they are dependent on charity or government doles for their survival. They have not actively participated in their emancipation due to their lack of economic independence and illiteracy. They should be organized and strengthened at the grass-root level to reduce their subordination.

GiftAble Foundation is making an attempt in that direction to make rural persons with disabilities and their caretakers self-sufficient through various training. The main aim of this program is to enhance the quality of life of Persons with Disabilities and their caretakers through increased knowledge and skills. GiftAble also realizes that merely imparting literacy will not be sufficient. GiftAble addresses livelihood challenges by building an end-to-end platforms- Skilling, Product Design & Development, Supply Chain Optimization, Marketing, Technology.

Swatantra is an attempt to make rural Persons with Disabilities and their caretakers, acid attack victims, transgenders, underprivileged and single women self-sufficient and economically independent by giving them relevant employable skills, in partnership with local resource training centers.

Swatantra follows 2 models

**Direct Training:** Operational and capacity building training support to People with disabilities and other marginalized minority groups. This model also includes business & financial management skill training for beneficiaries who are aligned to product-based training. Direct Training provides disability & region- specific skill-based training which will lead to livelihood opportunities.

**Train the Trainer:** This model builds the capacities of the trainers through training workshops for any organization working in the space of disability. The main aim is to upskill the trainers in current market requirements.

### OUR GOALS AND OBJECTIVES

1. To empower People with Disabilities and their caretakers self-reliant through employment, craft unit, or micro-entrepreneurship.
2. To Upskill the trainers working in the space of vocational training with new craft skills, hence building the capacity of the trainers.

# TRAININGS CONDUCTED

## SEWING SKILL TRAINING

People with minimal educational qualifications have very few chances of securing a job in the formal sector. People with Disabilities and their Caretakers find themselves inept at supporting their families due to the absence of any professional skill. Skilling them in the everyday needs of people like stitching various fabric-related products will provide self-employment at their homes, which can earn them a daily income. Sewing Training is focused in the Nagapattinam and Thiruvallur region of Tamil Nadu. Tsunami waves that struck the Coastal Areas in Tamil Nadu in December 2004 have caused immense damage to human lives and properties and Nagapattinam remains one of the most affected areas to date.



## SPICE AND INCENSE STICK MAKING TRAINING



Entrepreneurship development for the Persons with Intellectual and Developmental Disabilities including Autism Spectrum Disorder, Cerebral Palsy, Intellectual Disabilities, and Downs Syndrome. People with Disabilities are paired with one of their Caretakers and are trained in an assisted environment. Trainees will learn the mechanism of processing incense sticks and spices which also includes other associated skills like packaging, sealing, sorting, counting, dispatch, stocking, and raw material maintenance.

After completion of a 3 months center-based training, the Person with Disability along with their caretakers will be trained on independent entrepreneurship for 3 months with machinery and raw materials support. The products thus produced are bought by the center and through their various networks are sold by the center and profits are shared with the beneficiaries.

# IMPACT STORY



"This is just a beginning and I have a long way to go, I dream to have my own boutique one day," says Punitha. Punitha is a Deaf from a small town. She is a mother of 2 little ones studying in primary school, and a daily wagger & Sole breadwinner, earning Rs 150-200 per day. Punitha came to our Dream Center in Thiruvallur with a lot of interest to learn. 3 months of hard work & training, & today here she is, calling herself an entrepreneur. Punitha has started taking orders from her neighborhoods & earned her first income of Rs 3000 in Jan 2021. She has also registered at TN Society & expecting many more stitching orders.

## COE LEAD MESSAGE

Livelihood for the disability sector has always been a challenge, especially for the rural section of society. In this sector, it requires us to match the skill training with disability type, we cannot have the same training for everyone. We have to understand the abilities and limitations of each. It is not just persons with disabilities but even their caretakers whom we have to look into while planning a training. Along with the skill training, we also have to note whether those skills will be helpful and will those generate a sustainable income in the respective geographical area where they reside. We understand the needs and demands in the market growth for the skill and empower the beneficiaries to build a business around the same. We have deviated from the traditional method of fitting everyone into the same skill training to customized skilling. We are able to replicate the models and accelerate the programs in different areas. We look into more collaboration of like-minded organizations to cascade this effect. We also aim to promote supplier diversity through which the products made by our beneficiaries reach the customers and we believe this will create more employment opportunities in the future.



In the year 2020-21, we focused on Training the Trainers with different skills and initiated 3 Skill centers. Today we are successful in partnering with different organizations across the nation that has joined hands with us in making an impact.

# PROJECT SCULPT : AN EDUCATIVE INITIATIVE

Learning is a process of acquiring new understanding, knowledge, behaviors, skills, values, attitudes, and preferences. Learning for Children with Disability involves a holistic approach to schooling. It occurs when a child can gain a mental or physical grasp of the subject, make sense of a subject, event or feeling by interpreting it into own words or actions. The main objective of the GiftAble Sculpt e-Learning Program is to Help Children with Disabilities acquire age-appropriate competencies through a self-paced learning mechanism.

## COE LEAD MESSAGE

---

The education Centre of Excellence (CoE) is the youngest initiative of GiftAble and was born from our deep understanding in the education space with respect to Children with Disabilities. We strive to give Children with Disabilities access to quality, competency, and concept-based learning. we aspire to create an impact not just in India, but across the world.

Children have not been able to attend school in the last 16-17 months due to covid. They have lost all learning that is supposed to happen in that period. It is staggering for a child who has missed out on learning and most children have forgotten a lot of what they used to know in March 2020. The learning gaps have widened. There is a need to have a thorough and systematic plan as to how we deal with this, which can only be described as an absolute state of emergency in education.

GiftAble - Sculpt -eLearning program has been developed keeping these crucial points in mind. It is a remedial program that is designed to bridge the learning gaps in children for the pre and primary grades. Through our collective experience and thorough research in learning methodologies, we have developed learning modules which are self and assisted learning in concepts under Literacy, Mathematics, Social & Emotional, Science and Social Studies in 9 languages along with audio recordings of every module in all the languages. The unique process of Sculpt assesses gaps in the conceptual clarity of a child, and then guides the child to appropriate learning content to bridge these gaps.

# PROJECT LEARNABLE: VIRTUAL COURSES FOR PEOPLE WITH DISABILITIES

A more recent study conducted by Cyber Media Research Ltd. in 2013 in the IT - BPM Industry, revealed that the percentage of employees with disabilities vis-a-vis total employees was only 0.36%. According to equiv.in, a recruitment platform only 34 lakhs of about 1.34 Crore People with Disabilities in the employable age have a job in India. According to NSSO just 1.2% of the 3.6 lack disabled youth are in the Universities and Colleges. It brings the stark reality into an established truth that India's higher educational system is not accessible to 98.8% of its disabled youth.

GiftAbleD runs virtual crash courses for Youth with Disabilities to provide highly demanding tech & non-tech job opportunities in the corporate world. Primarily our objective and focus are to create a trained cadre of youth with disabilities with skill sets matching the industry requirements. And all classes are accessible for People with Disabilities. Students from the across India can join the course and course will be conducted in English language.

## Rakhi Chikki

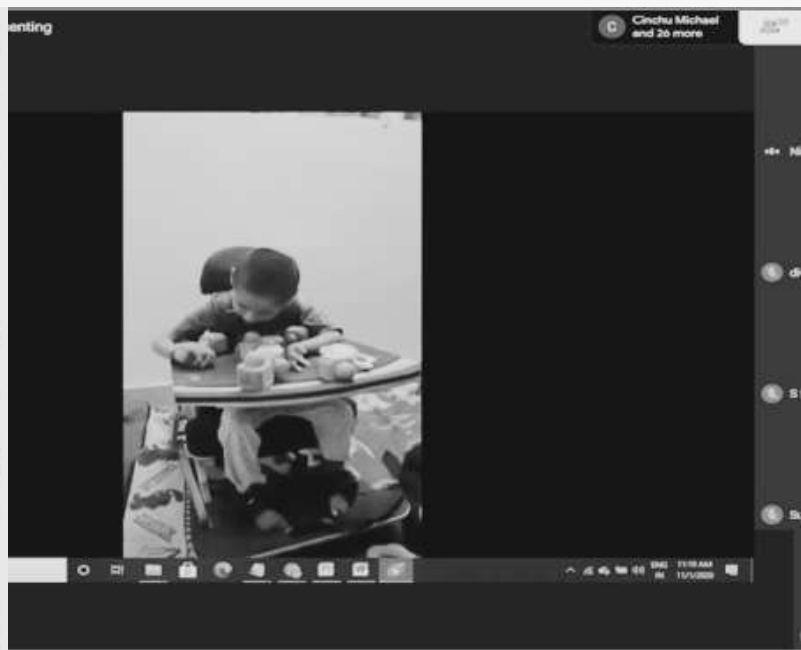

## Be a Career Mentor

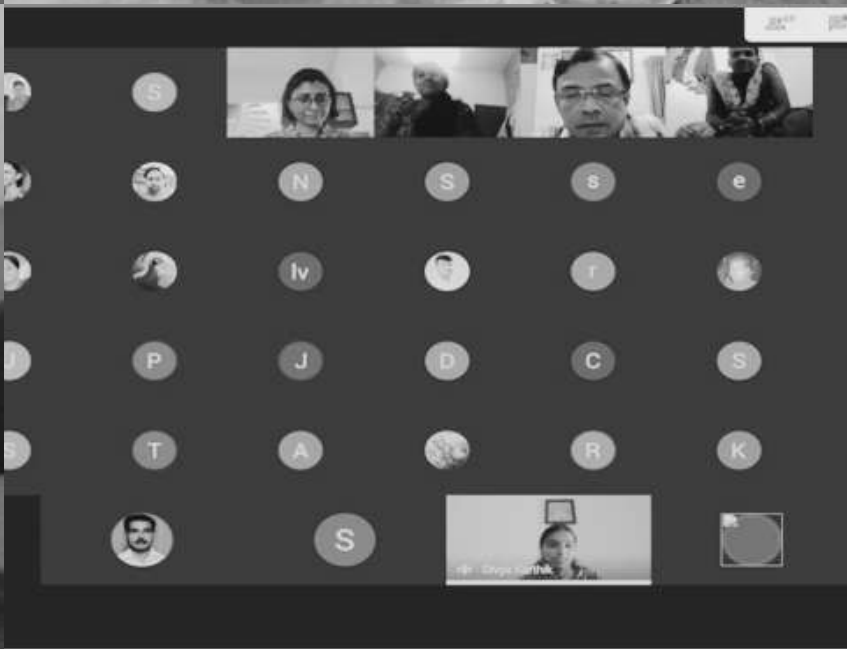
