The types of activities undertaken by the association are to organize parents meeting from time to time, workshops, Advocacy for inclusion in society, seminars, and guidance to parents as and when required, take up issues with Govt. related with their Rights, rehabilitation and different types of schemes and benefits provided by the Government.

❖ Activities in the Year 2021 - 2022

- Met with Director CAPD regarding AAY/PHH Ration cards to disabled people. Department completely fail to evolve a proper mechanism.
- No games for children with special needs was conducted by SOB in JK UT. So no need to provide any data to anyone.
- Meeting held at DC Office regarding a case of Guardianship with DC Jammu along with CMO, DSWO, Bank Official and myself.
- Meeting with Director Airport and Comdt. Central Industrial Security Force at Jammu regarding difficulties faced by disabled people and remedial measures suggested by NGOs to be taken care.
- Composite regional center for Jammu still in files not on ground after nine years. It has not be established in rented building yet. Why?
- Govt. approve transfer of land at vill. Chak jawala, Vijaypur for CRC. Our 12 years struggle yield results.
- On the eve of International day of persons with disabilities celebrated at Akhnoor, Jammu.
- Meeting with Director CAPD regarding AAY Ration Card. This order was issued way back on 22nd Aug.20 but still not implemented on ground.
- Aids and appliances distribution camp at Rajpura, Samba.

- Met with sh. Romesh Pandey and sh. Zafar Iqbal Nodal Officers CRC Jammu along with sh. Ajay Salaan DSWO Jammu at the proposed site for Composite Regional Centre.
