We are qualified expert in Neuro rehabilitation services. We are successfully running our Neuro rehabilitation centre under name of "Nai umneed A child neuro rehabilitation centre, at 130/E S.k Puri Boring road Patna-1 Since 2017. We are providing child Neurology and Neuro rehabilitation services as 1st time in Bihar with both of combination. Our major work is diagnosis of Neurological diseases in children's as well as its rehabilitation. Our centre "Nai umneed" providing day care services for around 40-45 patient in a day from 08:30Am to 06:30Pm (Monday to Saturday). We are providing services for Autism, cerebral Palsy, Down's syndrome, intellectual disability and multiple disability. Our services includes- Physiotherapy, occupational therapy, speech therapy, special education, psychological Assessment & counselling since last 4 year

We are also doing disability detections & early intervention programme time to time in different districts of Bihar, we are catering parents counselling, handling techniques & Education programme about special children's at our centre "Nai Umneed".

Goals

As per recent data by WHO children's with Autism increases day by day and now it has been reached upto ratio of 7 out of 100 children's Predominantly in boys, this ratio is suspected to be increased more in coming years. Since, Pathogenesis of disease (Autism) is not well understood, so there is no evidence of complete medical intervention care about disease. There are only few medicines only available to treat co-morbidities in children with autism, so research has shown that rehabilitation services is only main treatment available now a days like- ABA therapy, Physiotherapy, occupational therapy, speech therapy, sensory integration etc... In coming year. Our Aim is to provide childrens rehabilitation services for all peripheral regions in different district of Bihar By providing training of trainees ,Parent education and awareness, early Detection and intervention , Training of doctors/other Health care professionals, teachers of primary school about how to detect special childrens as early as possible and referred him for early intervention and rehabilitation services. We are planning to open branches of "Nai umneed" A child Neuro - rehabilitation centres at villages and panchayat level after involving stakeholder so that we can expand and provide services to special children, we will try to co-ordinate with others .NGO of Bihar so , that he can also come forward and help us in Rehabilitation of special children's of our society like - Autism , cerebral palsy , Down's syndrome and multiple disability . As we discussed earlier the Incidence of Autism is very High and pathogenesis of Disease is unclear . So, now a days it is mandatory to take certain action for early detection and intervention services for special childrens so ,that they can participate in main stream activities and help our Nation in Growth and Development .
