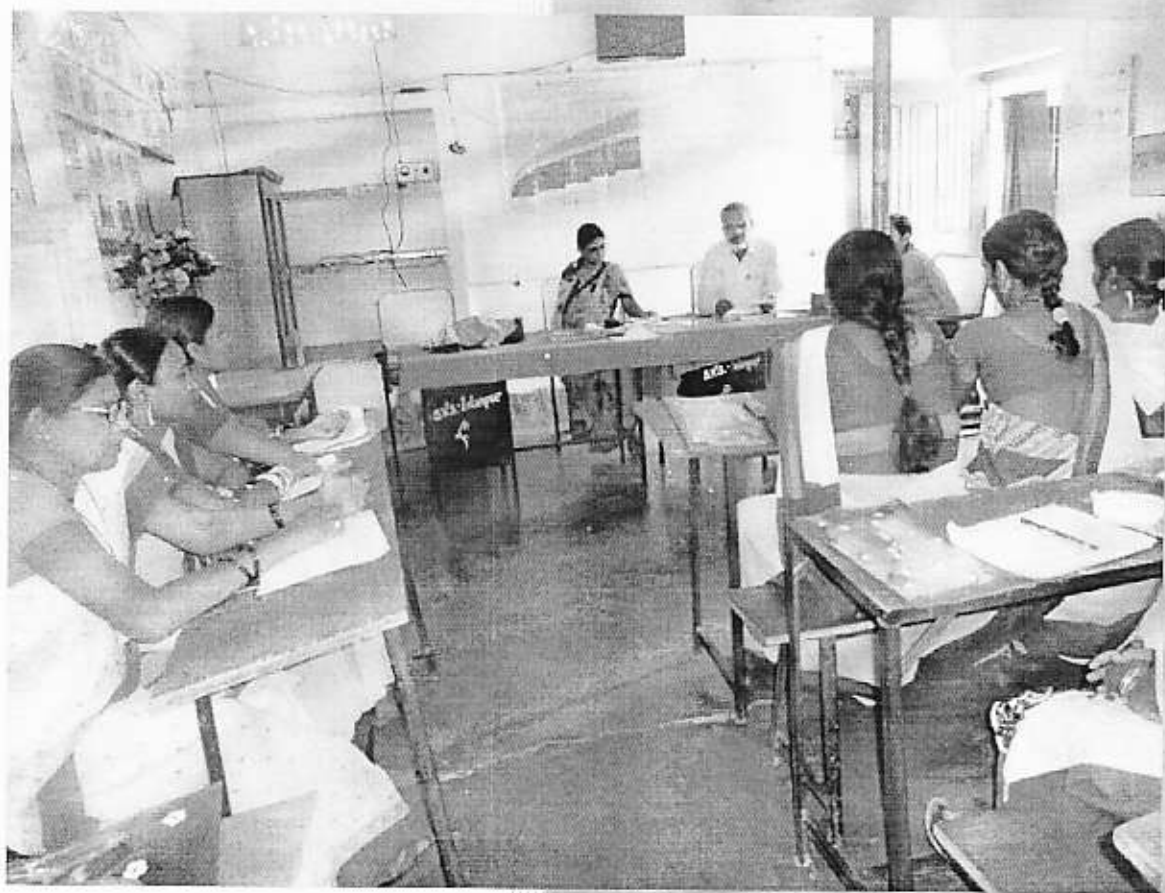

VISION:

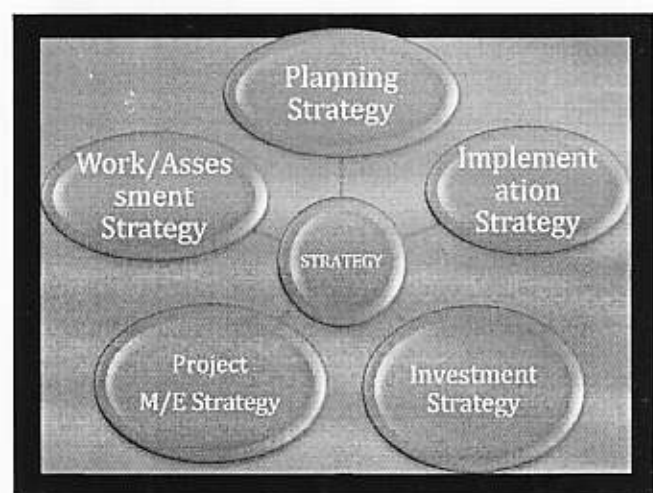
Establishment of peaceful, progressive and prosperous society based in the value of equality fraternity & mutual Co-operation.

ACTION & ACHIEVEMENT

Training- Capacity building/ management support is the fundamental part of our organization. We have been organizing various type of training programme as following:

- ANGANWADI WORKER'S TRAINING CENTRE FOR SEVIKAS/ SAHAYIKAS

Anganwadi Worker's Training Center has been running since 2005 at Patel Nagar, Gaya Road, Islampur (Nalanda) for Sevika/Sahayikas supported by Directorate of ICDS, Social welfare Department, Govt. of Bihar, Patna. Trained Seviks and Sahayika sensitized and aware regarding childcare, nutrition, immunization, breastfeeding, mother care, family planning etc. The training is the residential in which we provide Boarding, lodging, medical care, TA/DA etc to the sevika's/ Sahayika's.



- KUSHAL YUVA PROGRAMME (KYP) Under BIHAR SKILL DEVELOPMENT MISSION

We have been running Kushal Yuva Programme (KYP) since 2017 at Patelnagar, Gaya Road, Islampur (Nalanda) for the age group of 15 to 25 with the support of Bihar Skill Development Mission- Labour and Resources Department- Bihar. The main objective of this programme is empower the youth by providing them with requisite skills to fuel the growth of the State of Bihar.



DIPLOMA IN COMPUTER APPLICATION, BUSINESS ACCOUNTING & MULTILINGUAL DTP (CABA-MDTP) 'O' LEVEL.

SVS have been organizing "Diploma in Computer Application, Business Accounting & Multilingual DTP" (CABA-MDTP) 'O' Level since July, 2010. This course is jointly run by National Council for Promotion of Urdu Language (NCPUL), Ministry of Human Resource Development, Department of Higher Education, Govt. of India & National Institute of Electronics and Information Technology (NIELIT)- Chandigarh, Ministry of Communication & Information Technology, Govt. of India. In this course we transformation of Urdu speaking population into part of the employable technological workforce in the age of technology and computer. It not only provides job opportunity for Urdu speaking people but also increases computer literacy rate.



- COURSE OF COMPUTER CONCEPT (CCC)& BASIC COMPUTER COURSE (BCC)

SVS has been running these courses since 2011 at Patelnagar, Gaya Road, Islampur (Nalanda) with the support of NIELIT Chandigarh Centre- Chandigarh. This course is designed to aim at imparting a basic level IT Literacy programme for the common man. This programme has essentially been conceived with an idea of giving an opportunity to the common man to attain computer literacy thereby contributing to increased and speedy PC penetration in different walks of life.

- **SECRETARIAT & GRADE 'C' EMPLOYERS TRAINING PROGRAMME.**

We have been organizing Course on Computer Application & Concept (CCAC) supported by NIELIT-Patna Centre. In this training programme we trained to Grade 'C' Employers of Bihar Govt. Official. In this training we are providing Information Electronics and Communication Technology (IECT) area.

- **VIKAAS SCHEME (Day Care Centre) "RAHBAR"**

SPECIAL SCHOOL FOR PERSON WITH DISABILITIES (Cerebral Palsy, Mental Retardation and Multiple Disabilities)

Special School for Person with Disabilities (Cerebral Palsy, Mental Retardation and Multiple Disabilities) is running for Person with Disabilities in Nalanda district with the support of The National Trust Ministry of Social Justice & Empowerment, Govt. of India, New Delhi. In the VIKAS Scheme (Day Care Centre) "RAHBAR" PwDs are studying and got all the available facility. We are being provided them educational, vocational training, medical facilities, etc. In this school we provide respite home for Persons with Disabilities (PwD) atleast one of the four disabilities covered under the National Trust Act. It also helps in supporting family members of the PwDs with disabilities covered under the National Trust Act to get some time during the day to fulfil other responsibilities. The main purpose of the centre is to link these PwDs children with the main stream of the society to build the self-confidence and will power.



- **ONE YEAR URDU DIPLOMA COURSE IN URDU LANGUAGE (NCPUL)**

SVS have been organizing One Year Urdu Diploma Course since 2007-08 supported by National Council for Promotion of Urdu Language (NCPUL), Ministry of Human Resource Development, Department of Higher Education, Govt. of India for the development of Urdu Language. The main objective of this programme is to promote, develop and propagate Urdu Language. We distributed books and all relevant course materials. There is a provision of library

- **NIRAMAYA (Health Insurance Scheme)**

We are running NIRAMAYA (Health Insurance Scheme) supported by The National Trust Ministry of Social Justice & Empowerment, Govt. of India, New Delhi. The main objective of this scheme is to provide affordable Health Insurance to Person with Disabilities- PwD (Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities). There are total 126 enrolled/renewal Person with Disabilities (PwDs) under the NIRAMAYA (Health Insurance Scheme).

The scheme envisages delivering comprehensive cover which will

- Have a single premium across age band.
- Provide same coverage irrespective of the type of disability covered under the National Trust Act.
- Insurance cover upto Rs.1.0 lakh on reimbursement basis only.
- All persons with disabilities under the National Trust Act with valid disability certificate will be eligible and included.

- Services ranging from regular Medical Checkup to Hospitalization, Therapy to Corrective Surgery, Transportation.
- No pre-insurance medical tests.
- Treatment can be taken from any hospital.



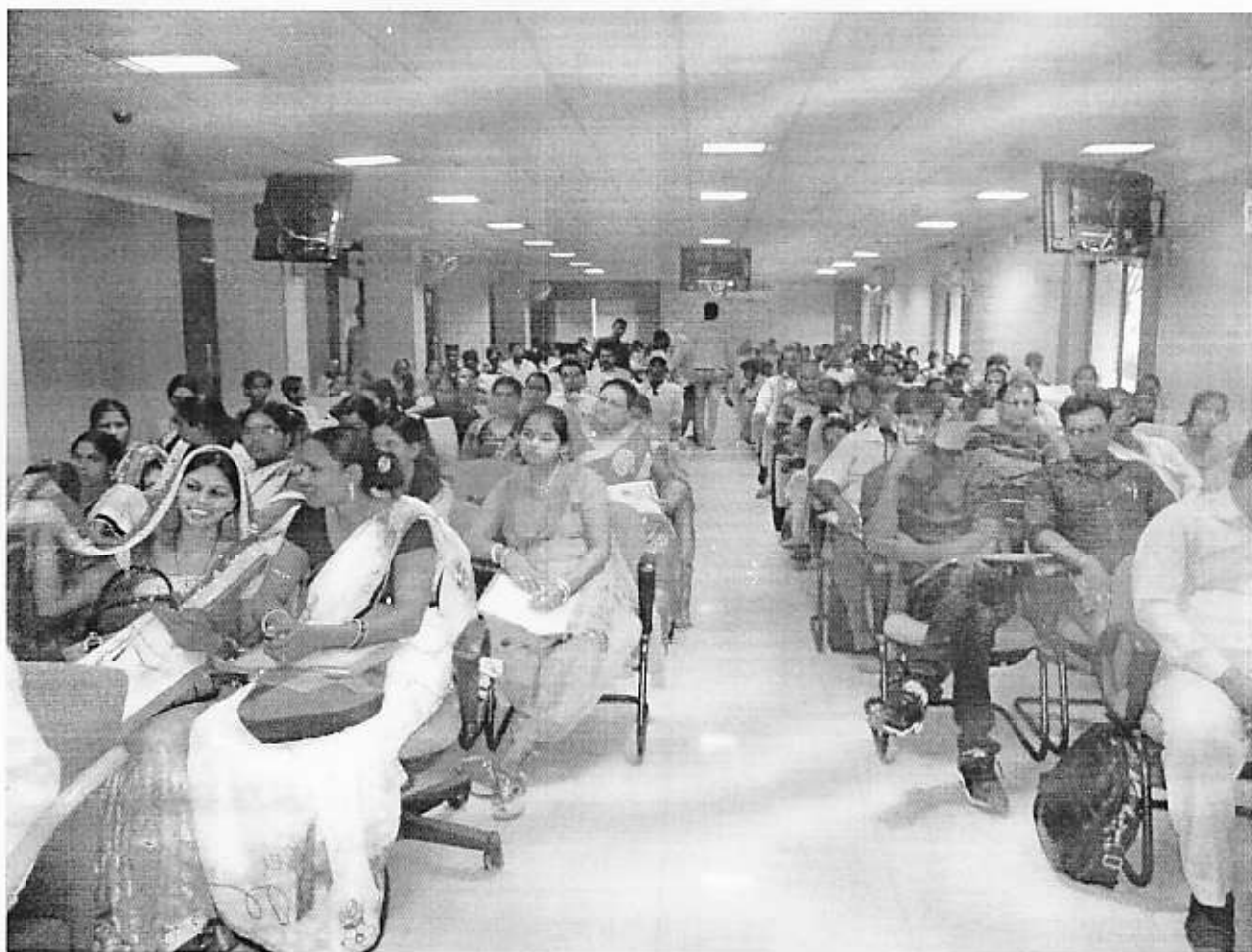
