Cerebral Palsy, commonly known as Spasticity is a condition which causes loss of control on the movements of body parts. At times it also adversely affects hearing, vision and mental faculties. All these things combined make an affected person dependent on others even for the basic needs of life. He /She needs somebody's helped and support for life time.

Parents of such persons are constantly tormented by questions like "Who/What after us? HCPA was formed to provide an answer to such questions. The basic objective was to provide a safe and secure place where these persons could spend the rest of their lives in case they outlive their parents. The mission was to establish a **HOME for SPASTICS**

We are proud to state that we have achieved our mission, though partly. Our dream has turned into reality. **Sneh-Kunj** at Dwarka, New Delhi is operational from March 2003. It has fully functional residential facility for 36 persons. It also has additional infrastructure to create accommodation for another 60 persons as and when the need arises.

Keeping in view the need of other categories of disability such as Autism, Mental Retardation and Down syndrome in addition to Cerebral Palsy. We have decided to open Sneh Kunj for them also. We have also started **EARLY INTERVENTION CENTRE** in our premises inclusive for infants from the age of 1 to 5 years. We have got competent faculty for Physiotherapy, Occupational Therapy and Speech Therapy. The Early Intervention is fully equipped with latest gadgets, and is spread in Area 600 Sq. ft. Our charges are most reasonable and competitive. We also provide Physiotherapy at very reasonable charges.

Annual Report on the Activities of HCPA for the year 2021-2022

During the year 2021-2022, the Managing Committee convened 7 Meetings to discuss, execute and review the programs and activities of the Association. A Brief Report on the Activities is presented below: -

Activities:

- 1. Respite/Prolonged/Life Care facility:** 5 children namely Tarun Dhingra, Vikas Gupta, Utkarsh Sahni, Vanket Murthy and Chaitanya Gohil, have been staying comfortably at Sneh Kunj under Life care/ Respite care Scheme on regular basis. However, 2 children namely Vikram Gulati and Vanshaj Gaba have been staying at Sneh Kunj under respite care scheme for short duration frequently, say 15 days to one month or two months. With the recruitment of additional staff, the stay at the Centre has been made comfortable. We purchased an MI TV for our Children's entertainment and also purchased a washing Machine for hostlers.
- 2. Day Care facility:** About 18 children (of grown-up age) are availing themselves of this facility. At present, 3 Vans are being used to pick up and drop them from various parts of the city. At the Centre they are attended by Special Educators and experienced attendants. One qualified physiotherapist provides them necessary exercise in accordance with their medical needs. During the Pandemic, our Special Educator provided online classes through google meet to our angels.
- 3. Celebration of Festivals/Birthdays:** All the important festivals e.g. Republic day, Independence Day, Lohri/Makarsankranti, Holi, Rakshabandhan, Janamshtami, Dushera, Diwali and Christmas were celebrated in Sneh Kunj. The children took active part and enjoyed in the music and Dance held on these occasions. The Birthdays of the beneficiaries were celebrated and their Parents/Guardians and Members of the Association felicitated.
- 4. Visit of other Organization** Age well Association visited our center along with their 25 members they interacted with our children and donated sum of Rs.19000/- and stationery kit for our Angels.

5. **Foundation day:** This year 36th Foundation Day as a get-together function was celebrated on 27th February 2022 in the lawns of Sneh Kunj. About 220 persons including guests and members of family and children participated. Special Children from Sneh Kunj, Special Children from Bal Vihar, children from Saksham Bharti presented their cultural and musical programme which were highly appreciated. One of the founder member Dr. **Sushil Kumar** was conferred with Lifetime Achievement Award. Lifetime Achievement award was also given to our most respected President K.N. Singh ji for his selfless dedication for HCPA.
