President's Message

As we turn another eventful leaf of the calendar, we reassert our commitment towards children and people with different abilities, with higher goals. As a matter-of-fact, Khushboo has been able to serve more children this year than in the past. We continue to focus on the qualitative aspects of our services i.e., improving the daily attendance at our day care facility, introducing need-based interventions which are therapeutic in nature as well as focused on self-development. Children have also been introduced to new sports-based activities to reshape their attitude and zest towards life. Our patrons are aware of our constant efforts to keep improving existing ways and techniques of interacting with children. We use latest technologies, chalk out creative programmes which are aided by scientific methodology and equipment.

Further, we are extremely happy that our consistent efforts in materialising our dream of providing a long-term residential care to specially abled persons (SAP) have started to yield results. Khushboo is getting closer to build its Residential Facility at Tauru in Haryana's Nuh district. It's going to be a unique space with supportive infrastructure for people with different needs. This will enable them to lead life with dignity and care. As of now, the entire documentation of the project has been completed, electrical and water connections obtained and a proper boundary wall erected to protect the campus. The detailed architectural plans have been prepared and the NOC for construction of the facility has been obtained from the local panchayat as well as the Department of Town and Country Planning. Some 40 kms away from Gurugram, Tauru in Nuh district is a part of National Capital Region (NCR) and is one of the aspirational districts recommended by Niti Aayog. It has decent infrastructure with planned markets, medical facilities and transport services. Having obtained the final sanction letter from the authorities, the next challenge is to raise sufficient funds to take our mission forward. We have been able to raise Rs 4.5 crore till now but require much more money to complete this ambitious project.

There's no denial that treating special kids is a challenging job, best enabled with innovative and evolving practices. New techniques are being introduced world over to upgrade expertise and knowledge. However, smaller organizations like us in India don't have access to the best of the global practices. Indian government should think of setting up a Knowledge Center which could act as a repository of all information on practices and developments in care of special children. Easy access to this repository will significantly improve quality of services being given to the children. This repository can also be expanded to provide specialised training for the caregivers or employees of such care centers functioning in the remotest corner of the country.

While the achievements have been many, the year of 2019-20 has turned out to be a very unique one, to say the least. The pandemic of Corona virus and its subsequent impact in the form of lockdown and consequent effect on economy have raised concerns. Since most beneficiary families at Khushboo come from the economically weaker sections, their earnings and employment have got severely hit. Certainly, there is a disruption in their lives. Also, we are expecting challenges in our fundraising initiatives. We notice more and more organisations have been trying to focus on mitigating monetary difficulties emerging from the evolving circumstances. Since corporate have limited corpus, this might lead to splitting, if not diverting of funds between the NGOs that they were earlier supporting and organisations attending to Corona-related challenges.

Therefore, there is an earnest request to the donors to continue to support the present work so that the children under our care do not get affected. These testing times have compelled everybody to be utmostly compassionate towards the disadvantaged sections. As Winston Churchill aptly said, "We make a living by what we get, but we make a life by what we give."

Addressing a serious concern of parents



New Initiative

Khushboo's close engagement with the families of special children gave us insights into their deep worries. The question they constantly ask themselves is "who will look after their child, when they die?" The siblings or the extended family are unlikely to provide care, especially in urban areas where families have become largely nuclear in nature with no one to fall back upon. Government, with its limited resources also does not provide any alternative care facilities.

Some major services which would be made available would be:

- Therapeutic services such as Physiotherapy, Occupational Therapy, Speech Therapy, Sensory Integration, Clinical Psychologist etc.
- Life Skills Building ie Education Assistive Technology, Computers, Yoga, Expressive Arts etc.
- Sports and other avenues of recreation.

These services would also be made available to the nearby community as a day care center.

The facility will have a head who will stay on the campus along with her/his family and would be assisted by few other residential staff comprising of special educators, other staff who will be trained as per the need.



About Us

Who we are

Khushboo Welfare Society (Khushboo) was established on 13 November 1995 as a non profit organization under the Societies Act, 1860 to provide holistic care and multifarious services to people with mental and multiple disabilities.

Vision

To have a society where the physically and mentally challenged lead a life of care, dignity and respect.



Mission

Help the physically and mentally challenged to become self reliant, realise their full potential and enhance their capabilities to the maximum possible.

What we do

We work with special children, adolescents and grownups with special conditions such as:

- Cerebral palsy
- Down syndrome
- Autism
- Mental Retardation
- Slow Learners

Our work focuses on:

- Provide relief to the families of these children by taking care of the children during part of the day.
- Provide continuum of care to these children on a long term basis.
- Help the children to become more self reliant through Life Skills building & Therapeutic programs.



Where we work

We run a day care center at Gurgaon, Haryana providing a range of services.

It is thus a multi-sector, multi-dimensional approach for people with disabilities, with joint participation of the family members and Khushboo.



Our Methodology

Each person approaching Khushboo for care is assessed extensively by our Diagnostics and Prescriptive team comprising of Khushboo staff and specialists from renowned hospitals such as Fortis, Max, and Medanta.

Based on this assessment, therapeutic/development needs are identified and an Individual Development Plan (IDP) is created.

Based on the development plan, the child is made a part of one of the following streams:

Regular enrolment

The child is also assigned to a group based on her/his age and ability.

The center delivers it services through two programs comprising of various activities and the schedule is based on the child's individual development plan.

Executive Committee

Khushboo is governed by an Executive Committee which focuses on good governance and mentors the management team to ensure high standards of service to the beneficiaries. Committee meets at least four times a year to discuss a pre-circulated agenda. The decisions of the meeting are recorded and confirmed in the subsequent meeting.



Mr. Rakesh Jinsi is an Electrical Engineer, having graduated from Punjab Engineering College, Chandigarh (Punjab University) in 1977. He has over 41 years of work experience in the Automobile, Not for Profit and Education sectors.

For over 21 years he has held leadership positions with organizations such as Eicher, Hero Motors, Chase Manhattan, Force Motors, Tata Trucks, New Holland Fiat Tractors, SOS Children's Villages and School of Inspired Leadership. He has been a member of National level bodies such as National Human Rights Commission and Voluntary Action Network of India (VANI), the Apex body of NGO sector, National Skill Development Corporation etc.

His current professional engagements include management consulting (change management and SMSE's), Independent Director on Boards of a few companies, NGOs & Executive Coaching.



Mrs. Renu Maheshwari (Vice President) is an active Social Worker, having worked in areas of Social Development and livelihood creation for Families of workmen. She was the founder of a Welfare Organisation "Prerna" at Hoshiarpur (Punjab), that worked with housewives in the rural area, supporting trades such as needle work, etc.



Mr. Narendra Gera (General Secretary) is a Mechanical Engineer running his own manufacturing enterprise. Is an active Social Worker. He is also on the Board of DAV Senior Secondary School, Khandsa Road, Gurgaon. He is one of the founder member of Khushboo and also parent of a special child.



Mr. Pankaj Jain (*Treasurer*), an entrepreneur in the Publishing Business, is a social worker and deeply concerned about the under privileged. He is also one of the founder member of Khushboo.



Mr. Rajiv Gupta (Member), is an Engineer having spent many years with M/s Maruti Suzuki. He is passionate about helping children with Disabilities and is a parent of a special child.



Mrs. Reeta Rastogi (Member), a Post Graduate in Education, is a teacher by profession and deeply engaged with development of children.



Col. M.S. Krishnan (Member), a Mathematics graduate from Delhi University and an Alumni of Indian Military Academy, Dehradun. A decorated war veteran who took part in 1965, 1971 & Srilanka operations. He had to retire pre-maturely after 32 years of service, due to injuries received during field operations. Now he spends time in supporting causes of public interest.



Mrs. Usha Malik (Member), a Post Graduate in Education, is a grass root Social Worker and has been associated with Khushboo for many years.

Deepanshu Ratra - Story of a transformation:Rooting for a better tomorrow

Deepanshu Ratra's extraordinary journey at Khushboo is a symbol of hope and transformation. Take a look.

If one goes by the first impression, Deepanshu Ratra, a child enrolled at Khushboo for more than 15 years, comes across as a disciplined, well-groomed and active individual. This goes against the typical image one would have of a differently abled person. He makes a special trip to the center to share his journey at Khushboo. which is currently operating an online format due to COVID-19 pandemic. He is fully aware of precautions to be taken, is wearing a neat uniform, a mask and is carrying a small bottle of sanitizer. One can even notice his conscious efforts of maintaining social distance with his brother who's sitting on a chair next to him. "He's very attentive and alert whenever he steps out of the house these days," chips in Deepanshu's elder brother Harish Ratra as he reveals how he is often scolded by the younger sibling for overlooking safety norms. "Fearing his pointing out, mostly our family wears mask," he quips.

TOUGH CHILDHOOD

For Harish, it is a surreal transformation of his 24 years old brother over the years. From somebody who needed assistance at every step to now becoming a helping hand for everybody around him, Deepanshu has come a long way. "He was infected with jaundice a few days after his birth, which eventually caused 'athetoid cerebral palsy' and major hearing loss," Harish says. Symptoms started showing up soon. Deepanshu found it difficult to control his body and developed involuntary writhing movements in hands, fingers and legs. He was totally dependent on others to even manage toileting. In a hope to find 'cure', his father, despite struggling to



make ends meet, had to run from pillar to post. "We didn't have money, no resources. We still visited several hospitals in Delhi, Gururgram, Faridabad, Rewari... met many doctors, but to no avail. As Deepanshu grew up, it had become difficult to carry him in the arms," says Harish. With nothing else visible, the family wished for a divine intervention. Frequent trips to religious sites were made; hawans and puja were performed by babas. But nothing helped.

RAY OF HOPE

A chanced introduction to Khushboo by an acquaintance was a turning point in Deepanshu and his family's life. In April 2003, as 7-year-old, he landed at Khushboo's premise along with his mother. At the time of admission, his challenges were highly complex and extensive. He required assistance with every aspect of life from managing personal care to communication and feeding. "After detailed assessment by our multidisciplinary team, a development plan was drawn for him. It was shared as well as explained to his parents as it needed their participation as well. As a part of the development plan, he was put on extensive physiotherapy routine," recalls Vijay Pal, Director, Programme, Khushboo. The family was given the comfort that no monthly fee would be charged, keeping in mind their financial condition.

With the sincere involvement of Khushboo's teachers, physiotherapists, psychiatrist and other occupational therapists, Deepanshu started responding to the interventions. Today, after consistent efforts of close to two decades, he has grown up to be an exuberant personality, fondly looked upon as the 'Pride of Khushboo'. He can now walk on his own and independently manage activities of daily living. He has also learnt to do simple mathematical calculations. He has passed an 18 months 'Ability Enhancement Multimedia Program' certified from AllMS Multimedia, and has also learnt Coral Draw, Photoshop and other advanced computer programmes as a part of the course curriculum. He can recognize time upto hours. "Now he is able to guide his classmates at the Center. He has also started helping fellow students in solving computer problems," something which is even recorded in Khushboo's annual assessment report.

KING OF KITCHEN


In Khushboo's kitchen, Deepanshu is an outstanding performer. His cooking and catering skills have earned him a whole lot of fans. He has been trained to make some delicious Indian and European dishes. He can cook staple Indian khichdi, pulao, matar aloo, daal, tamatar aloo, sabot dane ki khichdi, pasta, sandwiches to name a few. "He is a quick learner. It is not easy to put ingredients in the right quantity when you are cooking for 3-4 people but he gets it right mostly. He takes feedback seriously. Hamesha aakar puchega kami koi hai... namak ya cheeni kam toh nahi hai (He would always enquire if there was any shortcoming in his cooking... less salt or sugar). He wants to improve," shares Madhu Chauhan, teaching assistant.

SPORTY SPIRIT & LEADERSHIP

Chandveer Barak, Special Educator, Sports, calls Deepanshu a 'true sportsman in spirit'. "He tries hard to push his limits even though he is uncomfortable due to physical limitations," he says. Deepanshu has got varied interest in sports. He loves running, football, cricket, hockey, carrom, bocce ball etc, and has fetched many laurels at State and National levels in almost all of them. What impresses the sports trainer most about the 'special champion 'is his professional behavior when they travel out of station to play games. "He becomes an excellent commander and a follower at the same time. He follows instructions carefully and ensures others don't slip out either. He is willing to help other children in need or otherwise. He assists them in taking food, toileting and addressing grievances. In case of injury, he will be hyper active in assisting the attending expert. In case there's no warden at that time, we give him the responsibility to take care of the team," says Chandveer. Deepanshu has often surprised his teachers and family with his enthusiasm and perseverance. While Chandveer wonders "how he rolls the ball so smoothly in bocce ball or manages wicket-winning bowling in cricket", brother Harish is yet to win a Carrom match against him.

INTERPERSONAL SKILLS

Deepanshu is called a social butterfly by Shashi Bala, a programme supervisor at Khushboo. This compliment describes an intense journey of a boy from being recluse and helpless to a talkative and confident individual. "He could barely speak or walk when he came to Khushboo. Today, he has a friend circle of boys and girls and he loves mingling around with them. I feel so happy when I find him discussing about his teachers and family with his friends, like any regular student in other schools," says Shashi. In order to further sharpen interpersonal skills of the children, the supervisors encourage them to communicate messages and hold conversations. This boosts confidence and improves social skills. "Deepanshu volunteers to help other children communicate better. He explains to the teachers what they are trying to convey," says Shashi.

Deepanshu has carved a niche for himself with his generous, selfless attitude. While at school, he is supportive to other students, at home, he is busy caring for his ailing mother, and has taken over most of duties. Courtesy his multi disciplinary training involving Gastronomy, Home Management and Housekeeping at Khushboo, he is able to play helpful role in everyday chores at home. "Honestly, we are dependent on him," confides a smiling brother, calling Deepanshu "backbone of the family". "Our mother has not been well for a long time. So he takes care of everything, right from buying groceries to managing kitchen. He's a fantastic cook as well as a good bargainer," he adds. Deepanshu often takes pride in buying things at cheaper prices. Last November, his mother was admitted to hospital for almost a month. His brother attended to the hospital while Deepanshu took over charge of the home. "Now that she is back, he ensures she is at ease. He goes out to buy medicines, milk etc, and makes evening tea for her," says Harish. With time, Deepanshu has become fully aware of financial constraints. He has been saving up his disability pension(this was facilitated by Khushboo) which he now independently collects from the authorities.

LAYING THE ROADMAP FOR FUTURE

His challenges couldn't come in the way of Deepanshu's desire to dream of a better and secure future. He wants to set up a shoe store in Gurugram. Preps have already begun. His free time goes into researching shoe types, wholesale manufacturing, retail prices and latest designs. "I'll buy them from Delhi," says a charged Deepanshu, the moment brother Harish brings up the subject. He has been watching YouTube videos on shoe business and regularly hands over a list of contact numbers to Harish to check on latest developments in the market. "In a year or two, when my father is retired from his work, we will definitely try to establish a footwear business," hopes Harish.

It is a gratifying moment for everybody at Khushboo that Deepanshu Rawat is gradually maturing into an independent adult who is willing not only to take charge of his own life but also become a support to people around him. It takes years of hard work, dedication, discipline, perseverance, commitment and determination to reach such a stage.

IN THE WORDS OF FAMILY

Asha Rani, Mother

It was a challenge to cope with our son's illness. We did everything possible to find a cure. For the first few years, he was not able to sit and walk. It affected us emotionally and financially. However, Khushboo became our guiding light at the right time. Their efforts of years have been full of promises and growth. We decided not to visit any hospital after Deepanshu enrolled at Khushboo. Today, he is a man of skills and a great help. He is craving for a self-reliant future. He wants to apply for a loan and establish his shoe business. I will try my best to assist him in his future endeavours.

Virender Manchanda, Maternal Uncle

I have closely followed the struggle of Deepanshu's family. The parents were stressed financially but didn't give up on their son. Fortunately, his admission at Khushboo changed their life for good. He has been trained to manage all regular things on his own. He is also a support system to his mother, who has not been keeping well for a long time. I can say we had never imagined Deepanshu would grow up to be an almost independent person. He is a different human being than what he was 10 years ago. There's a zest in him to live life and tap his own potential despite apparent challenges.



Infrastructure & Facilities



Khushboo operates from a self owned campus of 0.4 acres, land for which was allotted by Haryana Govt. The campus houses a 17,424 sq ft of built up area which ensures easy accessibility to our children and confirms to the needs of the special children. The building specifications are as under:

- Wide staircases with easy to hold side-railings
- Big, steel, water dispensers on each floor
- Disabled friendly toilets near classrooms

At Khushboo, we are constantly trying to improve our services; be it in form of new amenities, modern machines, latest technology, innovative teaching aids etc. The aim is to make learning easy and fun.

Communication & Assistive Technology (CAT) Unit

First of its kind in India has been set up in collaboration with Ash Field Academy, UK. This is an impactful intervention to provide transformative and learning experience to children suffering from learning disorders, cognitive dissonance and communication motor impairments and comprises of:

- Interactive White Boards
- Special software for teaching



Transportation facilities

A fleet of 5 self-owned vehicles pick up the children from their homes and drops them back after the center closes for the day. All our drivers and attendants have been made aware of the home routes of each child. To ensure safety compliance all our vehicles are equipped with:

- Safety belts
- CCTV
- GPS tracker
- AC
- Side handles/ Boarding handles
- An attendant in the bus throughout the journey
- Licensed and skilled drivers









Computer Laboratory

This facility is housed in a bright room and is equipped with:

Our Programmes

Activities of Daily Living (ADL)

Children are taught to do the following routine activities on their own.

- Eating
- Bathing
- Dressing
- Toileting
- Personal care and hygiene
- Getting in and out of bed or chair easily (transferring)
- Controlling bladder & bowel movements (maintaining continence)
- Opening clothes buttons
- Filling water can
- Washing clothes
- Identifying toilets of their gender
- Managing time etc

Interpersonal Skills

At Khushboo, children develop their social skills to:

- Ask for assistance
- Make new friends
- Communicate clearly to have their needs addressed
- Hold conversations with friends and family
- Give their opinions



Personal Safety and Security

A very important life skill, special children are taught safety measures. They learn:

- Kinds of risks they may face
- How to avoid tricky/unsafe situations
- Awareness on personal safety
- Sense of right conduct
- Deterring unwelcome behaviour
- Difference between good and bad touch
- Safety precautions from fire, or sharp instruments such as knives or scissors











Education

Khushboo ensures that our children learn basic academics to the extent possible. The focus is on the following:

- Reading

Home Management and Housekeeping

This skill is important in everyone's life, more so for special children. Performing household tasks builds their abilities to work on their own and also be of help to their families. A big factor in building interpersonal relationships too, children gain self-worth and respect from their families. Amongst other skills, our children learn:

- Cleaning
- Dusting
- Table laying
- Bed making
- Ironing
- Setting up almirah
- Folding clothes
- Money Management
 (Familiarization with notes and coins and doing transactions while shopping)

Computers

Children who have requisite capabilities are taught basic computer skills and are also trained in special applications viz Photoshop and CorelDraw. The intent is to have a meaningful engagement for the children and at the same time impart computer skills.

Cooking and Catering

Children who have a little better ability are taught these skills so that they can be of help to their families.

One school of thought believes that gardening has some therapeutic effect, Khushboo involves children in this activity to have a meaningful engagement which can be done at home also.

Art and Craft

Science has proved that creative expression helps in emotional well-being. This skill helps children express their needs while benefitting from the immeasurable joy that art brings. At Khushboo children learn:

- Colouring
- Painting
- Drawing
- Crafting waste material into useful products

Therapeutic Services

Children under our care have serious medical afflictions. Hence, these services from the core of our work. Following interventions are carried out by us:

- Physiotherapy
- Occupational Therapy with Multi Sensory Integration
- Hearing & Speech Therapy
- Performing & Expressive Arts (Music & Dance)
- Pottery
- Yoga
- Sports

Physiotherapy

This intervention aims at:


- Strengthen and recuperate weak muscles through weight bearing exercises
- Enhance leg muscle capacity with standing programs
- Enable mobility with programs such as walking and the wheelchair use
- Identify and meet orthopaedic needs







- Based on the individual development plan drawn for the child a physiotherapy schedule is drawn for the child. The therapists work closely with the children and assess the need for aids - such as standers, wheelchairs, or any other orthotic devices.
- Help the child and family to become familiar with the required equipment.
- Conduct group sessions with other professionals.
- Advise supplementary home activities to caregivers after training them.
- Hold quarterly conference meetings with parents.
- Assist the child reach his/her developmental milestones that requires gross motor skills, like sitting, crawling, standing, walking, jumping, kicking ball, etc.
- Facilitate to achieve the desired goals through manual therapy, frame standing, standing bars, tilt table, parallel bar training, balance training, muscle stimulator etc.



Developing skills that are a must for daily living is the main objective of this intervention. Designed to improve basic motor functions and reasoning skills, the program helps prevent permanent loss of functions. The intervention uses methods such as multi-sensory stimulation and integration to:

- Help eat properly through Oral-Motor Exercises.
- Teach new activities through Imitation Techniques.
- Improve tactile sense through Touch Therapy Sessions.
- Tone up Body Balance through exercises like jumping, climbing stairs etc.
- Improve Motor Skills by picking and releasing small objects.
- Improve concentration & attention through clear commands.
- Cutting of flowers for improving hand-eye coordination.





Hearing & Speech Therapy

This intervention helps in improving speech of the children, and their ability to understand and express, including nonverbal cues. Our therapists work to:

- Test hearing ability of children
- Assess the problems & provide treatment.
- Identify difficulties in articulation, fluency, resonance, or language disorders.
- Demonstrate the right sounding words and practise with children to follow same using computer/ tablet.
- Ensure proper mouth coordination to produce sounds to form words & sentences
- Help with voice volume regulation.
- Address language disorders to help children express their thoughts.
- Use of written, pictorial, body & sign forms to help children develop their understanding.
- Practice on computers and iPads with special software applications to develop children's speech.





Psychiatry and Counselling

At Khushboo, counselling is an important and an integral part of the care process.

Good bonding with family plays an important role in a child's rehabilitative progress and this is exactly what this intervention does.

The process of counseling involves:

- Understanding child's uniqueness, Identifying their strengths and struggles.
- Developing a partnership between the teachers and the parents to bring desired changes in the child.
- Facilitating learning of new skills and trying new behaviours.
- Since the parents and the children struggle with challenges in everyday living, acquiring new skills lead to improvement in the quality of the life of children as well as the parents.

Pottery

This unique therapeutic intervention settles and calms children. It also manages to hold their attention for a longer duration and helps them focus. Pottery enhances a child's sensory development and motor skills. A pottery expert visits Khushboo to guide our children in the art of making diyas, pots, pen holders, and other clay items. Full of creative joy, this intervention boosts our children's confidence levels.



Yoga

Where conventional treatment methods reach their limits, yoga has shown remarkable results at different levels. Children with Down Syndrome and other development disability often surprise their families and teachers with quick mastery of basic motor, communication, and cognitive skills through practice of yoga.

Regular yoga leads to a greater concentration, balance, and composure in daily living, and long term gains include relaxation and softening of inner tensions, body —mind equilibrium, and a feeling of energetic buoyancy to carry through even the most difficult days.

At Khushboo we ensure children practise yoga asanas (postures), pranayam (breathing exercises) and listen to meditative music — using phonetics for healing. A yoga teacher oversees the session and conducts beneficial asanas for each individual case. After the session, children clean their yoga mats and keep them neatly rolled for the next class. Each day children attend their yoga class for one hour which has been formally included in the curriculum.







Performing and Expressive Arts

Dance and music is a great way to encourage muscle movements and greater joint mobility. They not only improve muscle tone, spatial awareness, and kinaesthetic sensation, but also stimulate endorphins and facilitate social skills.

These activities are specially tailored to meet individual needs, capabilities, and have the highest level of participation- so much that children eagerly look forward to these sessions.



Sports

A new sports program aimed at "Learn while playing" was introduced with the help of an expert. The programme enables children to learn things like following instructions, waiting for their turn, develop alternate solutions etc. This has further enhanced the confidence level of the children. Apart from this, children with little more capabilities are provided with special coaching to participate in competitive sports. Some of our children have done us proud by winning prizes at National and International level competitions.

Professional Enhancement and Training of the staff

Capacity building of the staff is an important aspect at Khushboo. Management gives due attention to the needs of the training of its team. Various in house and external training have been conducted. It has enhanced their skills, increased their confidence and improved the quality of their work. Some of the trainings conducted were as follows:

- 1. Understanding of Children with ADHD (Attention deficient hyper active disorder).
- 2. "The Upper Extremity Joint Mobilization Techniques and Decoding the MRI and X-rays of the Upper Extremity".
- 3. Community Radio Awareness workshop.
- 4. Workshop on Prevention of Sexual Harassment (POSH).

Resource Development & Communication

Last year, we continued fundraising efforts through conventional ways. We deepened our engagement with our existing donors, both individuals and Corporates. Focus was on keeping them informed about the activities at the centre and sharing with them the progress of our children.

We also amplified our efforts to reach out to netizens. An extensive campaign has been running on our social media pages to create awareness about our past activities, ongoing programs and future initiatives. The communication team started effectively using popular networking platforms such as LinkedIn and Facebook. Details of our upcoming "Residential Facility" was also shared online. As a result, there's a substantial increase in the footfall on our social media pages as well as website. While this has generated a high degree of awareness among the masses, we have also managed to establish few new Corporate connections, but none of them have progressed to the stage of becoming a donor so far.

We thus continue to rely on our old relationships. In fact we lost few donors, in the year gone by. A total of Rs 1.55 Crores was raised last year.

The coming year promises to bring more challenges on fundraising as Covid programs are receiving a lot of attention from the Corporate sector as well as the government. This would lead to splitting, if not total diversion of philanthropy funds.

Support from our existing donors thus becomes even more important.



A word from Staff



Journey with Shashi Bala

I can still recall the day I took my son for his first physiotherapy session at Khushboo. I was impressed by the sensitive care and comprehensive attention shown towards handling specially-abled children. Soon after, I decided to join the field under the guidance of the senior staff at the organization. I did a B. Ed. in Special Education in 2002 and the following year was assigned the post of a special educator at Khushboo. Initially, it was difficult to understand behavioural issues of the children but the senior staff was cooperative and helped me with planning and conducting lessons. In 2012, I became a part of the OPD, where I was designated the task of conducting individual sessions with children along with a therapist, which also helped me learn and understand in more depth the problems faced by specially-abled children.

Special Training with Caretakers

In 2016, Khushboo started a pre-school for specially-abled children (3-6 years) with the prime objectives of cultivating the abilities of children, helping them channel energies in creative pursuits and making them proficient in essential life skills. Here, children attended the school along with their parents or caretakers so they could better comprehend behavioural and learning difficulties. As the program supervisor for this task, I along with other therapists trained parents to work with their children in specially planned exercises. This joint effort instilled parents with a renewed confidence and helped strengthen them emotionally in handling their children.

Need-based interventions

At Khushboo, we offer a holistic social and work environment which is carefully attuned to the specific needs of the children. An Individual Development Plan (IDP) is formulated keeping various parameters in mind including but not limited to the individual challenges faced by the child and their parents' requirements and expectations. The social ambiance of the organization is such that both the educators and parents are equally invested in the growth of the child. We are constantly employing advanced and innovative techniques in the field to better equip the children with essential life skills that would help them deal with day-to-day routine tasks. I, along with other educators, was sent to UK to learn how to employ these techniques in our methodology. The classroom atmosphere is such that it accommodates the requirements of every child and helps them surmount their barriers and unlock their potential. The ultimate objective of these exercises and activities is to expand their learning capabilities and also prepare them for a vocation.

Today, Khushboo has progressed remarkably from its humble beginnings. I have not only taught but also learned and improved during this fruitful and rewarding journey. The portfolio of activities now offered includes yoga, music, dance, sports and other creative pursuits. This has been an endeavour replete with both personal and professional growth. The organization functions on the principle of self and collective development. The unwavering belief in dignified life for specially-abled children is the central tenet of our guiding philosophy. Currently, Khushboo is working on a residential project for specially-abled persons where they will be cared for and provided with assistance for lifelong settlement which further shows their commitment to the cause.

At Khushboo, we believe in not only helping children adapt and learn but also ingraining their minds with a sense of belonging and self-worth.
