

## II Inclusive Education Program for Hearing Impaired Children (Exilo, Mumbai)

Geographical boundary of the program/ Taluk: Bagalkote District, Bagalkote Total number of villages that come under the action plan: 73 Villages

#### 1. Parents/stakeholders Training

Date: 24.12.2021

Place: BIRDS Office, Bagalkote

This training program focused on informing the participants about the effects of physical weakness and measures to prevent it. They were explained about the meaning of hearing impairment. In general terms, hearing impairment means listening disorder. A person who cannot hear voice measuring 60 decibles is called as a person with complete hearing impairment. Usually such people will also have speech defects too.



#### Main reasons for hearing impairment

#### **Prenatal**

Infection in pregnancy, measles, brain fever, genetical disorder, exposure to X-ray, lack of nutrition, consumption of high dosage medicines, same blood group of mother and child, frequent abortions, lack of oxygen during delivery, if the infant doesn't cry soon after birth, difficult delivery, premature delivery, lesser than one-and-a-half kg weight of the infant soon after birth, usage of uncleaned medical equipment, jaundice, consumption of medicine that may cause damage to the hearing nerves.

#### **Postnatal**

Due to frequent ear discharge, brain fever, typhoid, consumption of strong medicines, self-medication without doctors advise, damage to ear nerves. Training was provided on teaching methods and exercise methods for children and management procedures of such children. Sign language to address children about weeks and months, introduction to family members and counting of numbers from 1 to 50 were also taught. Smt. Nadini from the APD Bengaluru (Davanagere) was the resource person. About 35 parents and 15 children took part in the training program. Indian sign language skills were taught to the participants.

#### 2. Parents/ Stakeholders Training:

Date: 11.02.2022

Place: BIRDS Office, Bagalkote

A training workshop was organized for the benefit of the parents of children having hearing impairment. Sri Nagaraj, from the B.D.Tatti Society, Lakshmeshwara, Gadag District participated as the resource person.

- Teaching methods for hearing impaired children
- Oral methodology
- Total Communication, Sign Language

### Teaching methods for hearing impaired children

Various stages of teaching hearing impaired children using drawings and pictures along with natural objects, sign language along with showing drawings and pictures, mathcing a word with the picture and matching words, matching pictures with words, the child should write the word when it is shown a picture.

The parents were taught how to use sign language to communicate with their children as follows:

- 1) Weeks
- 2) Months
- 3) Introduction of family members, example: Father, mother, uncle, aunty, sibling, brother/sister, house, school, etc.
- 4) Different varieties of food. Example: Meals, chapati, sambar, tea, idly, poori, rice
- 5) Things that we use daily: Clohtes, school uniform, shoes, books.

The resource person explained the participants in a very unique manner about all the above aspects so that they understand easily. He also made them demonstrate what they have learnt.

# 3. Sign language training for Primary School teachers

Date: 22.02.2022

Place: BRC Office, Bagalkote

A one-day training program on using of sign language was organized for the benefit of the Primary and High School teachers of selected schools in Bagalkote taluk.



Ears are one of the five sense organs of a human being. Ears have parts, both which are visible and invisible to our eyes. We listen through ears. Ears pass the message to the brain, which control the body. There are 3 important parts of an ear.

- 1. Outer ear
- 2. Middle ear
- 3. Internal ear

External ear: Pinna, ceruminous, ear canal, cylia

**Middle ear:** Ear drum, three bones, Incus, Maleaus, Stapes (smallest bone in human body) **Inner ear:** Oval window, Choclea, Perilymph, Endolymph, hearing nerves, semi-circular canal.

What do you mean by hearing impairment? In general terms, hearing impairment means listening problem. A person who cannot hear a voice measured at 60 decibles will have complete hearing impairment. Usually, such people will also have speech defects.

#### **Important Reasons of hearing impairment**

#### **Prenatal**

Infection during pregnancy, german measles, measles fever, brain fever, genetical disorders, exposure to X-ray during pregnancy, lack of proper nutrition, consumption of strong medicines, same blood group of mother and child, several abortions, lack of oxygen during delivery, if the newborn won't cry, difficult delivery, premature birth, infants

weighing one or one-and-a-half kg at birth, using of unclean medical equipment, brain fever, jaundice, consumption of medicine that may harm ear nerves.

#### **Postnatal**

Frequent ear discharge, brain fever, typhoid, consumption of strong medicine, taking medicine without doctors advice, accidents, due to damage of ear nerves.

Educational programs for hearing impaired children

- > Audiology test
- Compulsory usage of quality earing aid
- Provide communication/speech training and encourage to read loudly
- Make the child sit on the right side, in first row, in front of the teacher
- > Teach the child without external disturbance in classroom
- > Teachers should speak clearly and use accurate pronounciation while teaching
- Use proper teaching aids of the subject
- > Teach new words in the lesson
- > Evaluate regularly
- > Understand whether their teaching is effective on the child, if not, provide remedial teaching

## 4. Classmates training:

Date: 10.03.2022

Place: Model Senior Primary School, Kadampura R.C

A sign language and communication training program was conducted for the 5th and 6th standard students having hearing impairment, of the Model Higher Primary School, in Kadampura R.C. Village. They were taught the following topics:

What is hearing impairment? Generally hearing impairment means a person who finds it difficult in listening to the words measuring 60 deichles frequency. Usually people having hearing impairment will also have speech defects.

#### Main reasons for hearing impairment

#### **Prenatal**

Infection during prengancy, german measles, measles fever, brain fever, genetical, exposure to X-rays, lack of nutrition, consumption of strong medicines, same blood group of both mother and child, many abortions, lack of oxygen at birth, if infant won't cry at birth time, difficult delivery, premature delivery, lesser than one or one-and-a-half kilo weight of

infant at birth, usage of unclean medical equipment, brain fever, jaundice, consumption of medicine that may damage ear nerves.

#### **Postnatal**

Frequent ear discharge, brain fever, typhoid, consumption of strong medicines, self-medication without doctors advice, accidents, damage to ear nerves.



# IV. NABARD sponsored Mahalakshmi Animal Husbandry Farmer Producers' Company Ltd., Hungund

NABARD granted Women Farmer Prodcuers' Companies (FPOs) to BIRDS. Accordingly, a Chief Executive Officer was selected for Hungund Taluk, who visited several Self Help Groups (SHGs) in Hungund Taluk and held a meeting, and informed them about the FPOs and its activities.

In the beginning, SHGs located at Ramavadagi, Hungund, Rakkasagi, Timmapura, Dhannura, Hagedaala villages in Hungund Taluk were visited and the members were explained about the rules and regulations of the functioning of FPOs.



Out of these villgaes, 150 shareholders were selected from 5 villages Ramavadagi, Rakkasagi, Hungund, Timmapura and Dhannur. Training programs were conducted 2-3 times to educate them of the various activities of NABARD and FPO. As a result of this, 46 members from Rakkasagi Village, 36 from Dhannura Village, 38 from Ramavadagi Village, 36 from Timmapura Village gave their consent to become members and provided the required documents.



Meetings were held in 5 villages and with the consent of all the members it was named as "Mahalakshmi Animal Husbandry Farmer Producers' Company." With the consent of all the members, 11 office-bearers were selected as follows:

From Ramavadagi Village: 3) Smt. Yallamma Maadara

Application was submitted to register the "Mahalakshmi Animal Husbandry Farmer Producers' Company" under the Copmanies Act and the names of all the 11 office-bearers were included in the application software and DSE and EKYC process was completed. Certification of all the 11 office-bearers was obtained from the Agriculture Department and Animal Husbandry Department, as per the Companies Act.

Documents like Aadhar Card, Bank passbook, Voting ID cards, PAN cards, etc., were collected from all the 11 office-bearers to get the Company registered. All the documents were taken to the Belagavi Division and the officials of the VYSHA & Company were met and the documents were submitted to them. The VYSHA & Company people added all the details in the software. On 04/09/2021, the Company was registered under the name "Mahalakshmi Animal Husbandry Farmer Producers' Company.

The "Mahalakshmi Animal Husbandry Farmer Producers' Company Limited," Hungund conducted a meeting of all the 11 office-bearers and members on 14/09/2021 and selected the President, Vice-President, Secretary, Treasurer and Directors.

Smt. Mahadevi Kattimani was selected as the President. Smt. Durgamma (Vice-President), Smt. Yallamma Kademani (Secretary), Smt. Mallamma Hanumagowdra (Treasurer), Smt. Sharanamma Rati, Smt. Manjula Kengal, Smt. Riyana Shirura, Smt. Shilpa Kambale, Smt. Durgavva Talawara, Smt. Hullavva Vaddara, Smt. Nelamma Patil, were selected as the Directors unanimously.



A joint bank account was opened at the Karnataka Vikasa Grameena Bank, in Hungund, in the name of the 'Mahalakshmi Animal Husbandry Farmer Producers' Company Ltd.' The Company office is opened at Hungund. The membership share amount was deposited in the bank account.



Training was provided to the SHG members at the village-level, under the NABARD Atma Nirbhar Bharat program. About 30 beneficiaries from Timmapura Village, 20 in Hungund Village, 22 in Ramavadagi Village, 25 in Rakkasagi Village and 30 in Dhannura Villages were provided training.

Applications of all the 150 share holders was collected within December 31 and a total sum of Rs. 2,27,882/- at the rate of Rs.1,000/- and Rs. 500/- from each member was collected and was deposited in the bank account. Share certificates will be issued to all the share holders.

A meeting of Bank Manager's of Hungund Taluk was held on 04/12/2021 at the Hungund Town Municipal Council office. Lead Bank Manager and NABARD DDM Smt. Yamuna Pai were present. The Company CEO also participated in order to discuss and share information about the FPOs.





The Bagalkot District-level workshop and 'Bellada Habba' (Jaggery Festival) was organized on 23/12/2021, on the occaison of the Farmers Day. The program was organized by the Agriculture Department, Bagalkot and ATMA program, Bagalkot. Members of the Sri Mata Women SHG and FPO share holders took part in the Prime Minister Micro Food Processing Exhibition Mela and exhibited various products prepared using jaggery and ghee.





On 01/01/2022, the Hon'ble Prime Minister held a farmers welfare virtual meeting, in which 15 share holders took part and obtained information relating to the FPOs.



On 10/11/2021, ten members from our FPO visited the Food Processing Unit formed by the Green Future Company in Bagalkot, and collected information which can be adopted in our business plan.

Forty SHGs have been formed as on September end, including Gorajanaala (03), Tallikeri (04), Chillapura (04), Muradi (02), Kelura (07), Dammura (02), Vadageri (07), Ilala (04), Gudura SC (07).





▶ **Net Program (DPR):** Action plans for 10 micro watershed net programs have been prepared under the WDDP. Signatures of the GP President, Panchayat Development Officer, Assistant Agriculture Director have been obtained to the action plans and submitted it to the Hungund Office. Also works of digging pits have been undertaken under the MGNREGA program in the farmers fields. On 09.06.2021, the Deputy Agriculture Director made a spot visit to the NREGA work place in Kelura Village. On 10/06/2021 the District In-charge Secretary Sri Shivayogi Kalasada inspected the NREGA works going on in the Kelura Village.





- ➤ Under the WDDP program 40 User groups have been formed, including Gorajanaala (02, Chillapura (02), Tallikeri (05), Kelura (06), Murad (05), Ilaala (05), Dammura (05), Gudura (SC) (05), Vadageri (05).
- ➤ The Belagavi Revenue Division level Watershed Development Programs Progress review meeting was held on 28/06/2021, under the leadership of the Watershed Development Department Commissioner. The meeting was held at the Office of the District Joint Agriculture Director, Bagalkot. Preparation of the Net Program was discussed in the meeting. The members were asked to conduct a survey of 300 farmers

and find out what saplings do the farmers need along with the statistical data. Accordingly, a farmers meeting was held under the leadership of Horticulture Department Assistant Director Smt. Hema, on 30/06/2021 at Chillapura Village.









- ➤ A Detailed Project Report is also prepared accordingly and submitted it to the officials concerned. Executive Committee (EC) has been formed at Gurudra S.C, Muradi, Vadageri and Kelura Gram Panchayats.
- > **S-1 training for Women Self Help Group members:** Training was provided to a total number of 600 women members. Information about the background of the program, its aims, purpose, benefits for farmers, advantages, were explained to the participants.

The participants were explained about the importance of savings in order to help other SHGs, to show there is strength in unity. They were told that saving a small amount of money from their total income and depositing it in the group bank account would lead to accrual of a big amount. This would help them to get loans at lesser interest rates. Using that they can undertake livelihood income generating activities. For this SHGs are required, they were told.

The members should be between the age group of 18 to 60 years. Landless, labourers, SC/STs and people belonging to other weaker sections should get the membership. All of them should have same social, educational status, should belong to the same street, locality and should have mutual trust and belief and respect between each

other. They can name it as per the demand of the group members, and should open a bank account in the same name. Office-bearers should be selected and meetings should be held regularly. All the required documents should be maintained, they were informed. The program should begin with an invocation and all the members should participate and decisions should be taken with the consent of all.





**U-1 Training for User Groups:** Special training programs will be conducted based on the farmers activities who are in the users groups. Like the SHGs, the User Groups should also make savings and make arrangements to disburse loans to the members out of the savings amount at lesser interest rates. Bank account should be opened and guidelines should also be framed concerning subscribing for treatment of land. The members of the User Groups will play a vital role in preparing plans at the farmers-level and include the same in the action plans. Representatives from User Groups shall be selected and they shall be made members of the Watershed Committee.

Method of conducting meeting and responsibilities of the members: All the members should sit in a circle. Let the meeting commence with a prayer. One among the members should be selected as the leader to conduct the meeting. Welcome speech should be prepared and attendance should be taken. Read the decisions of the earlier meeting, collect details of the topics that have to be discussed from all the members. Money matters should be completed. Discussion should be made about all the points one after the other and a decision should be taken and documents should be maintained. Ensure that the Users Group functions properly, maintaining books of accounts. Should attend training programs conducted for the representatives. Help the members in taking proper decision. Should look after financial matters of the group and get auditing done regularly. Ensure adoption of the Watershed Committee action plan in the group. Intervene if there are any misunderstandings or quarrels in the group. Should visit banks and coordinate in getting loans for the group and ensure proper repayment of the loans availed.

While preparing action plan, instructions should be given to the farmers of their respective areas to participate. Monitor implementation of the action plan, ensure that the benefits of

the programs reach micro, small farmers, SC/STs. In case of any mistakes in implementation, immediately it should be brought to the notice of the Users Group and Watershed Committee members and ensure proper steps are taken to set it right. The participants were also informed about the purpose of MGNREGA and jobs provided to the labourers under the program. Works like forming pits and agricultural ponds in farmers fields are undertaken under this program.

Signatures of the Panchayat Development Officer and Gram Panchayat President, Agriculture Officers and Assistant Agriculture Director have been taken and it has been submitted to the Afzalpura Office.

Training to Women Self Help Group members: Training was provided to 600 women SHG members. They were educated about the background, purpose, aims of the program and its advantages to the farmers and the members. They were also informed about the importance of savings in order to help other SHGs mutually, to show that there is strength in unity, encourage saving a small amount of money from their income every week/ month in the group bank account. It accrues to a big amount which can be disbursed as loans to the members at lesser interest rates, which will in turn help them to undertake livelihood income generating activities and help to increae their income.

The members should be between 18 to 60 age group. Landless, labourers, SC/STs and people belonging to other weaker sections should get the membership. They should belong to the same social and educational status and same street, locality and should have trust, belief and respect for each other. It shall be named based on their common consent and a bank account should be opened in the same name and representatives should be selected. Meetings should be held regularly and all the documents of the group should be maintained. The meeting should begin with a prayer and all the members should participate and decisions should be taken with the consent of all.

**U-1 training to User Groups:** Based on the type of farmer activities in the group training programs will be organized for the group. Like Self Help Groups, User Groups should also frame guidelines to save money and utilize the savings amount to disburse loans among the members. Open bank account and arrange loan facilities and collect subscription for treatment of fields. The User Groups will play a vital role in prepearing plans at the farmers-level and adopt the same while preparing the action plan. Representatives from the User Groups should be selected and they should be made members of the Watershed Committee.



# Procedure of conducting the meetings and responsibilities of the members:

All the members should sit in a circle. Let the meeting commence with a prayer. One among the members should be selected as the leader to conduct the meeting. # **IX. Literacy Program**

The Literacy Program, which was stopped during the COVID-19 Pandemic time has been recommenced through the volunteers.

On 27/01/2022, tests were conducted by 140 volunteers comprising 1400 illiterates of Stree Shakti groups in Dhanura, Chittaragi, Gorabala, Nandawadagi and Kandagalla Gram Panchayats. Overall 90% results were obtained. Out of the 1400 beneficiaries, 1089 have now become literates and 319 are failed candidates. Likewise, 1800 illiterates in slum areas were identified and 180 volunteers made efforts to make them literates and obtained 90% results in the test.

As per the D.M. Nanjudappa Report, literacy program was conducted covering 2000 illiterates in the backward taluk gram panachayat limits. As a result of this 1525 people have become literates now and 475 have failed. The program has registered 90% result under this program in Aihole, Kelura and Chikanaala Gram Panchayats. 38 volunteers made efforts to make 382 iliterates read and write under the District Panchayat Link Program. Beneficiaries include people from Amaravathi Gram Panchayat and Timmapura and Ramawadagi. This efforts have yileded 95% results.

Overall the volunteers made efforts to overcome illiteracy even during the COVID-19 Pandemic period. We extend our gratitude to the volunteers for their efforts. We also would like to thank the Loka Shikshana Department District Adult Education Officer and Staff, Taluk Coordinator and Executive Officer, Gram Panchayat staff and Higher Secondary School staff.
