

1. INTRODUCTION:

SOCIETY FOR PEOPLE'S INTEGRATED DEVELOPMENT (SPID) is incepted in the year **2004** by likeminded, dedicated Social Workers, Educationists and Professionals with an aim to bring socio-economic, education and health developments among the rural and urban populace particularly aiming at backward classes, reserved community, minority, poor of the poorest with due focus on women and children.

2. BACKGROUND OF THE ORGANIZATION:

The organization is registered under Karnataka State Societies Registration Act 1960 with the Governing Body consisting of 07 members with due representation of female. The organization Registered Office is at Haruvanahalli Village near Kadur Town in Kadur Taluk of Chickamagaluru District and its Administrative Office is functioning in a rented building at the above address as is mentioned in the top sheet of this annual report. The organization Chief Functionary is Mr. K. Prakasha is a Post Graduate in Social Work and Under Graduate in Education with adequate experience in social work which includes various sectors in urban and rural development programs. The organization does have required automation, training materials, furniture and fixtures with required number of two wheelers to suffice the needs of implementing the rural and urban development programs. The required field and administrative personnel are also available with the organization.

3. GEOGRAPHICAL BACKGROUND OF THE ORGANIZATION:

The organizational working area is situated in Chickamagaluru district comprising 008 Taluks and 226 Grama Panhchayaths in Karnataka State Details appended below: The land scape falls under the region of hilly, semi-hilly, plain and coastal regions of Karnataka State. These land spread in the regions of 12-14 degree Latitude – N and in the longitude of 72-74 degree – E. The cultivable soil is of red moorum, sand mixed red soil and black cotton soil. To some extent coconut, areca nut and coffee plantations are also does exists. The main food crops grown are ragi, jower, maize and paddy. The main commercial crops grown are edible oil seeds, pulses, cereals, spices, vegetables, flowers and fruits. The average percentage of literacy among the target group populace of the organization is around 70% and 65% from male and female respectively. The target group populace is mainly depending on the agricultural and daily wages labour which is of seasonal as such they are always under migration regularly which in turn plays the results of school dropout children and child labour practices. The average per capita income is around RS. 300/day. The health condition among the target group populace is below average level of the State and National level. 6. ACTIVITIES IMPLEMENTED DURING THE YEAR 2021-2022:

(A) ORGANISATION DEVELOPMENT:

(I) INFRASTRUCTURE DEVELOPMENT:

The organization administrative office is functioning in a rented building in Chickamagaluru district head quarters town of Chickmagalur District in Karnataka State which also holds District Disabled Rehabilitation Center of Chickmagalur District & Senior Citizen Day Care Centre. This building does have the full furniture and fixtures with all amenities like bath, toilets, electricity and water supply. The administrative office does have the full automation with training materials, loud speakers, camera, projector, screen, audio-video visuals. Adequate two wheelers are also available with the organization for timely conveyance purposes.

(III) RESOURCE STRENGTH:

The Organization is well equipped with internal resource services through the Office Bearers and well qualified, experienced staff. The internal resource persons are post graduate in the discipline of Social work, Arts and Science, Medical and Paramedical. The Organization is well equipped with external resource services through the net-working NGOs, Experts and Consultants and also from the resource persons from the Government Departments and Panchayath Raj Institutions.

(IV) <u>NET-WORK NGOs:</u>

The Organization is maintaining exemplary nexus with net-working NGOs right from taluk level to state level in its working area. The net-working is in the form of planning, implementation, monitoring and evaluation of the project activities. The net-work NGOs are also lending their support for resource services. The Organization is also maintaining ideal nexus building with Government Line Departments and Panchayath Raj Institutions.

(B)COMMUNITY DEVELOPMENT:

(i) DISTRICT DISABLED REHABILITATION CENTER- CHICKAMAGALURU

This program has been supported by Department for Empowerment of Differently Able and Senior Citizen, Government of Karnataka, Bangalore. To implement this program a District level monitoring team has been set up by chairing the DC, with the committee members includes, CEO (Vice President), DHO, DDPI, DD (WCD) and sitting NGO Member Secretary of this organization and coordinated by DDWO. The main activity of this committee is to cover local awareness rehabilitation and health check up camps at site for the disabled. This activity covers in all eight taluks of the Chickmagalur District. The details of activities under taken by this committee during reporting year are as follows:

• HEALTH AWARENESS CAMPS: Health Awareness Camps amounting to 050 Camps in which 1010 beneficiaries participated. The Resource Persons are Mr. Kiran Kumar, Nodal Officer, DDRC, Chickamagalur & Medical Officers and paramedical staff of the respective PHC Hospitals were took participation as Service providers. In these camps Disabled persons have been identified for free supply of aids and appliances. These awareness camps are being conducted on every Tuesday and first and second

week Fridays of every month. In the camps the medical experts like, Psychiatrist, Audiologist, SLP, ENT Specialist, Orthopedic, Opthalmist including Clinical Psychologist are taking participation and identifying the patient problems and referring the case to the concerned Medical Institutions.

- HEALTH CHECKS-UP CAMPS: Health Check-up camps amounting to 56 Camps in which 1393 beneficiaries participated. Out of which 140 identified for treatment in which 123 persons referred. The Resource Persons are Nodal Officer, DDRC, Medical Officers & Paramedical staff of Taluk Hospitals. In these Health Check-up camps the Medical Specialists from the Taluk hospital together with their paramedical staff are taking participation to diagnose and at site treatment is given. Referral cases are also exercised. To Provide UDID CARD 793 Members.
- The identification card for The National Trust Under Niramaya Health Scheme were identified 350 for which beneficiaries have been issued with the cards 200. The Niramaya Scheme covers the patients (Disabled Persons) like Mentally Retarded, Multiple Disability, and Cerebral Palsy & Autism.
- Trained up the disabled persons to utilize the local available resources to the optimum level.
- To disseminate the information to the disabled persons about the optimum utilization of the 5% funds meant for their development from the Government.



(ii) SENIOR CITIZEN'S DAY CARE CENTER – CHICKAMAGALURU:

- The above center is housed in the Organization Administrative Office at Chickamgaluru Town and 315 Senior Citizens have been registered and 050-060 Senior citizens are attending this Day Care Center every day. Here they are availing the facilities like Indoor Games, Library, Reading Room, Mid-day refreshments, Television, Health Check up like Blood Pressure and Diabetes, Yoga, Meditation including time bound Excursions.
- The Center serves the Senior Citizens for the following:
 - ➤ Information about their rights and duties including facilities available in various Union/ State Government Schemes.
 - Access to the medical care.
 - Cultural Programs.
 - Redressal of their grievances through Senior Citizen Help line 1090.
 - ➤ 40 Doctors visit has been exercised in which 1660 senior citizen availed the benefit of health checkup.
 - ➤ 06 Panchakshari Meditation conducted in which total of 315 Senior Citizens took participation.
 - ➤ 02 Meditation has been conducted by the Theosophical Society in which total of 100 Senior Citizens took participation.
 - ▶ 05 Health Checkup Camps have been conducted by the Society in which 250 Senior Citizens availed the benefit.
 - ➤ 400 grievances cases has been solved through Senior Citizen Help Line 1090.
 - ➤ 03 programs has been organized by the District Legal Services Authority, Chickamagaluru in which legal awareness has been given to 150 Senior Citizens.
 - ➤ 14 Yoga Camps has been conducted in which 700 Senior Citizen took participation.
 - ➤ 01 Health Checkup has been conducted for checking the cancer, Heart, Diabetes & Paralysis by the District Hospital Medical and paramedical staff team in which 050 senior citizens took participation and availed the benefit.
 - ➤ The national festivals like Independence and Republic Day has been celebrated in the center in which 130 Senior Citizens took participation and sweets have been distributed to them.

1. ABOUT ORGANIZATION:

<u>Management:</u> The organization is registered under Karnataka State Societies Registration Act 1960 with the Governing Body consisting of 07 members with due representation of female. The organization <u>registered office</u> is at Haruvanahalli Village near Kadur Town in Kadur Taluk of Chickmagalur District and its <u>Administrative Office</u> is functioning in a rented building at the above address. The Chief Functionary is <u>Mr. K. Prakasha</u> who is a Post Graduate in Social Work and Under Graduate in Education with adequate experience in social work which includes various sectors in urban and rural development programs.

<u>Staff:</u> The Organization does have the Administrative Staff 006 Field Staff 011, Paramedical Staff 005, Medical Professional (Part Time) 001 Volunteers 057 (Part Time). In all the above categories due representation has been given to female and reserved community.

<u>Infrastructure:</u> The organization administrative office building does have the full furniture and fixtures, storages with all amenities like bath, toilets, electricity and water supply. The administrative office does have the full automation including internet facility, telephone with training materials, loud speakers, camera, projector, screen, audio-video visuals. Television, Two Wheelers.

<u>Area of Operation:</u> The area of operation of the organization is in all the 226 Grama Panchayaths in 008 Taluks of Chickmagalur District. Apart from which the organization has also worked in Chickamagalur Districts in Karnataka State in the past.

Area of Expertise: Community Organization, SHG Development, Awareness/ Income Generation/ Vocational and Skill Development Trainings, Integrated Women and Child Development, Environment, Community Health, Disabled and Senior Citizen Welfare and Rehabilitation, Awareness on Adolescent Girls Care, Rural Water Supply and Rural and Urban Sanitation, Youth Development, IEC/HRD Activities, Slum Development, Cultural Activities, Sports, Group Activities, Legal Awareness and Literacy.

<u>Geographical Condition:</u> The Organizational working area spreads over hilly, semi-hilly, plain and coastal regions of Karnataka State. These land spread in 12-14 degree Latitude – N and in the longitude 72-74 degree – E.

The cultivable land soil is of red moorum, sand mixed red soil and black cotton soil. coconut, areca nut and coffee plantations farms are exists. The main food crops are ragi, jower, maize and paddy. The commercial crops are edible oil seeds, pulses, cereals, spices, vegetables, flowers and fruits. The average percentage of literacy among the target group is 65% Health

condition of the target group populace is below average level. The average per capita income is RS 300/day. Migration is common in search of seasonal employment.

2. ACTIVITIES ACCOMPLISHED DURING REPORTING YEAR 2020-2021:

I. District Disabled Rehabilitation Center (DDRC) at Chickamagaluru: This program is supported by Department for Empowerment of Differently Able and Senior Citizen, Government of Karnataka, Bangalore. To implement this program, District level monitoring team is functioning. The main activity of this committee is to cover local awareness camps, health check up camps, rehabilitation for the disabled and this activity exercised in all eight taluks of the Chickamagaluru District. The following are the activities accomplished during reporting year.

<u>Health Awareness:</u> 011 Camps: 471 beneficiaries: 220 Disabled Persons identified to provide Aids & Appliances.

<u>Health Check-up:</u> 124 Camps: 710 beneficiaries: 220 Persons identified for treatment: 024 Persons underwent surgery:

Education Scholarship: 023 persons identified out of which 023 persons were granted.

The Disabled identification card: 077 identified: 069 identification Cards issued.

Niramaya Health Scheme: 087 persons identified: 032 persons issued with the cards.

<u>General Awareness:</u> Disseminated the information to the disabled persons about the optimum utilization of the 5% funds meant for their development from the Government.

II. Senior Citizen Day Care Center (SCDCC) at Chickamagaluru: This program has been approved by Department for Empowerment of Differently Able and Senior Citizen, Government of Karnataka, Chickamagaluru District. In this program the following activities are complied with during the reporting period.

<u>Senior Citizen enrolled:</u> 300 Persons: 050-060 Senior Citizens are provided with Light Refreshments in the noon, entertainment, physical exercises, reading materials, in door games, health check-up on every Saturday, Library facilities & Meditation.

<u>Senior Citizen Health Check-up:</u> 048 Doctors visits along with Staff Nurses of Day Care Center being attending this health check-up camp. Total cases amounts to 1832.

<u>Senior Citizen Eye Tests & Care:</u> 001 program with District Hospital Medical and Paramedical staff of Day care Center at Chickmagaluru in which 050 Senior Citizens were benefitted.

<u>Meditation and Yoga Camp to Senior Citizen:</u> 04 Meditation and 14 Yoga Camps were organize in which 800 Senior Citizen benefitted.

<u>Observance of Important Days:</u> The Inter-national/ National days like Senior Citizen Day, Republic Day, Independence Day, Cancer prevention, HIV/AIDS prevention, Disabled Day etc are being conducted in the center and the event is memorized.

<u>Legal Awareness Program:</u> Legal Awareness Program has been conducted in the Center in which The District Legal Services Authority Office-bearers and the Judicial Authorities has been participated. 050 Senior citizens were benefitted out of this program.

<u>Grievances Redressal Program:</u> 400 Cases of grievances redressed of Senior Citizen has been exercised.

III. Senior Citizen Help Line 1090: This program has been supported by Department for Empowerment of Differently Able and Senior Citizen, Government of Karnataka, Bangalore. A District level monitoring team has been set up to monitor this program This Help Line office is housed in Office of the Superintendent of Police, Chickamagaluru. This Help Line hears and help the call of senior citizen in distress through counselling, guidance, support and rehabilitation process in all eight taluks of the Chickmagalur District. Toll free telephone number 1090 is provided. Total Calls about Help Line Information received: 3336, Persons meet: 530 Complaints against family members: 036, Against Private & Government Establishments: 027, Against individuals: 028, Admission in old age homes: 265, Medical Assistance: 283, Old age Pension: 389 and about Complaints resolved by Compromise: 075, By Police: 011, By Tribunals: 003, By Rehabilitation: 132, By House Visits: 167, Pending: 004.

(IV) Observance of Important National and International Days Program: All the important national and international days programs have been observed in the organization office and the concept of the day have been delivered to the participants apart from which light refreshments have been arranged to the participants.
