# Diagnostic & Research Centre (DRC)

# Family Support Services

The Unit is the first point of contact at SSK for all families in need of services. Family Support Services are an integral part of the services, as our philosophy has always been Family Centred and parents are considered an integral part of the Rehabilitation Process of the child. This philosophy is put into practice through our team of Medico Social Workers whose work spans across all services and units of SSK. Initial screening, guidance and direction; Counselling with parents; Pre Case Conference Meetings; Facilitation of surgeries by coordinating funding and hospitalization processes; Facilitation for parents availing UDID and Niramaya Health Insurance scheme and integration of the child into mainstream society at various levels, like schools, colleges or employment were some of the activities undertaken in the academic year.

# Highlights:

#### Support to Parents:

SSK has provided guidance to 1360 new parents and 1200 existing children at the main centre, while also facilitating curricula accommodations and exemptions for exam taking for children with disabilities in collaboration with NIOS, CBSE Board, and parents.

#### Coordination with service departments of SSK:

Collaborated with Learners Centre and Centre for Special Education to address concerns of adolescents, working closely with psychiatrists and the team to develop strategies and preventive measures.

# Coordination with Government and external agencies:

- SSK, representing the following disability services - CP (Cerebral Palsy), IDD (Intellectual and Developmental Disabilities), and SLD (Specific Learning Disabilities), is an active participant in the Government committee for Post Identification in Government Jobs.
- The unit established a network with the district Mental Health Team at K R Puram Hospital for certifications; the team of Medico Social Workers aided by interns facilitated Niramaya renewals in rural areas.
- Pursued correct transfer documents for CwSN (Children with Special Needs) who joined SSK.
- Representation to Senior Divisional Commercial Manager, Railways Department, Bangalore, regarding the need to consider UDID for availing the Divyangjan Railway concession Photo ID card instead of the additional Govt. Medical Certificate again along with the UDID for the same. A positive response is expected.
- Contributions to TITAN Company's policy on supporting staff parents with disabilities.

#### Management Information System (MIS) support:

SSK has embraced technology by adopting Zoho Client Relationship Management (CRM), streamlining the operations and improving efficiency. Overall, SSK has made significant strides in various areas, benefitting individuals with disabilities and their families.

# **Allied Health Services**

At the Neuro-Rehabilitation Therapy Unit, children across different disabilities were given various therapy services such as physiotherapy, occupational therapy, sensory integration therapy and speech therapy. Our rehabilitation professionals adapted technologies for individual and group motor/ movement sessions which help them in sustaining and emphasizing functional skills to support the continuity of therapy at home.

Therapy department is providing continuous teletherapy services (PT, OT,ST) to parents of children at various outreach centers which



involves the senior professionals from the DRC giving therapy intervention, guidance and counseling with respect to each child's therapy needs.

#### Highlights:

- Dr. Rudra Pasad, Orthopedic Surgeon, Department of Pediatric Ortho, Indira Gandhi Institute of Child Health (IGICH) and his team started their first clinic at the diagnostic and research center of SSK. 13 children received Orthopedic services.
- SSK resumed therapy and special education services once a week at R L Jalappa Hospital, Community Medicine Department, Kolar from 8th March 2023.
- The department provided training to 57 interns and trainees from various colleges/ institutions across Bangalore.

- Four children were provided with therapy aids (wheelchair, corner chair with lapboard and potty chair) at the main centre.
- Ms. Subhashini (Therapy Coordinator) and Ms. Sujatha (Program Manager – Speech therapy) completed 6 months certification in **Qigong Sensory Training (QST)**. QST is a distinctive Chinese touch based therapy approach used specifically for children with Autism Spectrum Disorders which reduces parenting stress and sensory processing self regulation.
- Speech language pathologist Ms. K Mercy, attended a 3 days RCI-CRE certified conference (March 2023) on Pediatric dysphagia and hands-on training on Instrumental analysis on Pediatric dysphagia.

# <u>Child Study</u> <u>Centre</u>

The Psycho-Educational Department works towards the philosophy of Inclusive Education in mainstream schools by supporting school managements and teachers to retain children with learning difficulties in schools. This department is acknowledged by IGCSE, IB, State Board, CBSE and ICSE Board to give recommendations for accommodations to students with learning needs.

#### **Highlights:**

- Assessment services was provided to 800 young children that included at risk for learning disability; Progressive Developmental Delay; Learning Disability; Learning Disability; associated with Social and Emotional Behaviour Deficits; Autism with Learning Deficits and students with learning issues associated with partial sensory impairments (hearing and vision).
- Trial Remediation of 10 sessions each for students diagnosed at Psycho Educational Unit as students 'AT RISK' for Learning Disability was conducted by the trainees of Post Graduate Diploma in Learning Disability under the guidance of the unit staff.
- Parent counselling on a need basis. These sessions have greatly supported the parents to understand the assessment recommendations.
- Teacher Training Programme The unit staff were faculty for the two week workshop for teachers of Stracey Memorial School on Overview of Learning Disability; three day workshop for Delhi Public School, Electronic City on Overview of Learning Disability and Management strategies; six month course for Delhi Public School (North) Overview, Assessment and Inclusive education strategies

for students with Learning Disabilities.

Support provided to Knowledge Centre and Human Resource Training Unit by way of delivering lectures to school teachers, Postgraduate and certificate course; and diploma trainees; correction of examination papers and conducting VIVA.

# Psychology Unit

The **objective** of the department is to carry out psychological assessments of children and young adults (7 to 18 years) to determine their strengths, potential & concerns, to aid in further planning, keeping in mind the reason for referral and assessment findings. Assessments cover IQ, emotional & behavioural aspects.

At the **main centre/DRC**, some of the outcome of assessments of children with different developmental disabilities & Neuromuscular disorders has resulted in - Dealing with emotional issues related to Post-covid situations; Enrollment of new children to different units of SSK; Aiding of transition within different units of SSK for children referred for review assessments; Aiding in UDID process for those seeking disability ID; Referrals to special schools, inclusive setups; Seeking professional advice of other professionals; Providing accommodations/ concessions under various Boards – State, ICSE, CBSE, IGCSE & NIOS.

At IGICH Sub-centre, referrals of children have been those with medical conditions, requiring screening & assessments for cognitive, learning, emotional & behavioural aspects. Children with different syndromes, health concerns, low vision, those requiring cochlear implantation, malformation in the brain, developmental delays, those requiring enzyme replacement therapy etc. were provided services.

#### Highlights:

- The unit provided services for 490 beneficiaries at the main campus and at the subcentre at Indira Gandhi Institute of Child Health.
- One day screening camp was held in March 2023 for 29 children of SSK for the UDID

process. This was done in collaboration with Psychologists from Little Blue Jays Child Care Development Centre.

# **Educational Services**

### "The secret in education lies in respecting the student"- Ralph Waldo Emerson

Educational services at SSK aimed at Review and Revise curriculum programs for the children attending regular schooling post covid. Special Educators focused on a myriad of individual as



well as group activities within and outside the classroom to help rebuild the lag if any in children's cognitive, social emotional as well as physical well being. A year filled with deep involvement of professionals with sustained parent interactions at Joyful Learning Centre and at SubCentre, Indira Gandhi Institute of Child Health (Early Child Education); Centre for Special Education (Formal and Non Formal schooling); Rainbow Centre for Autism Spectrum Disorders; Learners' Centre (Bridge Groups; Secondary and Senior Secondary through National Open School). The Fitness Training Program was reintroduced to channelise children's physical energies as well as provide for opportunities of success through games.

Our joyful children of **Joyful Learning Centre** progressed through activity-based learning focussing on visual and perceptual training; readiness skills; communication and activities of daily living. IEP meetings held twice a year with parents supported priority goals achievement. Home-visits helped in strengthening home based learning. Colour, smiles and fun marked the celebration of festivals; a picnic to Bal Bhavan



with mothers and teachers was a happy time; and the tiny tots not only showcased their talents but also won hearts and prizes at Kalangana.

Our students of the **Centre for Special Education** progressed through project work and individual sessions. The happiness to be back to school itself contributed to their overall progress. Management of behavioural difficulties postcovid was addressed by the team through guidance and counseling for the child and parent



by Consultant Psychiatrist Dr. Shobha Ramesh and the social workers. The Pre-Vocational Training room with a coffee vending machine; washing machine; ironing and xerox was set up to focus on pre-skill training towards identifying skills for future vocational training.



**Learners' Centre** - The academic session commenced with students back to school and attending the academic program, sports and games and other co curricular activities. 22 students in grade 10 and 10 students in grade 11 & 12 were prepared to take the Secondary and Senior Secondary Examinations in March-April 2023. In the lower grades the focus was on improving reading, writing and comprehension skills to prepare them to take up the exams in the coming years.

#### **Rainbow Centre for Autism Spectrum Disorders**

- The children were excited to be back on the premises and eagerly got back into the schedules and timetables set out for them. An informal meeting with Director, Mrs Rukmini Krishnaswamy helped build a connection between parents and staff. The children took part in Kalangana and won prizes in singing, art and fancy dress. They were also excited to be present for the book launch of "Grit-The Vishwas Story" and enjoyed being photographed with Vishwas KS and V R Ferose at SSK. Events at Rainbow Centre culminated with celebrating a very inclusive and interactional World Autism Awareness Day at different Units of SSK (Introduction about ASD and Q&A, Demonstration of how we Communicate, We time – Joint art activity and Dance fun).

#### Highlights:

- International Day, an event based on a project method showcased the culture, language, history and cuisine of six countries. This was an inclusive event with mainstream schools which included a parade, cultural programmes, exhibition and food court.
- Students participation in co curricular events included Quizabled, an interschool quiz competition organized by Seva-in -Action; Kalangana by Information Resource Centre; Sports Day by MBA ESG institution; Sports & Cultural participation on International Day for Persons with Disabilities organised by Dept. of Disability Welfare and Senior Citizens.
- Open Days at SSK at the end of the academic year give our parents an opportunity to be part of the progress of their children; it's a time to be witnessing the many facets of development of children and an affirmation of the planning of goals for each child through their individual educational programmes. The month of March marked Open Days at the Centre for Special Education. Display of children's work; their presentations through public speaking, dance & music; interactions of parents and staff marked the series of open days.
- In students completed the basic course in Computer Skills and Personal Development Certificate Training by IBM Volunteers over 12 sessions on Saturdays.
- Students who completed NIOS Secondary in June 2022 received CIPLA Merit awards on 2nd September 2022. These awards are given to the top five ranked students.
- The National Institute of Open Schooling (NIOS) Study Centre conducted Personal Contact Program (PCP) online classes for two batches of students and Tutor Marked Assignments (TMA) correction was done by the subject teachers at SSK.
- NIOS practical and theory examinations were conducted twice i.e in Qtr III (October-November 2022) (58 secondary and 25 senior secondary students appeared for this

examination) and in Qtr IV (March-April-May 2023) (153 secondary students wrote the examination). 22 students studying in grade 10 at SSK wrote the Secondary examination at our centre

A day's picnic/educational trip was organized to Bal Bhavan in Cubbon Park; the railway station; to Wonderla and Rangoli Garden; an overnight stay at Camp Shrishti.

# A Story of Love and Commitment



Gehna is Mohith's mother. 18 year old Mohith, is diagnosed with Cerebral Palsy. He joined SSK at age six in the Early Child Education programme and

later at Centre for Special Education. Life has been a challenge for Gehna and Mohith as the family faced an uphill task of the rehabilitation process. Mohith was born with the umbilical cord wrapped around his neck which cut off the oxygen supply to the brain causing the disability. This was unnoticed until he was a year old. Coming from a joint family, Gehna received encouragement and assistance which talks of the importance of familial support. This helped in Mohith's positive growth, alleviating the burden of multiple responsibilities of parenthood especially those of parents of children with special needs. Now having moved into a nuclear family set up, Gehna sees that Mohith requires only minimal assistance in his activities of daily living and is able to do little things around the house to help. She is happy with his progress, but as most parents of specially abled children she ponders about his future and his life after her.

# Inclusive Vocational Skills Training Centre (IVSTC)

Focussing on the emotional and innate strengths of the students with positivity, the special educators and trainers helped them progress in functional literacy, skill training, life skills, fitness and behavioural challenges. We witnessed the emergence of leaders, artists, craftsmen, sportschampions, bakers, tailors, teachers, dancers, salesmen and many other special skills amongst the students. A significant change was evident in the grooming skills, being punctual and regular to training. They exhibit values while speaking to others by being courteous, helpful, polite and responsible. The year ended with the senior students being placed in internships.

#### **Highlights**:

- The unit worked on principles of Inclusion, as a team of students with the various developmental disabilities complementing and learning from each other. Opportunities for presentations of learning outcomes, showcasing abilities were provided through assembly, at events and in the classroom.
- Teacher Aide skill training was introduced with three students benefiting from the course.

- Skills in handling money; retail and sales were honed through exposure to daily sales from the bakery and at stalls in corporates.
- Physical fitness training with Runners High group resulted in few students attending regular training sessions at Cubbon Park on



Sunday mornings and completing marathons.

- Internship placements for student Jeeva at a beauty salon; Kalpana, Harsha, Furquan, Abdul at Mitti Cafe; Gayathri at Centre for Special Education as a Teacher Aide will take them forward towards employment.
- Medical screening along with counseling and guidance to parents was successfully completed. Speech therapy sessions were extended to a few students.

# Community Based Rehabilitation

"A Commitment to build diversity, dignity, joy, healing and Inclusion" SSK's team of professionals and community workers worked in unison towards identification of children with developmental disabilities, strengthening direct intervention services in a Transdisciplinary model with active parent involvement and training at the existing locations, thus developing appropriate functional skills in children and promote inclusive education.

Comprehensive Rehabilitation Services for Children with Developmental Disabilities Supported by Azim Premji Philanthropic Initiatives Private Limited, Bengaluru

The project supports children with developmental disabilities at Indiranagar campus, Bengaluru and children at Early Intervention centres (EICs) at Sub Centre, Indira Gandhi Instititute of Child Health; Ramanagaram, Devanahalli, Doddaballapur and Harohalliunits. *Teamwork, Parent Empowerment* 

and Community involvement were the highlights of the success of services at the grassroots level reaching out to families in need.

**Rehabilitation Centre at Indira Gandhi Institute** of Child Health (IGICH) Early Intervention / Rehabilitation Services for Children with Developmental Disabilities Group Programmes for children – Supported by Dept. for the Empowerment for the Disabled and Senior Citizens, GOK; OPD Rehabilitation services supported by Azim Premji Philanthropic Initiative.

Services include diagnostic assessments and follow-up services in physiotherapy, speech therapy, audiology, occupational therapy and special education to children from neonates to 8 years of age. 3000+ beneficiaries supported annually. Thanks to the support of the medical team of IGICH for referrals and medical follow up.

As part of the Group Intervention programme, children are trained in readiness skills for learning; social and behavioural readiness for school and activities of daily living. A picnic to Inclusive Sensory Park in Bal Bhavan, situated inside Cubbon Park was a fun day enjoyed by children and their caregivers. Children, parents and staff actively celebrated festivals with the team of IGICH.

#### Activities at Ramanagaram Rehabilitation Unit

The Rehabilitation Unit strengthened the partnership with District Hospital with the active involvement of the team of staff. Continuous and consistent intervention programmes supported the progress of children. Reaching out to families through Home and School Visits



and Cooperative Schooling model continued through the year. Mothers were trained at the main centre in Bangalore in Early Child Education Course and Parent to Parent training aimed at home training for child; reflections; building self esteem; bonding, valuing and respecting each other's views on parenting a special child was initiated which greatly improved support and communication around the child. After shifting to the new District Hospital, the unit was equipped with therapy and educational materials. comprehension. At the end of the year, 92% of children showed improvement in their areas of intervention. The project also supported health screening for all children under the project. 81 children needed nutritional support. Nutrition kit consisting of Ragi Hurihittu, jaggery and ghee were distributed monthly to the children in need.



#### Activities at Devanahalli & Doddaballapura Rehabilitation Units

SSK Rehabilitation Centre at Devanahalli General Hospital and Satellite Units in Devanahalli and Doddaballapur provide individual and group sessions in early intervention. After initial interventions, children are transferred to Anganwadis and primary schools where SSK staff continues need-based therapy and special education sessions. Pre-vocational training was initiated for children above 12-13 years with focus on. paper based products outsourced to SSK's Indiranagar unit. Identified mothers received training in Early Child Education Course and Vocational Courses from SSK's training department.

#### Vidya Project - Enhancing Literacy in 13 Government Schools in Harohalli Supported by Mindtree Foundation

Enhancing Literacy in 13 Rural schools covered screening of around 800 children and remediation support for 255 children (133 boys and 122 girls) from Grades 1 to 4. The remediation included the areas of reading, writing, math and

150 children received telerehab consultations from the medical ; para-medical and special educators from the main campus. The program covered community awareness and supported parent training.
