20th March to 25th March 2022 Pune State Level Training on Making Appropriate Wheelchairs for People With Multiple Disabilities and Cerebral Palsy

There is an urgent need for training workshops to prepare technically mature manpower for holistic rehabilitation of the disabled asserted Samir Ghosh, head of the consultancy and a national expert in the field of disability rehabilitation. In a five-day training program of Wheelchair Service Training as per WHO guidelines organized by Mahatma Gandhi Seva Sangh District Disability Rehabilitation Center Pune, Motivational India, Shodhana Consultancy Pune and Kamayani Training and Research Center Gokhalenagar, the trainers will be teaching on how to make appropriate wheelchairs for the people with multiple disabilities and cerebral palsy as these people needs special attentions towards their special needs. 7th July, 2022 Pune State Level Conference on State Policy for Divyang and Importance of Insurance



Mahatma Gandhi Seva Sangh and District Disability Rehabilitation Centre workshops in association with the Government of Maharashtra and State Disability Commissioner office organized a State Level Summit for discussion on Disability Policies and presented its findings, suggestions and plan of action to implement the Niramaya Scheme by National Trust at State Level.

The Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment of the Government of India has issued a draft policy for persons with disabilities for the effective implementation of the Rights of Persons with Disabilities Act for the comprehensive rehabilitation of persons with disabilities. Amendments and recommendations have been invited for this draft. For that

On the occasion of the inauguration of the program, Maharashtra State Disability Welfare Commissioner Omprakash Deshmukh, Pune Zilla Parishad Chief Executive Officer Ayush Prasad, Deputy Commissioner Sanjay Kadam, Pune Municipal Corporation Social Development Department Deputy Commissioner Ranjana Gage, Pimpri Chinchwad Municipal Corporation Urban Assistant Commissioner Srinivas Dangat, District Disability Rehabilitation Center Project Director Vijay Kanhekar, Counselor Haridas Shinde, Manager of Child Welfare Institute Aparna Panse, Assistant Commissioner of Skill Development Department Kavita Javale and other dignitaries were present.

In this day-long seminar, Madhukar Katwate, retired officer of Divyang Commissionerate, Rajiv More, Ajay Ahivale, Minita Patil of Abhisar Foundation, Pune Dist. W. Rohini More of Social Welfare, Dr. Vachasundar, M. Amey Aggarwal, Chief Executive Officer of Gandhi Seva Sangh Sanstha, Ashok Solanke, Ramesh Masudge, Sagar Kanhekar of Pune District Divyang Rehabilitation Center, Dharmendra Satav of Prahar Apang Kranti Andolan Organization, Surekha Dhavale, Bhagyashree More, Datta Bhosle, Chandrakant Hake of Divyang Rights Security Committee, Social Welfare Department Retired Divyangsevak Sunil Bhumkar, Nilesh Chhadwilkar of Indian Institute of Knowledge, along with representatives of many organizations and activists in the field of disabled rehabilitation in Maharashtra State participated. Topics such as Early detection of disability and prevention of disability, social

security and Insurance for the Divyang in the Draft National Policy for Persons with Disabilities was discussed by dividing the present members into seven groups.

The main focus of the conference was on disability insurance and the state wide implementation of the insurance scheme. Suggestions were provided to make the Niramaya Scheme of the National Trust Cashless and also that on the grounds of the Niramaya Scheme, a state level scheme should be designed that will cater to people with multiple disabilities.

Moreover, suggestions were made to make the National Trust schemes more accessible to all the people by making sure that all the stakeholders and administrative officers get proper trainings across Maharashtra so they could cater to the divyang in the right way and spread awareness about the National Trust activities.
