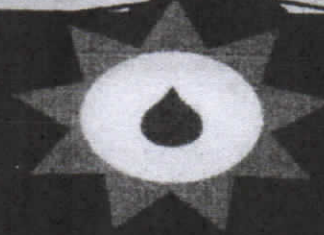

## 1. Special School for the Children with Special Needs:

BharatJyoti continuing the Special School for the children with Intellectual Disability, Hearing & Speech Disability & Visual Disability with residential care with the aims & objectives of bringing about feasible improvement in the life of the Children with Special needs through acquiring skills as basic as activities of daily living to their integration of learning. This year our institution have taken utmost care for enhancement of the cognitive abilities of different categories of children such as **Intellectual Disability, Speech and Hearing** and **Visually Disability** for bringing about behavioral changes, physically activities for improvement in dancing, play-acting, yoga, arts and crafts, music, painting and other creative vocational inputs through online classes due to COVID-19. This year 85 numbers of different disability categories of children were continuing their special education, out of this 11 numbers of children of our school passed out from class VIII & promoted to class IX & admitted in different Secondary schools for higher studies & students from Intellectual Disability section completed Pre-vocational Training 16 Nos. & left the school for higher vocational courses or skill Development training at Bhubaneswar.

BharatJyoti is continuing Rehabilitative / Therapeutic Services in the Sub-Divisional Head Quarter of Kaptipada Sub-Division at Udala, where children with Intellectual Disabilities ( Mental Retardation, Cerebral Palsy, Autism & Multiple Disability ) are getting the therapeutic services from our centre. Physiotherapist, Occupational therapist, Social worker, Special Educator & Care Giver have been engaged with this unit.

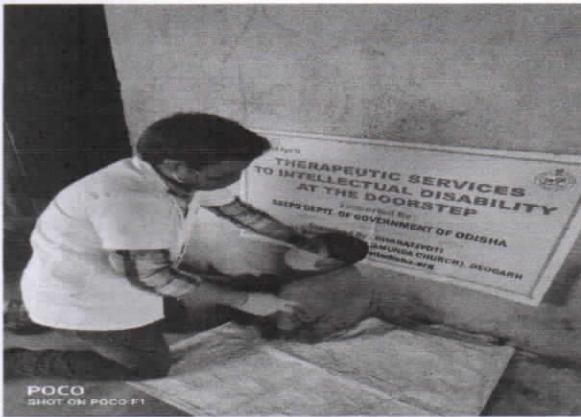
This year 40 Nos. of children with Intellectual Disabilities are availing the services in residential care basis in Mayurbhanj district & 84 Nos. of children with Intellectual Disability have been availed this services in Day Care Services at Deogarh dist. under Deogarh project office. #### Vikaas Day Care Programme :

BharatJyoti being a registered organization with National Trust, continuing a Day Care Centre with identified beneficiaries of 30 Nos. at Udala under Mayurbhanj district in the State of Odisha by the assistance of National Trust. Our volunteers aware the parents of persons with Intellectual Disabilities in different blocks of Mayurbhanj district. Accordingly 30 Nos. of Divyanga's data enrolled with National Trust portal for Vikaas Day Care prog. The programme continued with the help of experienced & qualified, therapists, Special Educator-cum-Vocational Trainer, Counselor & Care Givers.

The main objective of this programme is to expand the range of opportunities available to a person with Disability for enhancing interpersonal & vocational skills.

The Day Care Centre is continuing at Mendhakhai, Udala in the Sub-Divisional Head Quarter of Kaptipada Sub-Division, Udala under Mayurbhanj district since morning 9 A.M to 1 P.M & within the end of this financial year 30 Nos. of PWDs of MR (Mild & Moderate) category have been enrolled & continuing with the Day Care Centre. Frequently parents Guardians meeting is being carried out by our counselor & staffs about the progress of PWDs. Unscheduled visit of SNAC Co-ordinator of odisha encourage to the beneficiaries & management.



#### Niramaya Health Insurance for the Divyangjan :

Being a registered organization of National Trust, this financial year 2020 - 2021 BharatJyoti has enrolled applications for Niramaya Health Card 112 Nos. from Mayurbhanj district, 157 Nos. from Cuttack district & 26 Nos. from Deogarh district & all the beneficiaries have obtained their Health cards. This year 125 Nos. of beneficiaries have received their mediclaim amount from oriental Insurance on reimbursement basis.
