Our focused target groups are People with Disabilities and their Parents, Children, released Bonded Labour, Migrants, Returnee Migrants, Potential Migrants, Persons with Mental illness and their Caretakers, farmers, aggrieved consumers at micro level and we focused on service providers, institutions, civil society organizations, duty bearers, Networks, Federations, Media Persons at macro level in our different interventions and programmes.

# Alternative Forms of Care and Support Programme for Children without Parental Care and Other Vulnerable Children

The "Alternative forms of Care and support programme for children without parental care and other vulnerable children" has been launched in the month of May 2013 with the support from the Stichting Kindpostzegels, Nederland. The programme was directly working with children living without adequate parental Care in the Grampanchayats with an approach to ensure that children in need of care and protection have opportunities and access to services which help them to exercise their rights to survival, development, protection and due participation in a family based care and community. In this phase the approach of the programme has shifted to "Child centred family focus programme" with community based framework. Currently the programme is being implemented intensively in Eight Grampanchayats namelyRengali, Chhakormal, Lachhipur, Khaliapali, Mayurudan and Mallikmunda under Sonepur Block of Subarnapur District and Gudvela Gram Panchayat of Gudvela Block under Bolangir District in the State of Odisha. The RARE is directly working with 103 vulnerable families and their children in need of care & protection especially children without parental care, orphan and other vulnerable children. The programme have been working to improve the socio-economic status of the supported families and children with regard to care and protection at family, institution (AWC/School) and community engaging the community actively in the entire process. It is the one of the key values of the programme which we are practicing that not to refer the directly target children and their families as the receivers of service rather consider and involve them actively as the partners.

# Kay Achievements

- Maintenance packages of nutritional food, educational materials, health and hygienic care
  materials provided to 103 families to reduced the economic burden of the family, by which
  children are living with dignity and enjoying their childhood with full love, care and affection.
- 176 children are accessing basic support & care services

- 208 children out of the 100 supported families are in primary & secondary schools with 85% attendance.
- Financial assistance has been provided to 34 families to start income generation activities enabling them increase their income up to Rs 200 to 250 per day.
- 878 members actively involved in Child Protection Committees in integrated child protection Plan.
- 28 VLCPCs and 7 GPLCPCs have been formed and oriented about their roles and responsibilities which resulted to resolve the child protection related issues of the village.
- 7 numbers of Caregivers Association formed and strengthened in 8 GP. This initiative has stimulated the process to access widow pension for 77 caregivers, Rural Housing to 45 caregivers, National Family Death Benefit Scheme for 28 caregivers and inclusion of 59 care givers in Self Help Groups, Kitchen gardens are raised by 19 caregivers ,17 were benefited with bicycle scheme, 73 families have been benefited with IHHL scheme where as 93 families are receiving ration under food security scheme.
- 5 nos of training provided to the caregivers on skillful parenting and preparation of kitchen garden, mushroom cultivation. This action has resulted in building parent-children relationship, reduction in physical abuses of children, increased participation in school, thus giving adequate importance & attention to children in families. Parent has risen their earning to have more spending of money for their children education & health.
- 5 round of trainings has been conducted for AWWs, ASHAs & Teachers on adolescents' health care, Child Safeguarding, prevention of child marriage & child protection related Act, i.e. POSCO act and The statutory bodies formed to resolve the issues of vulnerable children.
- Four rounds of interaction with both the members of Child Welfare Committees of Bolangir & Subarnapur districtwere conducted. Presention made regarding the process adopted to provide support under the programme as well as gate keeping mechanism developed under the programme for the protection of children. The members of Child Welfare Committees are extending their support regarding the guidance to families and they are also keeping their presence during the training and capacity building programme under the project.
- 5 members of Taskforce visited to the project operational areas i.e. Lachhipur, Khaliapali, Mallikmunda and Mayurudan Gram Panchayat under sonepur block of Subarnapur District and Gudvela under Balangir District. Discussed with the supported families, VLCPCs, Children regarding the support given under alternative child care programme. They also discussed with the non supported families under the programme regarding the training, counseling, access to schemes & benefits under the programme. Found that the supported families are living well for this support and they are preparing themselves for living independently. They have placed their observation before the CWC and DCPU for resolve the issues of children
- International women's day were organized in the project at Khaliapali and Gudvela to realize and discuss regarding the contribution of women for the development of society in different fields. 257 women's participated and got information on the different dimension of women empowerment
- Children's Day is celebrated to increase awareness of the rights, care and education of children.
  we celebrated this day as festival for children as it is their's day. In the programme 328 children
  participated in various games and competitions. The children were also asked the guest
  regarding their issues and the Guests preset in the programmes assured to resolve the issues
  very soon in coordination with the line department.

# CRC @ 30

In the year 2019 Odisha Alliance for Child Rights celebrate the 30<sup>th</sup> Anniversary of the Convention on the Rights of the Child (CRC), the most widely ratified human rights instrument in international law till date. CRC is a human rights treaty that specifically grants everyone under the age of 18 various civil, social political, economic and cultural rights and sets minimum standards for the protection of these rights. It was child-led Child Rights Situation Analysis & Campaign for promoting child rights culture.

Based on the completion of 30 years of United Nation Convention on Rights of Children, an impact study was done through the Odisha Alliance for Child Rights and PECUC. RARE was the partner of the study for Subarnapur and Bolangir District.

Before going to start the Impact Study programme two days Regional level training programme for the Child Researcher with one SAATHI of Bargarh, Subarnapur, Bolangir, Nuapada and Kalahandi. Were participated. From each district there were 3 boys, 3 girls with 1 SAATHI were participated. The training was facilitated by Ms. Anuradha Mohanty from PECUC.

Just after the training programme the Child Researcher visited to their respective field and started the impact study on child protection through focus group discussion and individual from different stakeholders like child club member, member of child protection committee and PRI members. The study was done with 3 Gram Panchayat from each district. RARE had conducted the study programme in Mallikmunda, Khaliapali and Lachhipur under Subarnapur District and Madhekela, Deulgudi and Gudvela under Bolangir District. After the completion and compilation of findings it was shared with Gram Panchayat level Child Protection Committee and District Level Official by the Children. Later on a state level sharing was done by lead partner PECUC.

# Destination Unknown Campaign

The Research Academy for Rural Enrichment (RARE) is a campaign member organisation for the Subarnapur (Sonepur) district of the State of Odisha with the support of CARD, Bhubaneswar. The Destination Unknown Campaign is led by Terre des hommes globally to protect children on move. Millions of children are on move globally. They do not know their destination. They lost their childhood and home.

Children have the right to move, as well as being protected, based on their best interest and views. With this being a campaign member organisation we have conducted various awareness generation programmes in the Subarnapur district.

  move also they are knew about the child rights
- The understanding level was developed among the general public on the impact on move to a
  destination unknown place through cultural programme (Street Play)
- A charter of demands has been finalized for submission to the Chief Minister.
- Govt. officials, who are working with Children, were made aware on the cause and ways to
  protect the children from move to an unknown destination.
- 15 children have got a platform to raise their issues regarding migration and school before the district administration.

## DISHA CUM VIKAAS CENTRE

DISHA Centre is an early intervention and school readiness Centre for Children with Autism, Cerebral Palsy, Intellectual Disability & Multiple Disabilities between the age of 0-25 years.

The Centre aims at early identification, intervention and school readiness. The services provided in the Centre are early identification and intervention, physiotherapy, speech therapy, Nutritional food, Activities of Daily Living, special education, counseling services, referral services, provision of positioning and assistive devices, inclusion in school and different scheme and programme by a team of trained, skilled and professionals. Free transport facility is provided to the children for attending the Centre regularly. 40 children are enrolled and availing services from the Centre.




#### SWABALAMBAN-DAY CARE THERAPY CENTER

Person with some different type of disability like Intellectual Disability, Cerebral Palsy, Autism and Multiple disabilities are neglected more due the lack of knowledge regarding these types of disability and specific rehabilitative measures and extent of the same needed for these people. Again the problem is worse for such people living in rural and backward area where the special service for them is not available. Hence to cater the need of these categories of disable we are implementing a Project entitled "Swabalamban-Day Care Therapy Centre" for the children with Autism, Intellectual Disability, Cerebral Palsy and Multiple Disabilities with the financial support from Social Security and Empowerment for Persons with Disabilities Govt. of Odisha, with all required aids, appliances and qualified experts in concern fields. Two therapeutic center are running by RARE one is at Sonepur of Subarnapur District and another is at Kantamal of Boudh District.

The objective of the centre is to provide therapeutic and rehabilitative services and enhance the interpersonal and vocational skill. 99 children with disabilities avail the services on daily basis.

#### Achievements

- 10 numbers of children with disability having speech problem are availing services from DCTC. Children are able to speak
- 49 CWDs availing therapeutic services
- 67 CWDs availing rehabilitative services like training on ADLs and special education. 25 have doing their ADLs without support and 42 have with support.
- DCTC have its own multidimensional activities to create a platform for CWD for their inclusive development. The Parents are getting platform to enhance their knowledge on disabilities and process of rehabilitation.
- The CWDs are availing therapeutic and rehabilitative services in a daily basis. Different types of
  activities has been conducted such as creative fest, inclusive sports, vocational training for social
  inclusion and economic rehabilitation.
- A Van has been moving named "BHINAKSHYAMA SEVA O SAHAYATA EXPRESS" to the
  villages in every Saturday. The objective of the express is to disseminate the information on DCTC,
  early identification of CWDs and provide therapeutic services at door step.
- 72% parents are doing exercise at home and support their child in the rehabilitative process.
- Due to awareness meeting and mobile van Services local health service provider and doctors are referring the child to the centre for therapeutic and rehabilitative services.

# COMMUNITY BASED REHABILITAION PROGRAMME FOR THE PEOPLE WITH DISABILITIES

Community Based Rehabilitation Programme for Person with Disabilities is being implemented by RARE since 2011 at 6 Gram Panchayat of Tarva Block of Subarnapur District and 5 Gram Panchayat of Gudvela Block of Bolangir District with 1047 persons with disabilities. The project aims to undertake socio-economic rehabilitation of persons (including children) with various disabilities, building their agencies, strengthening and demonstrating services for disabled people and making the community and government systems sensitive and responsive towards the problems of persons with disabilities

#### Achievements

57 nos. of Disabled People Organization (DPO) have functioning actively. 23 nos. of DPO independently identified, raised and address their issues at Gram Panchayat and Block Level.
 As a result 3 have got wheel chair 28 have got disabilities Pension, 144 have enrolled in IHHL.

- 54 Self Help Groups are in functioning. 36 nos. of Self Help Group of Disabled received support from Government.
- 54 Persons with Disabilities have repaid Rs 130450/- to their loan account from their profit
- Rs 32000/- have been deposited in Bank by 11 SHG out of their profit.
- 190 Persons with Disabilities have applied for job under MGNREGS and getting job guarantee card
- 30 Persons with Disabilities have got house under Pradhan Mantri Awash Yojana.
- 56 Persons with Disabilities have got Buss Pass and Train Pass
- 652 have got new Disability certificate under UDID.

# COMMUNITY MENTAL HEALTH AND DEVELOPMENT PROGRAMME (Strengthening community based integrative care of people with mental illness)

RARE has been working on Community Mental Health and Development Programme since 2018 in Subarnapur District with the Support of Basic Needs India, Bangaluru. The programme aims at improved human rights of people with mental illness, reduced stigma and discrimination in community and resource enhancement of all stakeholders. The Programme is being implemented in Subarnapur District, targeting 500 Persons living with mental illness. 10 Community Volunteers are engaged in the process for identification, facilitating the process of treatment & access to entitlement, provide psychosocial education and referral services to PWMIs. On the other hand, periodical meetings have been conducted to activate the local health service provider such as ASHA, ANM and AWW on mental health to identify and provide referral services.

- 42 PWMIs have been provided with medicine support from the programme and they are also in stable condition.
- 41 PWMIs have received disability certificates, 41 PWMIs have got pension and 32 PWMIs have got PM Awash Yojana/Mo Kudia/Biju Pakka Yojna
- 10 Family support groups have been formed with regular meetings for strengthening
- 107 ASHAs and AWWs are actively involved in Identification, referrals and follow up process
- 285 have involved in household productivity activities
- 418 caregivers and 210 PWMIs have awareness on psychosocial education

# SEXUAL REPRODUCTIVE HEALTH AND RIGHTS

- 80 adolescent girls were made aware on child marriage & its impact, different government schemes for the children and adolescent health care & reproductive child health. All the adolescent girls have pledged against child marriage and aware to their neighbours to stop child marriage.
- 1500 members from SHGs and VLCPCs were aware on the impact of child marriage and pledged to stop child marriage.
- On the observance of International women's Day 126 members were pledged against Child Marriage.
- 105 members from SHGs were made aware on Adolescent Health Care, Education, Gender Based Violence, Domestic Violence and pledged against Child Marriage.

# Establishing a Manufacturing and training Unit of Sanitary napkins and its workshop for caregiver of without parental care and adolescent girls

Menstruation is a normal biological process which maintains the female reproductive cycle. This topic remains indescribable and is even considered unthinkable in different part of the world. In developing country like India, women have to deal with menstruation secretly. Poverty, Gender inequality and repressive conditioning of women folks continue deny to access proper menstrual hygiene products.

In India out of the total 355 million menstruating women, Only 12% of Indian women use sanitary pads. Lack of awareness and social cultural beliefs that render menstruation as a dirty phase in women's lives have deprived women long to access proper menstrual hygiene management

In Rural India, where the taboo related to menstrual hygiene is stronger, many girls are force to leave school out of fear of public shaming and discomfort. The condition of a girl one who deal with menstruation without proper aid may face health riskduring periods and after.

#### Achievements

- Awareness sessions were conducted for women adolescent girls, SHG members and students in 45 villages of Rengali, Chhakormal, Lachhipur, Khaliapali, Mallikmunda and Mayurudan Grm Panchayat under Sonepur Block of Subarnapur District covering 50 AWWs, 35 ASHAs, 923 Adolescent girls, 534 school students, 995 probable mother and 482 members of Self Help Group.
- The training and Production unit has already installed at khaliapali village under Subarnapur District of Odisha, India. On 13th February, 2020, the technical person from supplier grounded the unit, makes it functional and imparted 2 days practical training to 5 Care givers and 5 adolescent girls along with 5 staffs of RARE. Before starting the training programme in the first day the trainer Ghanashyam Pande demonstrated on installation of Pressing Machine, Sterilizer, solding iron, rolling stand and die.
- Soon after the training programme, in the very next day all the trained caregiver, adolescent
  girls and staffs of the unit are engaged in the manufacturing process. Up to 21st March, 2020
  we have already product 9007 pieces of Sanitary napkin. At present the adolescent girls and
  care givers are able to product 200-250 pieces of sanitary napkin per day. The production of
  sanitary napkin has started and the sample has been sent to "Opal Research & Analytical
  Services", Gazihabad, Uttar Pradesh for testing and approval.

To strengthen the capacities of elected women representatives of Panchayati Raj Institutions, a project titled "Strengthening Capacity and Leadership of Elected Women Representatives" is being implemented in 15 Grampanchayats of Tarbha Block under Subarnapur district since August 2017 with the support from "The Hunger Project India". With the objective to create a gender sensitive Panchyati Raj Institution and build the leadership skill of newly elected women leaders to understand their role and responsibilities to carry out the work effectively.

# DEMONSTRATION OF STRESS TOLORANT RICE VARIETIES

RARE is working on sustainable agriculture, drought management and forest protection to reduce the adverse impact of climate change and drought in the KBK region. To promote climate change adaptability among farmers and increase their productivity IRRI has bred several stress tolerant rice varieties for drought prone area, saline prone and water lodge area. Western part of Odisha is drought prone area and most of the part is rain fed area. To cater the need of the farmer, In collaboration with International Rice Research Institute (IRRI) and Government of Odisha has implemented a project "demonstration of stress tolerant rice variety" in Padampur Block of Bargarh District have been demonstrated on 50 hectors in nine villages of two Grampanchayats





Livelihood is the key component of the programme to create the opportunities for PwDs to start income generation activity. In this current year 150 PwDs and their families\* continued their vocation. 46 PwDs have started business with financial support by DPO federation Tarbha & NFI.

This Initiative creates an opportunity for 22 PwDs and their family memberto made annually additional income more than INR.5000 and they have reduced their economic burden with saving of INR.170, 000.

Six rounds of meeting with each village level Self-Help-Group of persons with disabilities in 18 villages with 20 SHGs were conducted. 107 Persons with Disabilities 67 Males and 40 females are involved in the Self-Help-Group. The SHGs of PwDs has playing major role for financial inclusion services, focusing in wage & self – employment and access to loan services to start income generation activity. They are working for financial inclusion, income generation activity, rapport building with bank and filing of loan application, maintaining of their group cash book and receipt & payment voucher.

#### The initiatives of SHGs have been resulted in;

- √ 17 SHGs of PwDs are doing internal lending.
- ✓ 4 SHGs (Maa durga SHG, Gudvela 22,200, Jaga Balia SHG, Dungibahal 31,080, Maa Laxmi SHG, Gudvela 6,720, Samaleswari SHG Deulgudi 15,600) has already started egg whole selling and earned profit upto 76600 during April 2019 to 31<sup>st</sup> March, 2020.
- ✓ 5 SHGs (namely Maa durga SHG, Gudvela, Samaleswari SHG, Bagbahali, Maa Laxmi SHG, Gudvela Samaleswari SHG Deulgudi and Jagabalia SHG Dungibahal ) SHG of PwDs has started Agarbati making earned profit up to 8,000 during April 2019 to reporting period.

Their families and caregivers also go through lot of stress and challenges in having a person with disability due to unavailability of therapeutic and rehabilitation services. People living in rural India are unaware about disability and their rehabilitation mainly children with cerebral Palsy, Mental Retardation, Autism and multiple disability.

To cater the need of the children with MR, CP, MD and autism RARE initiate a mobile van services named BHINAKHAMA SEVA O SAHAYATA EXPRESS. The objective of the initiation is

- To create awareness
- To create a system of Referral services
- · To promote inclusiveness
- To facilitate door steep rehabilitation services
- To create a network with village service provider

Bhinnakshama Seva O Sahayata Express started its journey to serve the children with disability on 10<sup>th</sup> March 2018. Every Saturday it reaches a village and does the following activities.
