ABOUT ORGANIZATION



ANNUAL ACTIVITIES FOR THE YEAR 2020-2021

It was a very tough year for every one as the year started with Covid-19 Pandemic, but under the guidance of Central government, State Government& district administration, Navchetna Society provided its services to the children having Autism, cerebral Palsy, Mental Retardation, Developmental Delays, Speech Delays & Multiple Disabilities at their door steps / home.

The total number of 36 PWDs were benefited from Navchetna Special School, Day-care scheme of The National Trust & Holistic rehabilitation Center of Navchetna Society. Out of total number of 36 beneficiaries the children with Mental Retardation were- 25, Cerebral Palsy –10, Multiple Disability - 1were benefited.

In keeping view of the objectives of the Navchetna Society, the year of 2020-2021 has completed with lots of Activities for the children like, Covid-19 Pandemic Awareness & prevention, Awareness among the parents & society, distribution of mask, sanitizers and preventive measures pamphlets to families of children having disabilities specially Autism, Cerebral Palsy, Mental Retardation, Developmental Delay etc.

Due to covid-19 pandemic situation the working of Navchetna Society were entirely different and we all worked under the guidance of The National Trust, Government of India and advisory released by the State Government.

On 04th April 2020, the Navchetna Society, Hoshiarpur made a difference for a Mr. Jawed's Life who absconded from his native place Delhi to Amritser. Navchetna Society tried its level best to bring him back to his parents when it was a very tough lockdown in the nation and worldwide. Within 24 hours the child was with their parents. It was all done in coordination with center& state government.

Navchetna society conducted the home-based awareness &sensitization program, intervention at home were also reinforced, distributed the dry ration, distributed android mobiles for online connectivity &for online special education classes and intervention.

All activities were like home based& online sessions of special education, Guidance & counselling, Physiotherapy, Speech Therapy were conducted by visiting children's home.

As per the guidelines of the National Trust the ration, Masks & Sanitizers were distributed to all children of Navchetna Society & day care students.

For the smooth conduction of the online home management program, Samsung Android Mobile phone were distributed. Health check-ups were done on regular basis & in need of time the medicines were precured for children who were in need.

The parents were counsel to follow the home plan & homework handed over to them, for the same demonstration were done at their home itself. In need of time telephonic counselling sessions were also conducted. We have attached the pictures of children with neurological conditions under the Navchetna society & the National Trust. We hope and believe that we all come out with this Covid-19 Pandemic soon and life will come to normal as it was.

HOME BASED EDUCATION

Home Based Education has provided to the students under Day Care of National Trust and other for home Intervention.



ONLINE STUDY

The Educational & Cognitive concepts were taught online also for consistent Assessment, Evaluation, and Improvements



HEALTH CARE SERVICES

Health Care Services provided to families of children having disabilities. In need of time Navchetna Society's Transport was prepared to take the kids to the hospital.



GUIDANCE OF PARENTS AGAINST CORONA VIRUS Parents and Guardian were guided to take necessary precautionary measures to present spread of Covid-19. Suggested them to wear mask regularly, avoid crowded places & wash hands regularly.



RATION DISTRIBUTION

Ration were distributed to the families having kids with disabilities. Immediate Medical support & Essential foods were distributed.



STATIONARY DISTRIBUTION

Basic stationary such as notebooks, pencils, erasers, pens, color boxes and worksheets were distributed during the Corona Virus. pandemic, so that their wish to study shall fulfilled and doesn't get affected because of lack of resources.



MOBILE DISTRIBUTION

During the Corona Virus, Pandemic, needy children were provided Android Mobile Phone and parents were informed to run android phone. The Reason for providing android phone is that there should not be any hindrance in children's education and communication with Navchetna Society.



SAFE HOME RETURN OF INTELLECTUAL DISABLE DURING THE

LOCKDOWN

On 2nd of April 2020 the SNAC PUNJAB (State Nodal Agency Centre). Received a call and message of Program Director of The National Trust i. e Mr UK Shukla on official Number of SNAC mentioning the detail of the male Child Called Jawed aged 21 year from Delhi Mayur Vihar, who was absconding from delhi few weeks before and found in Amritser Punjab with a lead of the civilian from Amritser. SNAC Punjab Navchetna Society, Hoshiarpur started intervening on 3rd April 2020 Morning with the ONLY LEAD provided by the National trust. We got to know that the child was in Ramtirath Police station but when we called up the SHO of Ramtirath police station, he updated that Mr.Jawed is out of their custody.

SNAC requested the SHO and spoke to the DSSO (District Social Security officer) Mr.Narinderjit singh Pannu immediately to be in action regarding the issue, following which DSSO and SHO Ramtirath police station came in action and found the boy in an Hour at Kamboh Police Station's Jurisdiction. The moment SNAC Punjab received the Information from DSSO and SHO Ramtirath Police Station, we had a conversation with SHO Kambo Mr. Yajvinder Singh and simultaneously spoke to Superintendent of Police (SP) Rural Amritser Mrs. Amandeep Kaur regarding the case of the child that he is having intellectual Disability with secondary Comorbid Conditions.

SP Rural Amritser Mrs. Amandeep Kaur understood the severity of the case and in Coordination with the SNAC Punjab, took the child to Civil Hospital for his medicines and proper medical assessment of the child for any Covid Symptom etc. Simultaneously the SNAC Punjab was in touch with the National Trust and DSSO of Amritser for further actions to be taken. Meanwhile, the mail was framed regarding the case by the National trust's program Director Mr UK Shukla with the SNAC Punjab and sent immediately to Amritser Adminstration I. e DC (Deputy Commissioner), ADC Grievance (Additional Deputy Commissioner), CDPO (District Child Protection Officer), DSSO (District Social Security Officer), CIVIL SURGON, DSP RURALAmrister.

After few minutes of the mail sent, SNAC punjab had words with the PA of DC Amritser Mr. Surabh Kumar regarding the action being taken on the mail sent and spoke to the Mrs. Alka ADC Grievance (Aditional Deputy Commissioner) Immediately, it was discussed and requested to ADC Grievance Amritser to take immediate action on care and protection of Mr. Jawed as he is having Intellectual Disability.

SNAC asked ADC Grievance Amritser to provide following few things:

1. As doctor at emergency of Civil Hospital suggested Mr. Jawed to be in home Quarantine, so arrangements to send him back to his home Delhi to be done immediately (Copy of Civil Hospital recommendation were sent to Mrs. Alka's phone).

2. As he was out for very long so provide him hygienic clothes, food and medicines as prescribed on his prescription sent by parents on what's app (Copy of prescription were sent to Mrs. Alka's phone).

After the discussion with ADC Grievance Amritser, SNAC Punjab called Mrs. Amandeep Kaur SP Rural Amritser immediately to update the conversation with ADC Grievance and Civil Surgeon's Recommendations and orders.

SNAC Punjab suggested SP Rural to organize an immediate meeting with SSP ruralre

garding Mr. Jawed's safe home return. And by 6:00pm Mrs. Amandeep Kaur SP rural called SNAC Punjab and gave information that Mr. Jawed will be going home in an hour with full protection (four constables) as all orders were Soughted from the Amritser Administration.

Also to mention, SNAC Punjab Navchetna Society Hoshiarpur was in continues touch with Mr. Jawed's parents on phone for updating the safe guard of their ward and providing them a counseling support.

On 4th of April 2020 at 6:00 am Mr. Jawed was safely handed over to parents through Mayur Vihar Police station. Later the SNAC Punjab Navchetna Society Hoshiarpur personally confirmed Mr.Jawed's safe return through telephonic conversation with Jawed's parent. This whole process of safeguard and safe home return of an Intellectual Disabled on this lockdown took only 24hour after the information received by the SNAC Punjab Navchetna Society Hoshiarpur. This could be possible due to the cooperation, collaboration and efforts of the SNAC PUNJAB (Navchetna Society, Hoshiarpur) and Amritser Administration.
