FOUNDER'S DESK

India, our holy motherland, is a glorious Country. We have reached the top most goal of human civilization. We the Indians have crowned the throne of superiority of the World. But our head bowed down with a shameful curse of the burning problem of begging. No doubt begging is one of the greatest problems of India. This is obviously true that the lion's share of these baggers belong to somehow disable persons.

We will take pain to look into the Reports of World Health Organization that 10% of people of our motherland India are suffering from disabilities. In accordance with census report 2011, 3% people of India are handicapped. The percentage may 3 or 10 that does not vary; in our province West Bengal the percentage has exceeded 3%. The diagram of Murshidabad is very poor. And the diagram of Hariharpara in respect of demography is nothing to be mentioned. This can't be denied that major percent of Muslim Minority People (67.67%) are residing at this district Murshidabad. This district is the largest Muslim populated district of India. This district has bagged the top most position in India in respect of economical backwardness. Some critics say there are no comparisons of the district Murshidabad with the district Purulia which is the most backward district in respect of education. There is no Industry in this district. The heritage of this district cottage and small scale Industries have covered faces in the pages of History. The phenomenon of smuggling, stealing, raping, dacoits, women trafficking is the head news of this district. Erosion of land, flood has changed economical condition of this district. Love and affection, sympathy and kindness including all humane values are very hard at present. Amidst this pathetic scenario the problems of the disables may think easily.

In this situation I am to mention the Census report 2011 identified 20, 17,406 persons with Disabilities who constitute 2.21% of the total population of West Bengal. And in Murshidabad this number is 165505.

That the district Murshidabad where we live in is covering in about 5324 sq.km area. It has five Sub-divisions, 7 numbers of Municipalities, 26 numbers of Blocks, 255 numbers of Gram Panchayet and 2166 numbers of villages. In accordance with Census Report 2011 total population of Murshidabad is about 71, 02,430 (at present near about 78 lakhs) and among these 165505 persons are Disables. (The actual figure is much more than this in accordance to our practical experience).

This is our practical experience that so many Volunteer Associations in Murshidabad worked and have been working for the welfare of the disables. It is also a fact that the initiative taken in Murshidabad for the benefits of the disables are pitifully small than the need because of jealousy, fallout among themselves, non co-operative

mentality, unconsciousness regarding government schemes and above all social barrier. This is our motto to get together with all the organization having same aims and objects to create an endeavor.

We are also in this belief that the non co-operation of government officials will have to be converted to an active and conducive effort to wipe out all the hurdles of social developing of the handicapped.

This is to mention that the non co-operative attitude exists in government and non-government foundations for welfare of the disables. But there are little more noble hearted person in this selfish era to stand by for the welfare of the disables. A numbers of eminent personalities of Murshidabad and the rest district of West Bengal and also neighboring States have gathered. Amongst them there are educationist, advocates, journalist and noble hearted persons. You all honored us.

Louis Braille, the Blind Thinker of international repute once said, "If you don't lead me the path, then who is the actual blind?" So, I call you to come forward with a generous heart and feeling with co-operative hands to stand by the persons with special need in our state West Bengal.

Last of all I am to quote from Stephen Hawking, "My advice to other disabled people would be, concentrate on things your disability doesn't prevent you doing well, and don't regret the things it interferes with. Don't be disabled in spirit as well as physically."

Before going to place this present Report I cannot but keep in mind the historic background of setting up JHANJHA UNNAYAN SAMITY.

It was 2006 AD our most loveable, beloved and affectionate JHANJHA UNNAYAN SAMITY was founded on 23rd January in the eve of Birth Day of Netaji Subhas Chandra Bose the greatest fighter of Indian Freedom Movement and the greatest legitimate of humane in reflection through a wistful endeavor of Shri Madan Sarkar, a renowned Social Worker of Murshidabad to rooted out of a serious problem that had among a part of mass of JHANJHA village of Hariharpara Police Station area. Next one, this foundation leads a very important role to lead the PwDs in the main stream of the society and to protect them from various discrimination and deprivation. Simultaneously we are doing various activities on social and cultural field.

Here is an amazing note for you that are at Hariharpara and Domkal 107 nos. of volunteers is being trained under Care Associate Training of Sahyogi scheme. In near future we are going to inaugurate such training at Salar, Lalbagh, Nowda, Jangipur, Dhulian and Berhampore and we are targeted to be trained more 200 volunteers. 40 nos. of PwD beneficiaries are covered health care scheme under the Niramaya scheme. This number will be increased in double within next 3 months. In Vikaas centre number of beneficiaries is 23, in Disha and Prerana this number is 16 and 30 respectively. Not only this but also, more or less 300 PwDs have been benefited by the endeavor of Jhanjha Unnayan Samity in such a way we are gradually developing our selves. I have in the conviction we must complete the incomplete school at Jhanjha within one year. For your kind pleasure I am to mention that a well decorated pamphlet has been published. Our office has been

replaced at Gopalnagar which will surely be a pivot for the PwDs. Within this short time 260 nos. of destitute women are trained on sewing under our foundation.

We have the colorful proud to distribute garments and clothing a numerous men and women. On 22nd August 2016 a special identification camp for the PwDs was held at Choa B.B. Paul Vidyaniketan and 87 nos. of certificate were issued in collaboration with Berhampore Mental Hospital. This programme was organized none but Jhanjha Unnayan Samity.

This is some of the achievements of our foundation. Besides on 3rd December we have observed world disable day on 30th December we have observe the Foundation of National Trust on 3rd April 2017 an indoor programme to observe Autism day was held on 23rd January the Foundation Day of our organization, 24th May Kazi Nazrul Islam Birth Day, 9th May Kavi Rabindranath Tagor Birth Day, 26th September Pandit Iswar Chnadra Vidyasagar Birth Day, 15th August Independence Day, the Inclusive India Programme called by the National Trust and various notable days were observed.

And in these entire programmes Dr. Kalyan Sarkar, Dr. Mujibar Rahaman, Prof. Aditi Kumar Dhawa, Shri Biplob Biswas, Jaynal Abedin, Kazi Aminul Islam, Md. Aijuddin, Abdul Hamid Sarkar, Shri Shyamal Kumar Majumder, Advocate Jinarul Hoque, Abdul Bakir Sekh, Professor Jagabandhu Biswas and Jb. S.M. Zaki glorified us by their August presence.

For your kind information 115 nos. men have taken the membership of our organization from Hariharpara and adjacent Block. And more 22 people have consented to be glorified the chairs of advisor. This is my expectation that both the numbers will be increase.

You all know the inspiring data of JHANJHA UNNAYAN SAMITY, in NIRAMAYA Scheme 100 numbers of Beneficiaries have been enrolled and a new Scheme DISHA-CUM-VIKAAS (Day Care Schem) has sets her journey. 40 numbers of Special Child between 06-18 years age group are cared up at this centre. And the former Disha & Vikaas both Schemes have to close as per the Administrative direction of the National Trust. Amidst this joyous news I want to keep you mind that Joy and Owe are woven fine.

Last of all this is for your brain. Shri Madan Sarkar the Founder and Chief Co-ordinator of JHANJHA UNNAYAN SAMITY has been performing his duties since 14 years. He repeatedly again and again urges that his physical condition and age is beyond of work. Besides he is associated with various social and cultural organizations. So he put and urges to perform the specific duties of all the staffs. We are grateful to him. We have to take an oath that we have to railing the work culture in future as he leads and dream.

During this crucial situation of COVID-19 an unwanted situation is prevailing. There is burden to perform the duties for Lock Down. But, in online procedure we are continuing in work culture. We hope that we will overcome very soon.

Lastly I thank to all the general and governing body members and the staffs, guardian of the PwDs and all the doners and well wishers but whom we will not achieve the crown. Thanks to all.

INCLUSIVE INDIA INITIATIVE PROGRAMME

The programme on 15th August, 2019 organized by Jhanjha Unnayan Samity.

The TRI COLOUR was hoisted at 8.00 a.m. at the yard of the office of Jhanjha Unnayan Samity conducted by Mr. Madan Sarkar, Founder & Chief Co-ordinator, Jhanjha Unnayan Samity. Sri Shyamal Kumar Majumder, Head Master of Choa B.B. Pal

Disha-cum-Vikaas (Day Care Scheme)

Following the administrative direction of the National Trust we have to close the

Disha and Vikaas Centre and merge the two Centers into DISHA-CUM-VIKAAS (Day Care Scheme). 40 numbers of CWSN are cared up here under the supervision of a Special Educator, one Councilor, two numbers of Physiotherapists, two numbers of trained Care Givers and two numbers of trained Aava.



This Centre is inaugurated on 02nd April, 2019 and is in active operation. With physical and mental assistance the CWSNs are cared up.

Helping hands:

JHANJA UNNAYAN SAMITY is not only for the disables but also for the orphans or poor. We also took pain for them. In winter we have arranged a programme to distribute Sweater & Rags to them who have nothing to ward off the cool weather. Tri-Wheel Chair, Hearing Aids, Mobility cycle, Sticks were distributed among the needy persons. And Garments were distributed among poor Muslim. Their smiling face reminds us the

The Institute being influence with our activities maintains a good relation with us. We are proud to Rehabilitation Center for the Children (RCFC) Kolkata. Near about 50 numbers of children get recovery in our recommendation that have physical disability.

Schemes of National Trust

National Trust is an organization for the all-out development of the disables. In 2012 **JHANJA UNNAYAN SAMITY** has got the recognition of this National Trust. Now, our organization will step forward with the others organizations recognized by the National Trust in all India basis. In 2016 we have got the recognition a newly and permitted to run the 10 (ten) schemes of the **National Trust**.

All the year round the dedicated volunteers of Jhanjha Unnayan Samity engaged themselves for the benefit of the PwDs and to provide due co-operation to obtain PwD Certificate, Pension, Scholarship, Identity Card, Kanyashree, Aids & Equipments and other schemes of the Government.

JHANJHA UNNAYAN SAMITY is a well established name in the field of Social Service for the all out welfare of the Disable persons of this District Murshidabad. The Society began a tireless activity for the benefit of the disable persons. Some of these are follows:-

1. PRESENT ACTIVITY

JHANJHA UNNAYAN SAMITY is an RO (Registered Organization) of the National Trust under the Ministry of Social Justice & Empowerment, Govt. of India being No. WJHA16514096608. This Organization is one of the foundations among the 12 organization of this District Murshidabad. Not only this but also we are one of the 45 Organizations of West Bengal registered by the National Trust, Govt. of India. We are proud of the only one Organization among the 3 organizations of our District that is registered by the National Trust. This is very amazing that till now we have applied 6 schemes of the National Trust and out of these 5 schemes are approved.

- **a.** To detect and identify Persons with Disabilities and to issue Handicapped Certificate to such from Government Hospital, Programme has been taken through a special identification Camp.
- **b.** 107 nos. of volunteers is being trained at Hariharpara and Domkal under Care Associate Training of Sahyogi scheme.
- **c.** 100 nos. of PwD beneficiaries are covered health care scheme under the Niramaya scheme.
- **d.** In Disha-cum-Vikaas centre numbers of beneficiaries are 40 enrolled and the Center is running regularly at Vill-Choa (Tamaltala), P.O- Choa, P.S-Hariharpara, Dist-Murshidabad.
- **e.** Within this short time 260 nos. of destitute women are trained on sewing under our foundation.
- **f.** In collaboration with Rehabilitation Centere for Children, Kolkata a programme for treatment both indoor and outdoor also been taken.
- **g.** A review programme of the parents and guardians of the Disables, Trainers, Trainees Governing Body, Advisory Board of JHANJHA UNNAYAN SAMITY are took place once in every two month.
