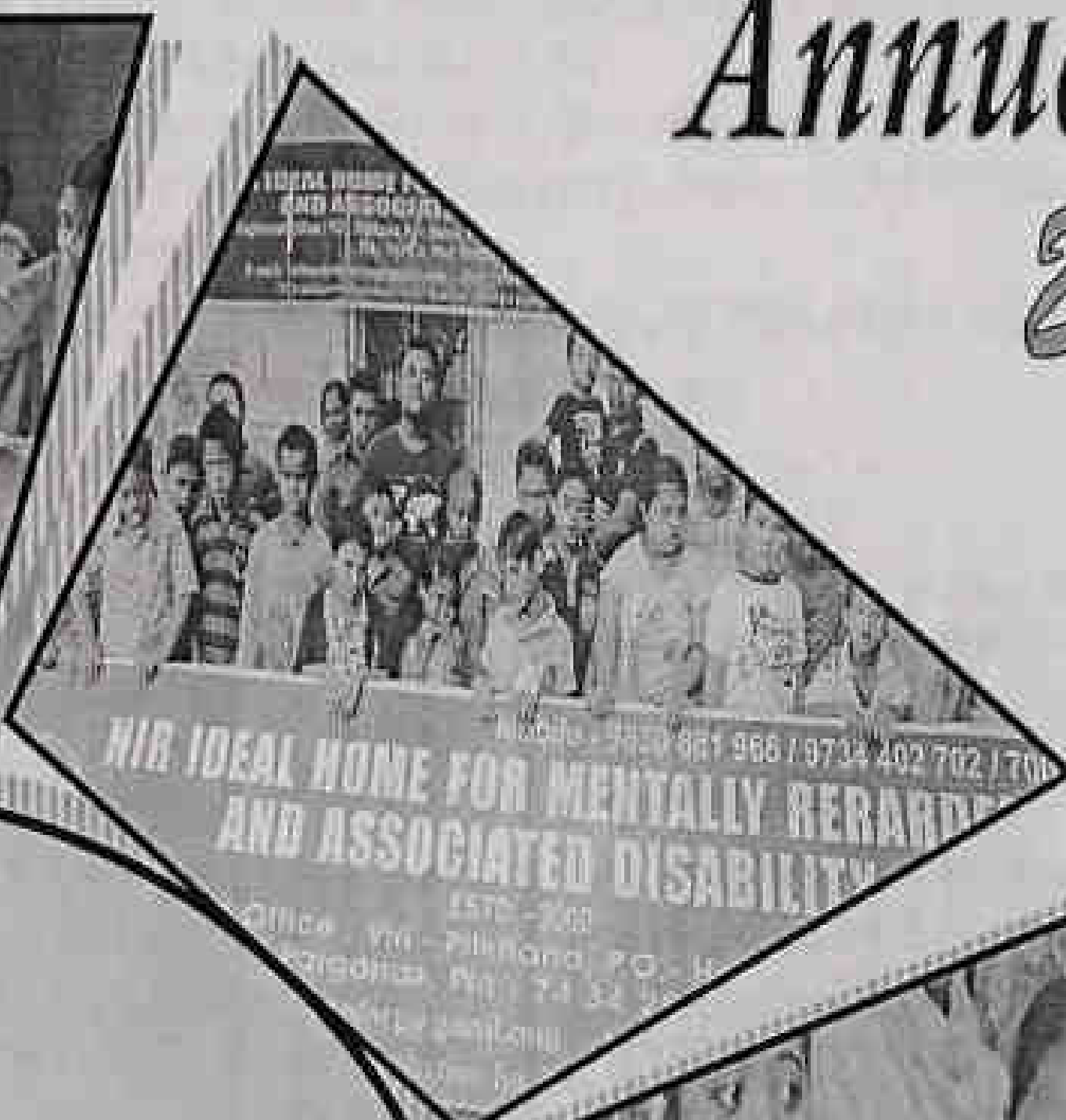

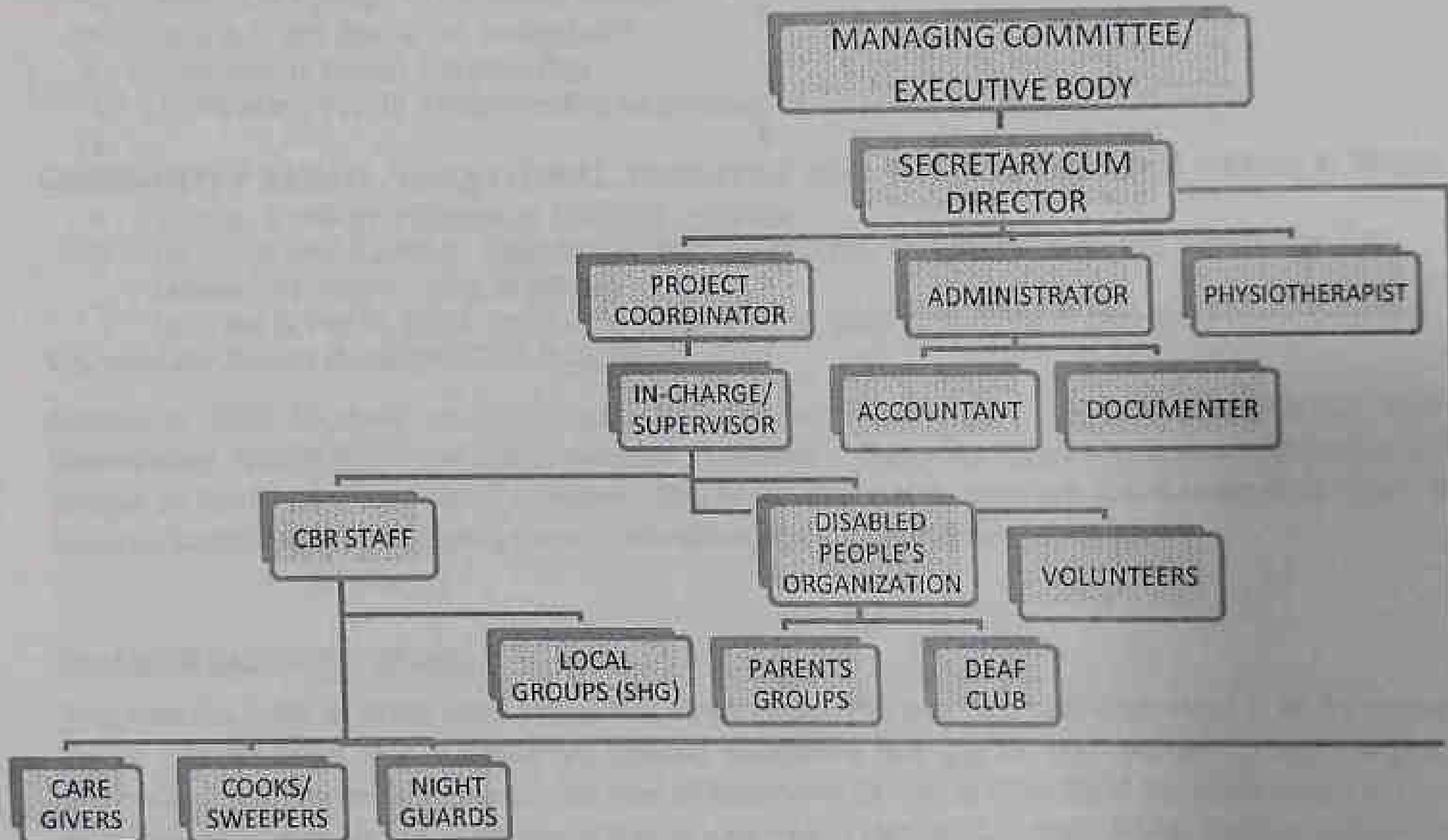

Community Based Rehabilitation Program:

Started in 2007 focusing on pre-primary and non-formal education, medical rehabilitation, community organization, health education and prevention of disability. Currently these services are spread to over Five Blocks of North 24 Parganas like Haroa, Deganga, Basirhat I, Basirhat II and Hasnabad have ensured children with disability completing higher education and vocational skill training.

Deaf education programme:


This was the focus in of Nir Ideal Home last three years. The aim was to include deaf in all its programmes. To do this Nir Ideal Home appointed special educators and got its staff trained in sign language and methods of teaching to facilitate barrier free environment for the deaf. In 2007 Nir Ideal Home started Rural deaf education programme. The aim of this programme is inclusion of deaf children in the mainstream. This programme has been successful including children with deafness in mainstream of schools and families have been proactively empowered in needs of deaf children.

NIR Resource Centre and Special School:

NRC was founded in 2002. This began with the aim of providing education and opportunities for all round development of children with disability. Of the 50 children at NRC, 80% have disabilities –all categories. The remaining non-disabled children complete this unique study environment.

The focus at NRC is on activity-oriented learning. The school offers a good resource center and library. Co – curricular activities like sports, cultural festivals, and arts and crafts ensure all round development. As most children at NRC come from very poor families, facilities like mid-day meals, books, transportation and special coaching supplement for their academic inputs. Their medical rehabilitation, an integral part of their development, is ensured through regular medical checkup, physiotherapy and use of mobility aids.

Community Based Vocational Training Centre (Community Based Management programme): Nir Ideal Home has been organizing Community Based Vocational Training programme for the Adult with Disabilities in small area of haroa Block. There are more than 500 PWDs in our area of operation who deserves same facilities.

We intend to cover the entire area of 9 Blocks and 3 Municipal areas NIR IDEAL HOME has already trained 450 PwDs on different trades who need more support from us.

1) DICUSSION ON HOW THE PwDs WILL CASTE THEIR VOTES :

15.03.2021 : This day a meeting with discussion is conducted at Haroa Block Development Office by NIR Ideal Home for Mentally Retarded and Associated Disability and with co-operation of respected BDO Saheb, Mr. Samiranjana Manna and respected Joint BDO Saheb, Mr. Shambhunath Das. The said meeting with discussion is held at 2 pm. Mr. Md. Abul Kalam Azad, the Secretary of Nir Ideal Home was present in the said meeting. The PwDs who belong to the Hearing Impairment, Mentally Challenge and Blind



participated in the said meeting with discussion. The subject how the PwDs will caste their votes in the forthcoming legislative election, 2021 is discussed and explained elaborately. The BDO and Joint BDO Sahebs discussed and explained the above said subject nicely and in-details so that the PwDs could easily understand to caste their vote. For better understanding an interpreter who knows sign language is engaged by Nir Ideal Home to explain and clarify the above said subject matter. More than 70 participants who belong to the PwDs are convinced by the said interpreter engaged on behalf of Nir Ideal Home. All the present participants are satisfied and they become very happy. The meeting with discussion breaks up at 3.30 pm nicely and with thanks as there is nothing left to discuss.

2) COUNSELING OF PwDs UNDER NIRAMAYA SCHEME IN THE BMCDM ORGANIZATION :

Sunday, dated-28.02.2021 : Nir Ideal Home for Mentally Retarded and Associated Disability arranged, organized and conducted a one day Counseling of PwDs under Niramaya Scheme in the BMCDM organization, located at Nalkora, under Canning-II Block in the District of South 24 Parganas.



This Programme was under National Trust. Mr Samsul Alam Khan and the Secretary of Nir Ideal Home were present in the said programme. Approximately 345 PwDs beneficiaries from grass root level of the Sundarban area attended the said programme to receive service. Most of the PwDs beneficiaries have no Disability Certificate and hence they are deprived of the facilities available under PwD Act. The said programme was conducted smoothly and nicely.

3) COUNSELING OF PwDs UNDER NIRAMAYA SCHEME IN THE GRAM PANCHAYET OF KALKATALA, CANNING-II BLOCK IN THE DISTRICT OF SOUTH 24 PARGANAS :

Saturday, dated-27.02.2021 : Nir Ideal Home for Mentally Retarded and Associated Disability arranged, organized and conducted a one day Counseling of PwDs under Niramaya Scheme in the Gram Panchayet of Kalkatala, canning-II Block in the District of South 24 Parganas. This Programme was under National Trust. Moulana Sahid Ahmed Kashim Saheb



communicated with us and requested to conduct the above said Programme in his birth place of Kalkatala repeatedly and we did the same. Mr Janab Abdul Hai, the Prodhana of Kalkatala G.P. Moulana Sahid Ahmed Kashim Saheb, the President and Secretary of Nir Ideal Home were present in the said programme. Approximately 170 PwDs beneficiaries from grass root level of the

Sundarban area attended the said programme to receive service. Most of the PwDs beneficiaries have no Disability Certificate and hence they are deprived of the facilities available under PwD Act. The said programme was conducted smoothly and nicely.

4) ASSESSMENT PROGRAMME FOR PwDs BENEFICIARIES RELATED TO DOWN SYNDROME :

Wednesday, 10.02.2021 : Nir Ideal Home arranged, organized and conducted an assessment programme for PwDs

beneficiaries related to Down Syndrome. Thirty one beneficiaries with PwDs came from different parts of the Sundarban area to attend the programme. The two assessors from Gift Abled Organisation namely, Mr. Nirakar Sir and Mrs. Rupsha Madam came to assess the PwDs beneficiaries who require physiotherapy, speech therapy and special education. They applied various technologies such as weight measurement, flat feet measurement, arm measurement, height measurement, individual interaction in details to assess and identify the Down Syndrome Children. The experts from Gift Abled Organisation assessed the 33 PwDs beneficiaries related to Down Syndrome carefully. Four experts from Nir Ideal Home on the said subjects helped the experts of Gift Abled Organisation to assess the beneficiaries. Thirty one PwDs beneficiaries and their guardians participated in the programme of assessment and identification of Down Syndrome Children. In future we hope to provide physiotherapy, speech

Training Kits, Banner, LCD Projector and PA system facilities were available in this training programme. Mr. Anupam Das, Co-ordinator of Vocational Training , Mrs. Piyali Kundu, ASLP and Samir Ghosh, Co-ordinator of D.I.L, a resource person discussed how to prevent, identify early and rehabilitate the PwDs elaborately. Mrs. Tamali Ballav, L. E. O. M. E as a representative from Haroa Block attended the programme. The eighty-two participants listened to



the important discussion attentively. Notebooks, pens, cover files and some other training materials were provided to the trainees who participated from eight GPs under Haroa Block. Tea and biscuits as tiffin were given to the participants who came to receive training. Lunch as Biryani was distributed among eighty two participants. The said training programme on PwDs is very important for all round development of the society. The Management Committee conducted the said programme nicely obeying the rules, law and order of the Govt. The said training programme broke up at 4.00 pm. keeping in view the present pandemic situation of COVID-19 protocol and Standard Operating Procedure (SOP). The programme is absolutely supported by Ali Yavar Jung National Institute of Speech & Hearing Disability.

59) Programme on Niramaya Scheme (Health Insurance Scheme) working with the support of the National Trust for welfare of persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities under the Department of Empowerment of Persons with Disabilities (Divyangjan), Government of India :

Near about 120 PwDs of above said description attended our programme. We discussed with those PwDs and their guardians about Niramaya Scheme elaborately. They were asked to register the names of PwDs through Online and they were asked to submit the following relevant documents along with the application. The required documents to receive the facilities under the said Scheme are as follows :

2. Xerox Copy of Aadhaar Card.
3. Xerox Copy of Birth Certificate.
4. Xerox Copy of the applicant's father/mother.
5. Colour Passport Sized Photo
6. Xerox Copy of the 1st page of Bank Account Book
7. Xerox Copy of Ration Card
8. Two active phone / mobile number
9. The Applicant requires no age limit

The areas of Kumarjole Gram Panchayet under Minakhan Block that fall under the area of Sundarban, famous for the Royal Bengal Tiger in the World had been damaged and destroyed by Amphan, the Super Cyclone . The population of the said G.P. were not in a good condition to meet their basic needs such as food, Clothes and shelter due to Covid - 19 and Amphan, Super Cyclone. In spite of adverse circumstances they somehow managed to attend our organization to know and receive the facilities under Niramaya Scheme. We distributed some leaflets among the PwDs and their guardians coming from Kumarjole G.P. Ninety Eight PwDs submitted their documents to us for receiving the facilities under Niramaya Scheme(Health Insurance Scheme). They were convinced and counseled as well as some of the beneficiaries became very pleased to get the information about the facilities for

During the last week of December, 2020 the P.C.s and F.F.s were introduced with all respective CDPOs, Supervisors, AWWs, G.P. Prodhans. Members. Geographical areas and

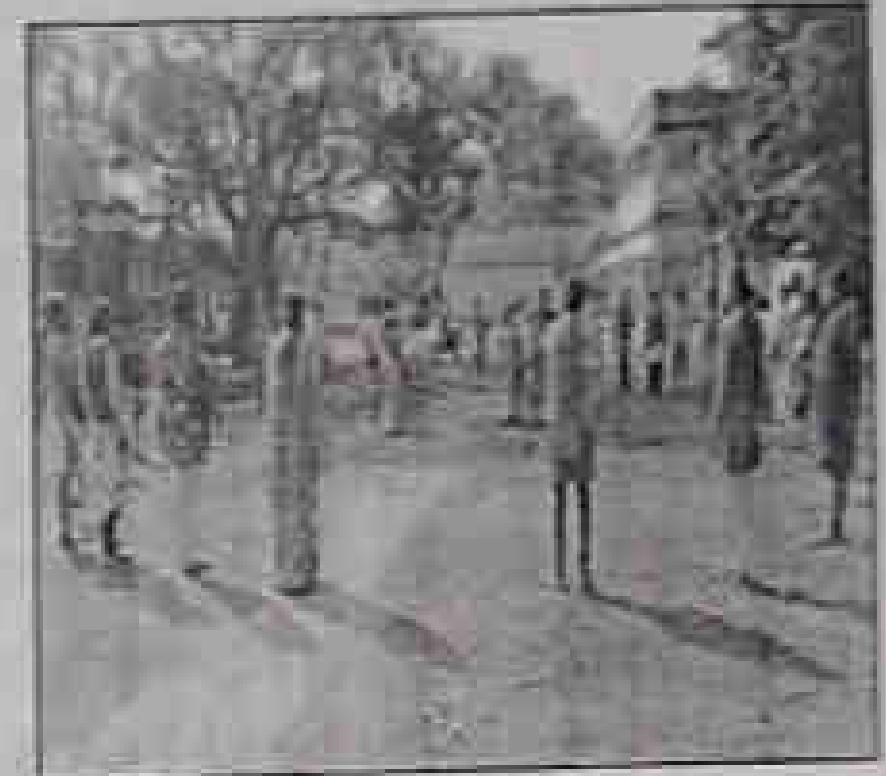

demography of the concerned area. Thus they made a strong a network and communication in the concerned ICDS Project Areas.

During the month of April, 2020 the P.C.s and F.F.s collected data as regards to Adolescent Girls with the help of ICDS Supervisors and AWWs from each ICDS Centres. As per instruction of the CDPOs they went to the ICDS Centres , visited the fields , collected the required data and thus they became well introduced with the Adolescent Girls and Community People of the areas. They were able to convince them about the purpose of the Project, SAG-KP Convergence Programme.

During the month of February, 2020 the P.C.s and F.F.s outreached the areas of the concerned vcentres, collected data and categorized the Adolescent Girls as per guidelines of the said Project. Later they started to form Groups/Clusters and provided training in presence of the ICDS Supervisors and AWWs. They collected a lot of data related to the AGs. From the fields during formation of Groups/Clusters of Adolescent Girls they noted down the data to solve in the next performance.



In the month of March, 2020 they continued to perform their activities to visit ICDS Centres/Areas , collected data, organized meetings with AGs, provided required training , managed support , prepared monthly report as per instruction of the CDPOs. Finally they were interrupted doing activities since 23.03.2020 due to Covid- 19 and lockdown as per Govt. Circulation. Since then they were performing their activities through Online Mode.

P.C.s

P.C.s have achieved the knowledges of geographical areas and demography of the concerned ICDS Project Areas. He was well versed with local language and training-facilitation skill. He monitored, supervised and reviewed the assigned activities and deliverable of the Field Facilitators jointly with the respective CDPOs. He



provided support in preparation of all the relevant reports at the CDPO level under SAG-KP Convergence Programme. He visited AWCs/Kishori Diwas/other events of the Adolescent Girls in different location within the jurisdiction of the concerned ICDS Project.

F.F.s

They conducted the capacity building training for the peer leaders (Sakhi-Sahalis) through learning games for girls training module monthly. They visited all the AWCs in a planned manner to support the AWWs and Peer Leaders (Sakhi-Sahalis) upto the Kishri Samoohs (girls Group) Level. They provided

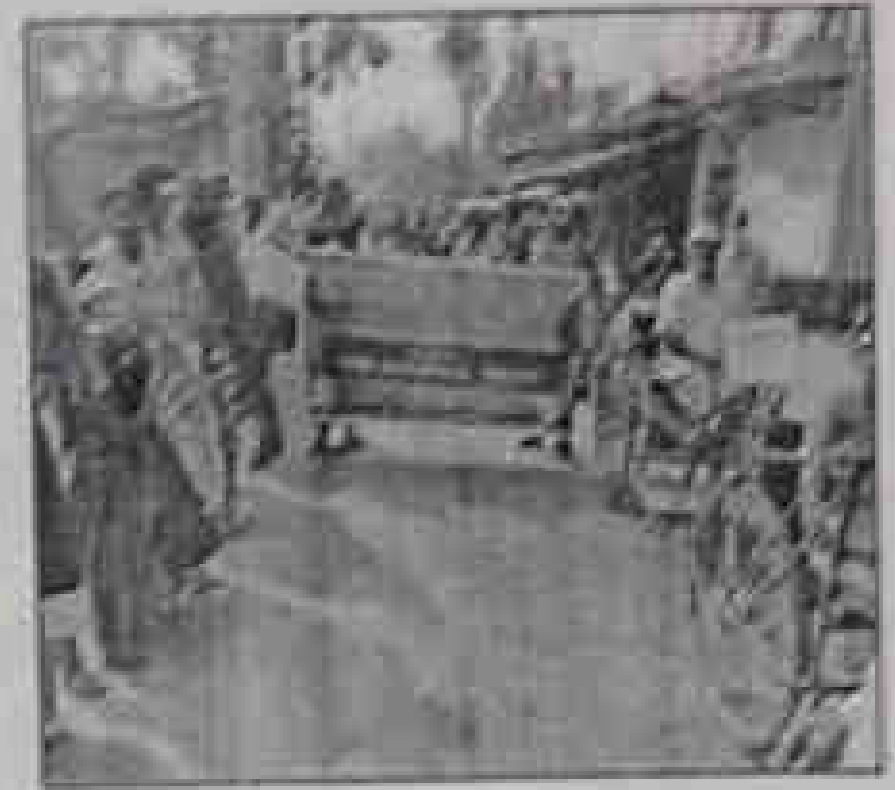

According to our instruction he received training on tailoring under SIPDA Project. He was married and he had two children. He was too poor to buy milk for his child. Later she came to our organization with her friend and listened to us everything about training on Tailoring. She agreed to receive training and took admission. In spite of Locomotor Disability she is now a successful in the world of tailoring.

SUCCESSFUL STORY OF ROMJAN ALL WITH LOCOMOTOR DISABILITY

Romjan All comes of a wretched family. He was unemployed for a long time and hence his parents would scold him very often. His father is a tea shop keeper. He has three sisters out of them two are married and one unmarried. He has five brothers who are younger than him. His father cannot

Abida Parvin is a good girl who comes of a very poor family. She has two sisters. Her father is a day labourer. They live from hand to mouth. Abida's mother is ill for a long day. Rafique Islam had lost his father at the age of six. His mother used to beg from door to door. He had also two sisters. They were in wretched condition. They lived in mud build house. 

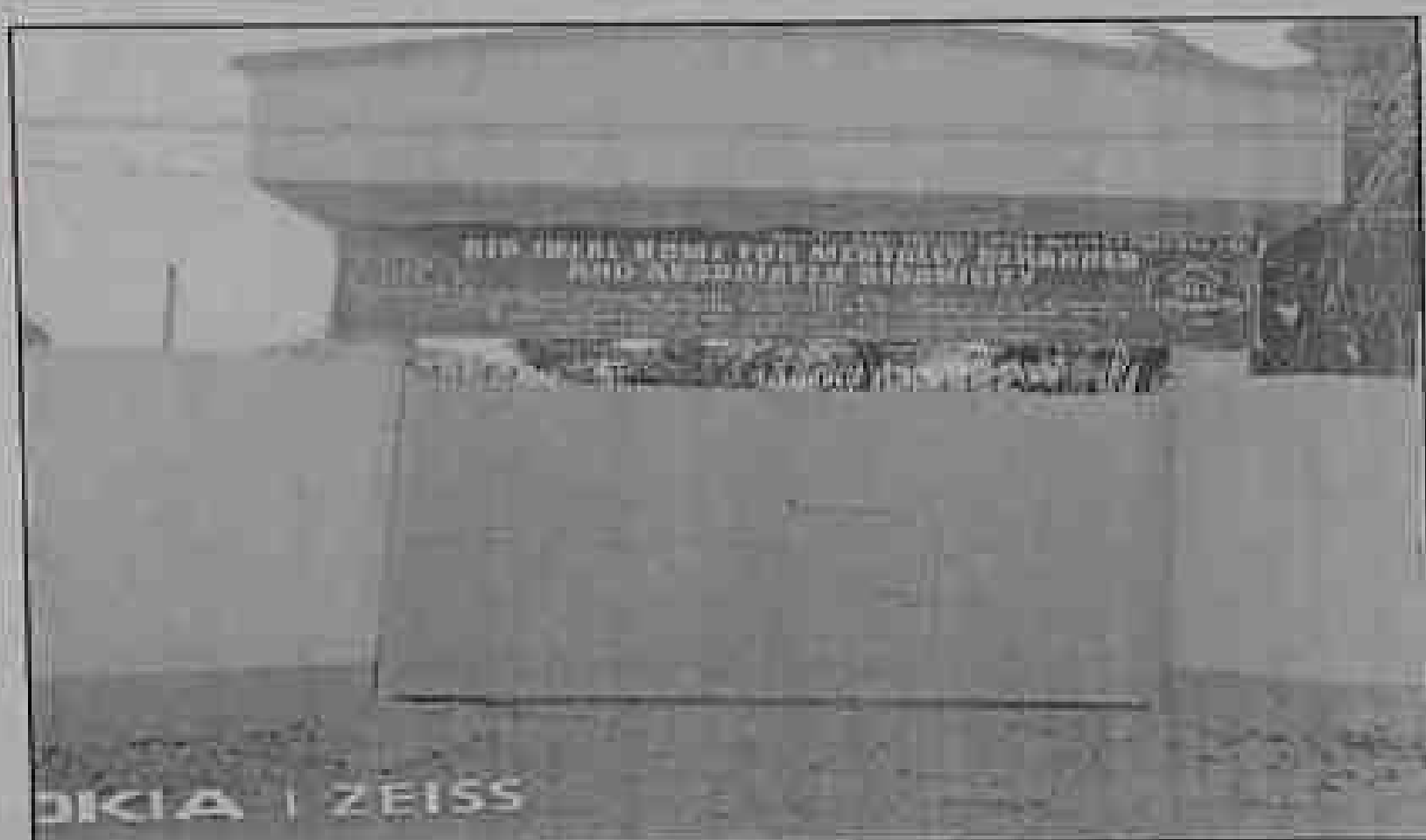
