Nature of service we provide also include evoking awareness among the parents of ID children & adolescents regarding the scientific methods of parttime training to those having ID, AUTISM, CP for upgrading their physical health and behavioural factors essential for early living, facilities and protection available under RPWD Act 2016 & National Trust Act-1999, possibilities of economic rehabilitation by providing vocational training and through CBR for earning their bread with the full consent and full participation of the parents. We take charge of Intellectually Disabled for parting training to them in every possible ways to ease their problems and short comings.

- We provide care givers to those who need them.
- We use to provide vocational training to the grown up ID in our training cum production centre.
